Election Results By Dick Travis, Election Inspectors Chairman

The recent general election, seeking approval of an amendment which would change the percentage of votes needed to amend the CC&Rs from 75% to 66 2/ 3% was successful, in that 75.8% of the owners voted

An amendment to eliminate Cumulative voting was also passed by 62.4%, more than the required majority.

In order to get 75% of all eligible voters, it was necessary to have a very large turnout, but as of August 10, approximately 1400 voters had voted. This meant that 400 to 500 voters would have to vote before the September 19 deadline. We needed a minimum of 1603 homeowners for the reguired 75% vote.

With good advice from Board and homeowners, we formed a committee of 27 residents to telephone those who had not voted.

The non-occupant owners who are habitually non-voters needed an incentive. The Board of Directors sent them letters encouraging them to vote and included a stamped. return envelope. It worked! We received 175 votes that normally would not have been received.

Five days before the deadline, there was a shortfall of 180-200 votes. Undismayed, we sent out a team to explain and assist shut-ins and others. This hard working group got another 120 residents to vote which was just enough, by 16 votes, to

Trouble In Paradise

The "angels" of Leisure Village, the above-reproach Women's Club, appear to have run afoul of the California Board of Equalization Sales and Use Tax Division.

There can be no blame imposed on officers past or present, the motives were completely innocent of wrong-doing, but our hard-working and lofty-minded women have somehow escaped paying sales tax for lo these many years without dreaming of having anyone dispute their methods.

All California Thrift-type stores must charge a sales tax. There can be no way around that fact. Women's Club has conducted bazaars (new goods) and trading posts (used items) to raise money for Ventura County charities, good works, and scholarships, as well as Village improvements which would have been unattainable without the work of the women. Several years ago they had to stop conducting the raffle, which was a major money raiser, because of State restrictions.

The L.V. Association charges sales tax on items such as light bulbs and other household items dispensed by service men. Liquor is not sold anywhere in L.V. Ticket sales by entertainment groups all name the fee as a donation, rather than a ticket rate. These examples are evidence of the several modifications of procedure around the Village in deference to State laws, codes, restrictions, but no clubs have considered they have a liability for sales tax.

Inside Leisure Village has full confidence that Women's Club will reach a decision and system which will allow it to continue conducting its affairs in a similar contributory manner, but in accord with California State edicts. It is conceivable that a monetary penalty of some kind may be imposed, but in view of the beneficent nature of the organization, a plea bargain might be presented which would not break the stride of the good works and selfless aims of this honored and honorable group of villagers.

The Facts And Findings
For An Exercise Room

By Moe Kadish, Chairman of the PRC's ad hoc committee

Because of the wide-spread misinformation going around our Village, as chairman of the Ad Hoc Committee, I would like to "set the record straight."

We found that many other retirement complexes such as ours have exercise rooms. In fact, having an exercise room is the norm and not having an exercise room is the glaring exception.

We also found that many of these retirement communities already have exercise rooms are now refurbishing their Rec. Center and the grounds in order to attract the younger seniors who will be retiring in the coming years. Many of them are proving very successful in attracting new residents.

Our Leisure Village has not done this and as a result our houses have fallen in value and we have become a stagnant community

NBC had a story on Tom Brokow's program featuring Del Webb's Retirement set up in Phoenix. They showed an Exercise Room with ten treadmills and ten bikes all being used. They also showed a computer room with men and women using 20 computers with in-

structor volunteers looking over their shoulders. They also stated that Del Webb was repainting the houses in light colors.

Many other retirement communities in California are doing the same thing. This is our competition.

Several local Real Estate Agents have written letters to the PRC saying that prospective buyers complain about the dark colors of the houses and the lack of an exercise room.

Leisure Village Oceanside operates their exercise room as follows: The users must sign two statements. The first is a certificate that they have received instructions on how to operate the machines, and the second states that they, the users of the exercise room, assume any risk for injury that may occur. Leisure Village Oceanside has not had any lawsuit filed against the Homeowners Assoc. in the ten years they have been in operation.

The PRC recommends we operate our exercise room as it is operated in Leisure Village Oceanside.

State Farm Insurance Co. will raise our liability premium by \$280 per year, because of the Exercise Room. They have informed us that the \$280 premium is based on their experience with the 500 to 600 associations they insure in California.

Exercise Room: Another View

Our Board has been requested to provide an adequately equipped exercise room for Leisure Village residents. The L.V. Racquet Club has also requested space and equipment for a table tennis facility. Each activity require approximately 1,000 square feet of enclosed indoor space.

The only building in Leisure Village suitable for these activities is the 5,000 sq. ft. shuffle board annex building. This building is presently limited by the trailers of stalled in these activities is the 5,000 lot or be tration or such a presently limited by the

Camarillo Building Department to a storage facility only because the bathrooms installed were not made for handicap use.

Here is a new 5,000 sq. ft. \$90,000 structure half empty, occupying premium space in the middle of our recreation area. The building is used to store donated merchandise for resale, Player's Guild props and Leisure Village equipment.

Merchandise and equipment can be stored in rental trailers or a quonset hut installed in our R.V. parking lot or behind the administration offices. Space is not such a premium in these locations.

Let's use the recreation area for recreation purposes!

Change the shuffle board court bathrooms to handicap usable bathrooms, finished walls, partitions and air conditioning would have to be added to the Annex Building. Install an exercise room and a table tennis room. Retain space for Players' Guild sets. Allocate remaining Annex Building space for future club recreation activities.



throughout the meeting.

Discussion based on false, and /or partial truths lead to anarchy, spleen venting and incivility. If that's your idea of discussion, then you're not made for politics in Leisure Village...try the Republican or Democratic parties.

Ideas must not be discounted, nor reduced. The "cult" of personality must

in fact be, many millions of dollars richer.



Page From a **Memory Book** By Ruth Brott

One day, early in the beginning of my tenure as Director of the Operation Exodus Project, I drove out from my office in New Jersey to J.F.K. International Airport with a photographer and staff writer from our community newspaper to meet an Aeroflot plane carrying five Russian Jewish families into our area. Exhausted from the long flight and the almost as long session with United States immigration authorities, they were permitted to see no one until they were allowed through the swinging doors into the waiting room where they were greeted by the tumultuous crowd of people looking for "their" assigned immigrants.

These bewildered new arrivals did not know what to expect, coming into the brightly lit waiting area, clutching a crumpled piece of paper with their destination scribbled in a few English words. They were overwhelmed with their reception, when eager American "cousins" embraced them with laughter and tears, scooped up the little ones and whisked everyone away to the waiting cars for the short journey to their new homes. That was young man of 38, courageously coming to forge a new life in freedom with his wife and their two young children. A strikingly handsome man, Mike (as he immediately insisted upon being called) seemed totally in charge of the situation, swiftly rounding up kids and gathering up baggage, then heading for the waiting transportation.

When I visited Mikhail and his family in their new surroundings a few days later he did not seem quite so assured. Yes. he remembered me from the airport, but as we sat on the couch in his beautiful new apartment fully furnished with gifts from his new Jewish community, he seemed genuinely puzzled, and wondered aloud to me why people had done "all of this" for him and his family. Ensconced in a modern, two-bedroom apartment, which had been secured for them by the Jewish Family Service and whose rent was paid for the next six months by that agency, Mike told me that all their married life he and Sofia had lived with her parents in Kiev in a cramped, one-bedroom flat. This newfound luxury was totally unreal. For Mike and Sofia with daughter, Fania, and son, Sasha, had been ush-

Mathematics, nemesis of many a hapless student, has been the challenging. enjoyable, and stimulating vocation of Paul White, Village 42.

After academic studies culminating in a Ph. D. from the University of Virginia, Paul started a long term (35 years) teaching career at the University of Southern California where he taught both undergraduate and graduate courses in mathematics. was her greatest gratification both professionally and personally.




