

MINUTES OF THE MEETING
OF THE VENTURA COUNTY DEMOCRATIC CENTRAL COMMITTEE

The Ventura County Democratic Central Committee met at the Court House, on April 13, 1959 at 8:00 PM.

Minutes of the previous meeting were approved as read.

No Treasurer's Report, as Marion Walker, Treasurer was absent.

The Chairman discussed the recommendations of appointments that were sent to the Governor. The matter of Cross Filing was discussed and the telegrams that we sent to Senators Hollister, Farr, and McBride, the cost \$9.63, the amount to be paid by the Clubs.

Dollars for Democrats Drive was set and the dates are October 1st to 3rd. Harold Nason moved that a committee be appointed to have some sort of kickoff barbecue with Pat Brown as Guest Speaker, seconded by George Tibbetts, motion carried. Chairman appointed the following Committee: Goldie Kennedy, Ronald Benner, George Tibbetts, Ralph Bain, and Boyd Finch. *+ Club Presidents*

George Tibbetts moved that we go on record with the following resolution; seconded by Bobbie Jennings:

Clash Resolution: Whereas it has been reported in the public press that Congressman Teague has been subsidizing the Republican Party Headquarters in Ventura County with the use of public funds. Now, therefore, be it resolved that the Ventura County Democratic Central Committee deplores such a misuse of public funds and be it further resolved that copies of this resolution be sent to Congressman Teague and to the daily press, radio stations, in Ventura County.

Al Blanford moved that we write a letter of thanks to McBride for his efforts in behalf of the FEPC Bill. Seconded by George Tibbetts. Secretary instructed to write a letter to the Senator.

The Chairman brought up the matter of forming an Assembly District Council for Ventura County. Boyd Finch the Senatorial District Chairman was asked to get the ball rolling and set up the necessary meetings to get the Assembly District Council formed. Meeting of all Club Presidents, and any interested persons may attend, meeting May 4th, at the Board of Supervisors Room at 8:00 O'clock PM.

Al Blanford submitted his resignation as Vice Chairman, George Tibbetts moved that we accept the resignation with regret, no letter of acceptance is necessary.

Bob Hill submitted his resignation as a member of the Oxnard Central Committee, George Tibbetts moved that we accept the resignation with regret, seconded by Bobbie Jennings, no letter necessary.

Ronald Benner moved that we meet the 34d Monday in each month. Seconded by George Tibbetts, motion carried. Meeting set for May 18th.
