

CSUCI Distance Education Overview

CSUCI offers 2 fully online programs. They are both run through the self-support unit, Extended University. At the undergraduate level, EU at CSUCI offers a BS in Business and a BA in Psychology fully online. We also hybrid BS in Nursing degree and a fully online Masters in Nursing degree which includes two embedded certificates.

The recent shift in WSCUC's definition of distance education that required institutions to request and obtain substantive change approval for all academic programs in which 50% or more of the program (units for completion of the program) could be offered through distance education, including general education components, pushed CSUCI to request review for all of our undergraduate programs in May 2022; approvals were received for all requests in June 2022. In the context of the Substantive Change review requirement for programs, WSCUC considers a distance education course to be one in which 50% or more of the instruction and interaction occurs using one or more of the technologies included in the definition of distance education, with the faculty and students being physically separate and pertains to the entire set of courses/units a student undertakes to complete the program.

Online courses and academic programs are approved the same way that in-person courses and programs; i.e. they are approved by the program/department, curriculum committees, and ultimately the Academic Senate.

Syllabi for online courses offered in statewide academic programs are reviewed at the same time and using the same process as those for in person and hybrid courses (see [Senate Policy 7.16, the Syllabus Policy](#) and [Senate policy](#) on Listing of Online Course Offerings). Each of the syllabi offered via program in EU are associated with courses that ensure regular and substantive interaction as students develop their abilities, knowledge, and skills in these courses. CSUCI's Teaching and Learning Innovations unit (TLi) has two learning designers who specialize in course design and UDL in particular, working with faculty via workshops, individual consultation, and design support to create online courses of exceptionally high quality, using the [CSU Quality Online Teaching and Learning Rubric](#). TLi also offers a voluntary [course feedback option](#) for online course peer review. Given Teaching and Learning Innovations' current staffing, project load, and service offerings, the following support is offered to online and blended programs during Fiscal Year 2024 (July 2023-July 2024):

Online Program Preparation

Directors, Chairs, and Teaching Leads for online programs are encouraged to schedule a consultation with the Director of Digital Learning and the TLI Learning Design Lead to discuss considerations for the online program. We can advise on topics like communication, facilitation of group teaching preparation, peer review, etc.
