MEETING GOALS

*How they can help us.*

1. Learn more about the positive and negative roles which the Chancellor's Office and the California Community Colleges Governing Board can play in the Oxnard College Development project.
2. Obtain the interest and assistance of the Chancellor's Office in encouraging the early development of Oxnard College.
3. Learn what additional information, if any, the Oxnard delegation might provide the Chancellor's Office to secure its support for the Oxnard College project.

MEETING APPROACH

The Oxnard delegation will attempt to achieve the above goals in its meeting with Mr. Peterson by making factual presentations, asking specific questions, and joining in open discussion with their guests. Since it is not yet known whether or not the Chancellor's Office is sympathetic to the early development of Oxnard College, an effort will be made to keep the meeting positive and objective in tone; such an approach should help the Oxnard delegation to obtain the fullest factual information possible, and impress the Chancellor's representative that the Oxnard community, despite its frustration on this matter, wishes to work in a cooperative manner to move the Oxnard project forward. In order to facilitate this meeting approach, Mr. Robert Butz, Oxnard College Task Force Chairman, will chair the meeting and an effort will be made to direct all questions and comments through the Chairman.
