Chair (Senghas)

 Resolution recognizing work of Art Warmoth. Questions re process, not merit of resolution. Is it setting the wrong precedent, where we have traditionally honored all, i.e., granted emeritus status for all; APC revised resolution into information item from committee.

Business

1. Senate Diversity Council request TC: 1:15

- Request additions of 2 questions to SETE re classroom climate and diversity issues
- Proposed questions to add to the SETE:
 - "I think that my instructor respects me as an individual, and has created a safe environment for all students, regardless of their specific background"
 - "My instructor uses language that is appropriate, sensitive and respectful when they refer to people from diverse backgrounds (race, ethnicity, culture, religion, disabilities, social class, sexual orientation, etc.)"
- Discussion:
 - Newer research shows some effectiveness of student evals
 - What is President's Diversity Council's goal of adding questions: awareness and motivation and accountability.
 - o Engendering rather than accounting
 - Look at as part of the whole rather than ad hoc additions
 - o What are SSU's obligations once problems have been identified
 - o Tweak language a bit
 - Need to avoid witchhunts or disproportionate reactions
 - Demonstrates institutional commitment to diversity
 - o Clear definitions of terms; context of comments

- How to support faculty who may say things to invoke a response
- o Explain to students why you are doing what you are doing
- o Create resource base of useful resources to support change
- Take a look at the SETE instrument as a whole; make part of comprehensive review rather than add on.
- Report back to Laurel at end of semester on progress and again at end of year.
- o Laurel will check to see when the SETEs were last revised.
