Re: Position statement by the Commission for Women for presentation to the Friends of the Commission

The Ventura County Commission for Women has expressed a desire for a change in its relationship with the Friends of the Commission.

Because the Commission feels an impasse has developed between the two groups, the Commission has opened a dialogue with the intended purpose of resolving conflicts so that business may continue on behalf of the women of Ventura County.

As requested by the Commission at the last monthly meeting, the Commission Co-chairs and the committee established to review the relationship with the Friends have met, continued their discussion of the roles and relationship between the Commission and the Friends, and present the following position for your approval:

THE FRIENDS ARE ENCOURAGED TO PROVIDE INPUT IN THE DEVELOPMENT OF BUDGETS FOR PROJECTS. THE COMMISSION SUGGESTS THAT A MEMBER OF THE FRIENDS BE ASSIGNED TO PARTICIPATE IN THE DEVELOPMENT OF A BUDGET FOR EACH PROJECT.

WHEN A BUDGET IS DEVELOPED BY A PROJECT COMMITTEE IT WILL BE PRESENTED TO THE COMMISSION FOR WOMEN FOR APPROVAL.

ONCE A PROJECT BUDGET IS APPROVED BY THE COMMISSION FOR WOMEN, FINANCING FOR THE PROJECT WILL BE EXPECTED FROM THE FRIENDS AS APPROVED BY THE COMMISSION."
