#### RESOLUTION

RESOLVED, that President, B. H. KAWAOKA, and Treasurer, MASAJI ETO, be, and they are hereby authorized and empowered, on behalf of SAN LUIS OBISPO BUDDHIST CHURCH, INC., a California non-profit membership corporation, to purchase for the sum of Sixty Five Thousand Dollars (\$65,000.00), the real property described in Exhibit "1", attached hereto and made a part hereof, and that they execute all documents necessary for the acquisition of said property, including the execution of a promissory note secured by Deed of Trust, in the amount of Forty Five Thousand Dollars (\$45,000.00), with interest at the rate of six per cent (6%) per annum, payable semi-annually, and principal payments in annual installments of Four Thousand Five Hundred Dollars (\$4,500.00), or more.
