 - a. Alexandra Mitchell
 - i. There is an internal Student Government issue that needs to be addressed immediately.
 - 1. It has been brought to my attention that some of our leaders within the Student Government body have not shown integrity. I am extremely disappointed with this news. There was an issue that arose at CHESS last weekend. Fundamentally, if one person acts without integrity then it reflects on the entire Student Government body as well as the student body. We are always in a student leader role, and because of this, the expectations for us to always be a positive example for the students is higher. The Vice President for Student Affairs is aware of what happened last weekend, as well as other entities on campus. Actions like these make our organization lose credibility. We need to abide by our mission statement. Everyone is held accountable. The positions that we hold on campus are a privilege. All officers of this Student Government need to make

sacrifices: this means no parties or events where you are under age and drinking or there are others who are underage drinking; and we need to be in good standing academically. We always need to be on our best behavior.

b. Dustin Erickson

- i. Your success is my success and your failure is my failure. I feel that we should not be having this conversation, especially at this point in the year. Please consider the roles that you are in and will be continuing in. I feel that I have to explain what the internal issue is. This is not the first incident that Student Government has experienced. In the past, Alexandra and I have tried to protect the privacy of those that were being held accountable. I feel that this protection though may have done more harm than good because we always need to be held accountable. I received a phone call that senator and president elect; Kevin Schallert was in Cal Maritime's room at CHESS and was offered a beer. I was informed that he did not drink the beer, however; he still accepted it. The Vice President for Student Affairs has also been informed of the incident. I would now like to open the floor for Senate Remarks.

1. Kevin Schallert

- a. I would like to formally apologize to Student Government and the entire student body. My actions were irresponsible and unprofessional. I would like feedback from the rest of the group: should I resign from my position?

2. Katelyn Rauch

- a. What are your plans for next year?

3. Kevin Schallert

- a. I plan to aggressively advocate for students.

4. Katelyn Rauch

- a. And what have you learned from this personally?

5. Kevin Schallert

- a. I was offered the beer and through peer pressure from one of our senators, I gave it back. This made me realize the importance of personal conduct and how quickly something like this can spread throughout campus. I plan to serve next year with integrity.

6. Lauren Pollack

- a. Thank you for apologizing. I feel that you did learn your lesson. I do not feel that you should resign from your position because I feel that you are a good senator.

7. Erica Roundy

- a. I agree with Lauren. There is a valuable lesson to be learned. I feel that you have a lot to contribute still. I think this case may have been very different if you did not give the beer back. I do not feel that you should be removed from your position.

8. April Burger

- a. I also agree. You are great at what you do. You gave the beer back under peer pressure, how do you plan to conduct yourself if this situation ever arises again?

9. Kevin Schallert

- a. That is a difficult question to answer. I learned my lesson and will think about my actions.

10. Alexandra Mitchell

- a. Thank you for your humility. Kevin is not the only person to be found in question this year. I apologize for having to use you as an example. I want to remind everyone that is against the law to be drinking alcohol if you are younger than twenty-one years of age. If you have a fake ID that would state that you are twenty-one years or older, please dispose of that immediately. We are still in our roles until May 31, 2009.

11. Dustin Erickson

- a. My recommendation for future officers and senators is that if this issue occurs again, we need to hold each other accountable. If you see misconduct, communicate that.
