## About Your Leisure Village Board Candidates

I was born February 19, 1915. My early youth was spent in Philadelphia, Pennsylvania. My father, Raymond Fosdick was a builder of homes in Delaware County; my mother, Virginia Fosdick, handled the real estate sales.

In 1938 we moved to Santa Monica, California. My parents separated and my mother and I moved to Los Angeles where I attended Hollywood High School, participating in baseball, track and basketball, I majored in pre-med courses.

In 1933-34 I attended U.C.L.A. studying pre-med. During this year I helped support myself by selling newspapers plus a part time job at Bullock's Department Store, Los Angeles. In 1934 I secured a full time job at Bullock's as a stock boy and rose to Buyer-Manager. From there I opened the first Men's Department at the Westwood Village Branch.

In 1938 Anne Carmichael and I were married, sharing 44 years of wedded life together.

At the outbreak of World War II I became an air raid warden in the West Los Angeles area. I joined the Army in 1942, soon became a sergeant and was assigned to Infantry School

### The Greening of Leisure Village

The cost of living in Leisure Village is going up.

Effective May 1st, resident service charges were increased from \$16.00 to \$20.00 per hour, and the minimums from one-quarter to one-half hour. In other words, the minimum labor charge is now \$10.00 instead of \$4.00.

A complete statement of resident service charges, as well as landscape service charges, is contained in the May 9th issue of VOICE OF THE VILLAGE.

Prior to April 1, 1981, the Association provided resident services to houses over one year old without charging the homeowners; the cost was absorbed in the monthly fee. This so-called "free" home maintenance service was much-abused by enough Villagers to warrant a radical change in the Rules and Regulations.

This year, acting under its authority derived from the Village's "constitution," the Declaration of Covenants, Conditions and Restrictions (the C.C. & R.'s), the Board of Directors accepted a recommendation of the Finance Committee to reduce losses incurred by the resident services operation by "upping the ante," as it were. Even so, we are told, some of the costs will continue to be absorbed by our monthly fee.

We cannot quarrel with the Board for acting so responsibly at its May 3rd meeting. After all, under present rules we must acquiesce in the decision.

However, we wish that the Board would have avoided a "future shock" approach by publicizing well in advance of the May meeting the facts and figures leading to the adoption of the new schedule of charges.

It is not enough to urge Villagers to monitor committee meetings and Board meetings. The fact is that very few do.

Perhaps it is time to consider amending the C.C. & R.'s (inherited from a corporate developer), to re-structure our Village "government" in ways that will ensure administration by consensus rather than government by acquiescence.

at Fort Benning, Georgia, graduated as an officer and was then attached to the Fourth Division and commanded the 2nd platoon, M. Co., 12th Regiment. I led this platoon, a section of Mortar and a Medical Section, on a L.C.M. in the Normandy invasion. Three weeks later I was badly wounded by mortar fire. Awarded the Combat Infantry badge, Purple Heart, and my Company was awarded the Presidential Citation.

After ten months in the hospital, and able to work again, I secured a job at F. C. Nash & Co., in Pasadena, as Buyer-Manager of Men's and Boy's Wear.

In 1946 our son Steven was born and we moved to Altadena. On a New York buying trip, the Joseph & Feiss Co. of Cleveland, Ohio, offered me a job in sales. Fortunately I rose within the Company from salesman to Vice President Marketing for the Western United States in 1958.

After 29 years with the company, I retired in 1980. We moved from Tarzana, Ca. To Leisure Village in March of 1980.

Presently I chair the Community Relations Committee, participate on Supervisor Erickson's Parks Committee, also the Ventura Emergency Medical Care Committee (CARE).

## Forum Discusses Utility Rates

Describing the California Public Utilities Commission as "a tribune for the people," Michael A. Doyle, Assistant P.U.C. Representative for Southern California, told Villagers attending the Current Issues Forum on April 23rd that electric utility ratepayers can expect a rate decrease "very soon."

Because of the heavy rainfall in recent months, there has been a large increase in the hydro-electric capacity generated in Northern California. As a result, the P.U.C. was contemplating an overall reduction of \$834,000,000 in utility rates.

During the question-and-answer period following Doyle's address a number of Villagers rose to question the high earnings of Southern California Edison Company in relation to recent sharp rate increases.

Harpel Smith, of Village 38, who had appeared before the P.U.C. with a petition against

rate increases, signed by more than 1,600 residents of Leisure Village, summarized the basic issues involved and reported on pending legislation.

With regard to nuclear plant construction, Doyle said that Calif. is one of 19 states that do not permit building costs to become part of the rate base until the plant begins to produce electric power. Some members of the audience expressed skepticism, pointing out that bond interest costs affect company profits and therefore necessarily influence factors that determine rates.

about Social Security retirement, disability and survivor programs.

Work experience: I took early retirement from the federal government after working 22 years for Social Security and Medicare.

From 1978-1981 I had been Medicare's representative in Southern California, I coordinated work and relations between the federal government and Blue Cross, Blue Shield, Mutual of Omaha, Aetna and Occidental Insurance Company who have contracts with the government to pay for services to Medicare patients.

I spent most of my time at Blue Cross, where I helped develop and negotiate the Blue Cross, Medicare budget which was \$10 1/2 million this year. I monitored the day-to-day activities of Blue Cross payments to hospitals and nursing homes of \$1 1/2 billion. I worked with the finance department, systems computer programming, medical review

by doctors, nurses and therapists, and claims processing. I also worked with the offices of US Senators and Congressmen when they asked for information for Medicare patients.

From 1972-1978 I was an investigator looking into complaints of fraud and abuse committed against the Medicare program.

During the 13 years prior to that, I worked my way up the ladder in Social Security, starting as an interviewer and technician, to field representative, supervisor, assistant manager and branch manager. I acquired experience in working with community leaders, experience in running an office and employee relations, dealing with employee unions, recruiting employees and also in answering inquiries from the news, radio and TV media.

Before that, it was World War II and I worked in defense plants as an inspector of electronic equipment. I dropped of Hunter College in New York City when the Navy took it over to train WAVES.

Education: When Leonte was discharged from the army, we got married. I worked as an insurance broker. Five years later we had a daughter. I later worked for a BA in Political Science from UCLA (1956) and a Master's degree in Public Administration, (1959).

For my MPA degree I worked for the City of Downey for 8 months as a management intern. The City had just incorporated and needed help to set up its government and transfer services from the County of Los Angeles to the City. I wrote Downey's Budget Manual and Purchasing Manual. I designed and helped put in the City's tax collecting system. I performed a study for the Police Chief on parking meters and a study for the Fire Chief on the need for fire stations. I helped compile the City's first Annual Report and worked with the Finance Director to determine the distribution of the City's bank accounts among the local banks. I wrote my Master's thesis for UCLA on this experience in Downey.

was asked to stay on and I continued with the University as Senior Staff Engineer and Contract Representative for the Applied Physics Laboratory. 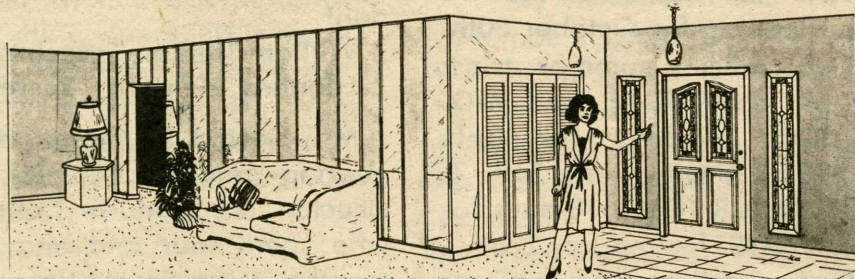

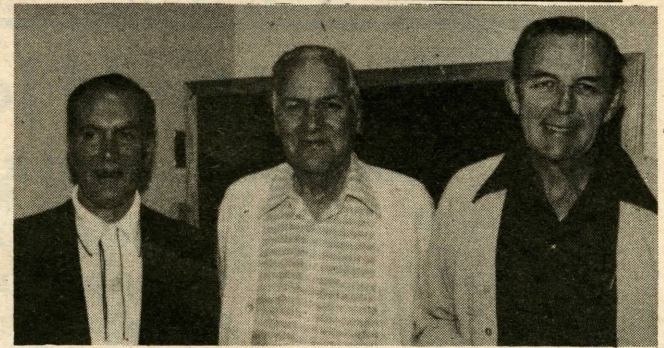

visit to the Heino Pottery and Studio Gallery in Ojai on May 20th.

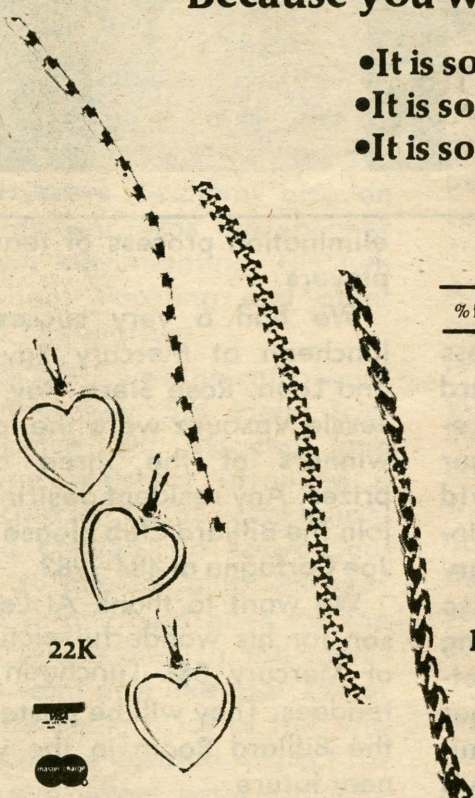

## Book Review

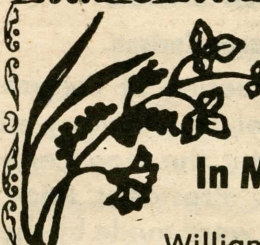

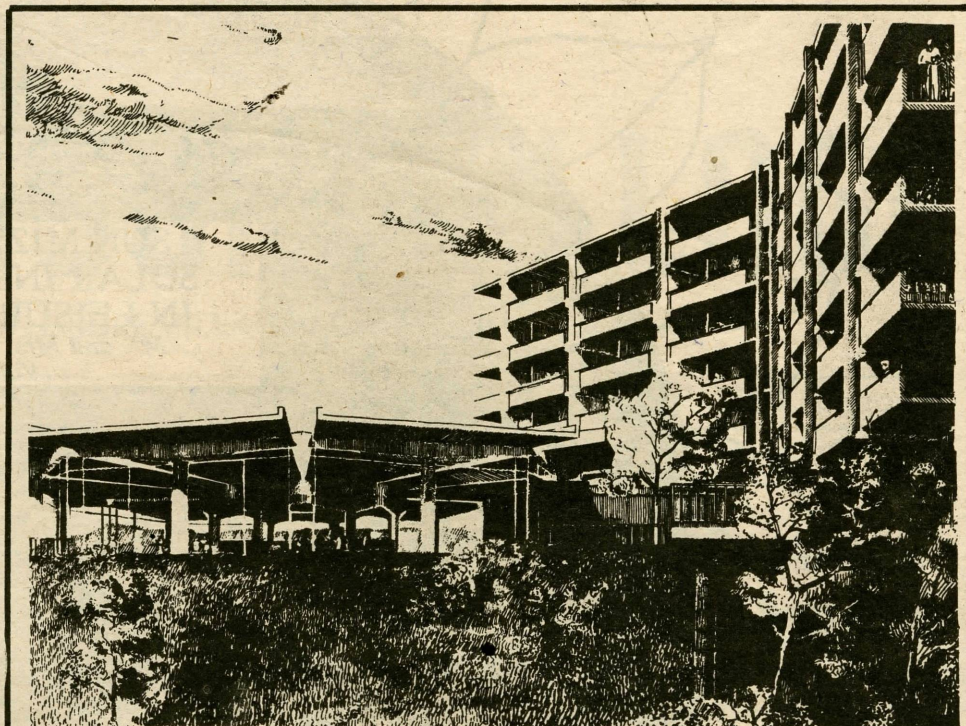
cessful and maintains a large active membership, but it is limited to high level dancers.

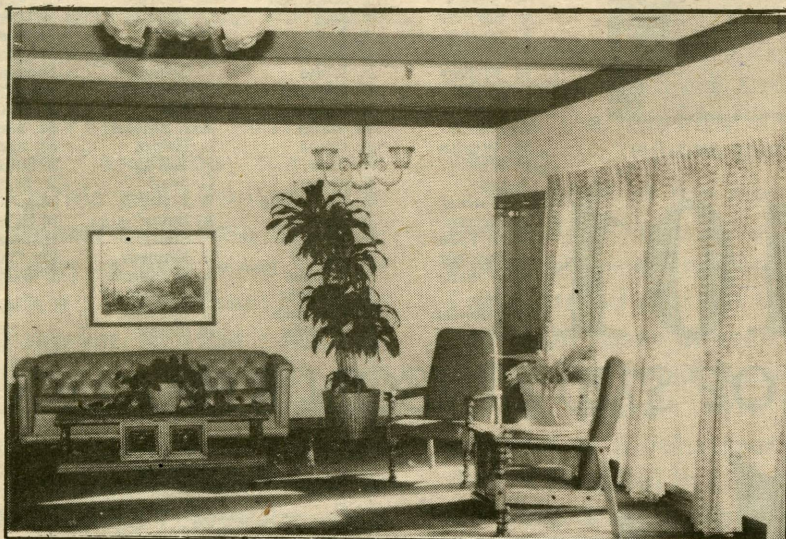

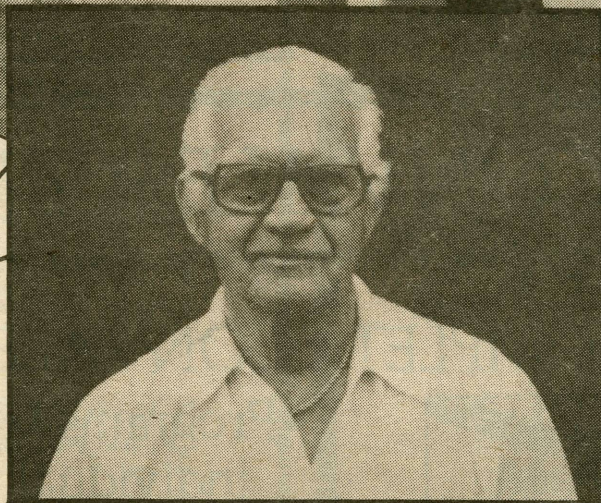
