DONATIONS: Many people have been asking, "How do I make a donation to Task Force One, how much should I give, and what will the money be used for?" To answer the first question, you can send a cash donation, or your pledge card, to the above address. If you do not have a pledge card, call extension 7284 and we will see that you get one. As to the second question, TFO desperately needs \$10,000 in order to assure that our forward progress is continued, and that laws are put on the books to prevent a recurrence of private industry's attempted piracy of the Civil Service system after the immediate battle is won. If 1000 people will each donate \$10, or 2000 people each donate \$5, we could easily reach our goal. As far as we have been able to ascertain, these donations are tax-deductable and we'll have more info on that later. All of the money you donate, to answer the last question, goes only for TFO expenses. Most of the TFO volunteers (all TFO workers are volunteers and do not receive any pay whatsoever) donate gasoline, stamps, typewriters, paper, etc., out of their own pockets. Donated funds are used mainly for travel, telephone long-distance calls, printing costs, costs of renting auditoriums, and for the out-of-pocket expenses of the Executive Director. The money that has been donated to date has gone mostly for the preparation of our legislative package and testimony before the Armed Services Subcommittee in Washington. Trips have been held to the minimum necessary to assure that we received proper recognition, and to make sure that all parties were thoroughly briefed on all aspects of the PMR case when it was presented in Washington.

PROGRESS: Our progress has been no less than phenomenal! Our chairman reports from Washington that our latest reception there was extremely cordial, and that he and our Executive Director were allowed all the time they needed to brief everyone concerned. GAO has not yet received any cost analysis from the Navy concerning the Civil Service to contractor conversion plan. They DO have the TFO cost analysis however, and it is an excellent one. It was put together by some of the sharpest economists and contract experts on the base, and will be released to the press this afternoon at the NAGE hall in Oxnard. A full progress report will be made at the open meeting next Monday night (23 July), Oxnard Civic Auditorium. DON'T MISS THIS ONE - IT'S BIG, IT'S IMPORTANT, AND IT'S FULL OF GOOD NEWS! DID YOU KNOW? That last January, ADM Isaac C. Kidd, in an interview with Cmdr Peter Hackes, concerning the CNM EEO program, said, "A man or a woman (employee) acquires an awful lot of experience. You just can't bottle that, or can it, and put it away and draw on it when you need it. You've got to keep these people around. So I think that here we're following the laws of the land as established by the Civil Service Commission." While he was making these statements his employee, Mr. R. G. Iverson, was sitting in a locked room and following ADM Kidd's orders to eliminate 1448 Civil Service career employees at PMR!

That Task Force One has a new chairman and vice-chairman? All TFO officers serve for three months only. At the last election, Mr. R. P. Carpenter was voted in as Chairman, and Mr. L. D. Bryant as Vice-Chairman. Anna May Ray was reelected to the Treasurer position, and Mrs. Barbara Romo was voted unanimously to be our new Secretary. Our heartfelt thanks to ex-Chairman Bill Hamilton and ex-Secretary Faye De l'Eau for jobs well done!

LATE NOTE: We have just been informed that Asst. Secretary of the Navy, Hugh Witt (who will speak at the Monday night meeting in the Civic Auditorium in Oxnard) is now an ex-Asst. Secy of the Navy! He has been moved over into a DOD job as of last Tuesday.
