higher education.

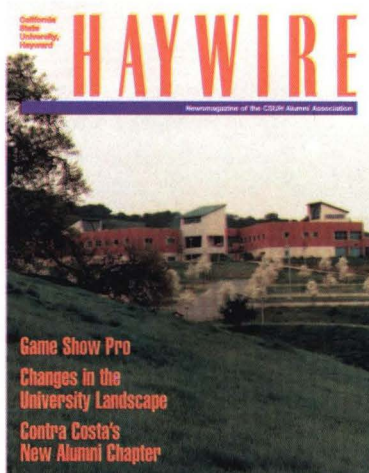

In Jeopardy – Again!

Leslie Frates has appeared on the game show Jeopardy more times than any other female contestant. On May 2 the Cal State Hayward alumna made her 11th appearance on the small screen in the special reunion contest billed as “The Battle of the Bay Area Brains.”

“I always loved this show, and it’s great fun to be a contestant,” she said after the March 21 taping of the latest show, recorded before a live audience in Berkeley.

Jeopardy was always a favorite with Frates, who recalls running home from her Hayward elementary school every day to catch the show when it was on in the afternoon.

Her recent Bay Area competition, a benefit for the American Red Cross, was scheduled the day before the annual Jeopardy College Tournament. For this fund-raiser Frates and the other contestants received prizes instead of cash. (She went home with a 35-inch Sony TV with surround sound and a digital video player.)

Frates, who now teaches Spanish at Cal State Hayward in a department with her former instructors, first appeared on Jeopardy in 1991. Undeclared during her first five appearances, she qualified to return later that year for the Tournament of Champions, in which she won the first of three rounds before being defeated in the semi-finals.

Jeopardy producers invited her back in 1993 for the show’s 10th Anniversary Tournament, in which she led until the final question.

In addition to the \$68,599 she has accumulated from the show, the trivia buff said she also has received some “lovely parting gifts,” including a case of Metamucil, \$25 worth of Tabasco Sauce, a desk reference set, a generous supply of Jelly Belly jelly-beans, a Nintendo game set, and, of course, the home version of Jeopardy game.

One of her favorite gifts was a case of Rice-A-Roni, manufactured in San Leandro, shipped to Iowa for distribution, then sent to her Hayward home by UPS express delivery.

Frates said when the UPS man delivered the 36 boxes, all chicken flavor, he was laughing so hard he couldn’t speak.

The game show winner graduated from Mt. Eden High School and Cal State Hayward, where she earned both a bachelor’s degree and teaching credential. She has taught Spanish for 21 years, at both Cal State Hayward and Chabot College.

Frates and her husband Bob, an Oakland attor-

ney, reside in Hayward with their son, Leland, 12.

To prepare for the contests Frates said she regularly reads almanacs, Time magazine, the encyclopedia, and the Readers Encyclopedia. She has an extensive home reference library and also combs the Internet, “which has changed my life.”

Her game-show prowess has generated some spin-off fame, as well. She appeared on the cover of a woman’s magazine and was written up in Money Magazine. A clip from one of her television appearances is part of the movie “Groundhog Day.”

In 1993 she was the guest on a two-hour radio show, answering questions about Jeopardy and fielding trivia questions from listeners who tried to stump her. Only a couple of callers succeeded, and Frates said live radio was a lot of fun.

During her fifth regular game appearance in 1991, Frates came home with \$56,099 by changing her answer in the final seconds of the closing round. In this segment of the show, guests write their question/answers on a desktop screen.

Prior to getting the clue, “This is the largest island on the West Coast of North America,” Frates bet one dollar more than the total earnings of her closest competitor.

“I began thinking, Japan could be considered an island off the west coast of North America, but I wrote down Hawaii instead,” she said.

While waiting for the game show music to end,

she began thinking of islands along the California, Oregon and Washington coasts.

“I immediately rejected Catalina,” she said, but then as she worked her way up to the state of Washington, she realized the correct answer.

“I crossed out my first response and quickly wrote ‘What is Vancouver Island?’ with only about three beats of music left,” she said.

Her haste made her handwriting hard to decipher, but she won the round.

The question that stumped her in the Tenth Anniversary Tournament asked for the name of any of the three women to win the Pulitzer Prize for drama during the 1980s. (They were Wendy Wasserstein for “The Heidi Chronicles,” Marsha Norman for “Night Mother,” and Beth Henley for “Crimes of the Heart.”)

Only one contestant, a New Yorker who attended Broadway plays, answered correctly.

Frates takes Jeopardy defeats in stride, saying she has enjoyed everything about the game show experience. She is equally enthusiastic about teaching Spanish at her alma mater.

“I loved it here as a student. I had so many really good teachers, including Vincenzo Traversa, Rodolfo Galan, Yolanda Patterson, and Don Warrin. My Cal State Hayward teachers always had time for me and always made sure I was taking the right classes,” Frates said. “Now I’m teaching in the same department where I was a student.

“I can’t believe my good fortune!”

Four Reporters Caught in CSUH 'Web'

Four journalists who spent a week learning about multimedia at Cal State Hayward said that getting to know the university was as fascinating as learning to navigate cyberspace.

"The faculty, staff and students were just a delight to meet and an inspiration to learn from," said Camille Feanny, a CNN associate producer.

Feanny was joined by reporters Mike Francis of the *Portland Oregonian* and Bill Ordine and Dan Rubin of the *Philadelphia Inquirer* for a five-day fellowship at CSUH, home of the nation's first multimedia master's degree program.

"The fellowship was of extraordinary interest," said Ordine. "It not only addressed a technology that is impacting commerce and culture but also points toward where journalism itself is headed."

Hall of Fame Inducts Six

Al Mathews, former coach and athletic director at Cal State, was one of six inductees into the CSUH Athletic Hall of Fame on Feb. 7.

Mathews spent 29 years at Cal State Hayward, serving as the CSUH baseball coach from 1964 to 1972 and as the university's athletic director from 1971 to 1992.

Five outstanding former student athletes also were inducted at the banquet.

Linda Jean Barneson was a top player on Cal State Hayward's two championship women's basketball teams and an outstanding performer in softball, volleyball, and track and field. (1965-68)

Monty Consani was a three-time All-Far Western Conference offensive lineman who played for Cal State Hayward on two championship football teams. (1969-71)

Marie Nickson, a top competitor in women's track and field, was a two-time All-American and held the records for 100- and 200-meter dashes in the Golden State Conference. (1978-80)

Ken Rodrigues was twice named to the first

Pam Williams earned All-American honors her junior and senior seasons on the CSUH swimming and diving team. (1978-1981)

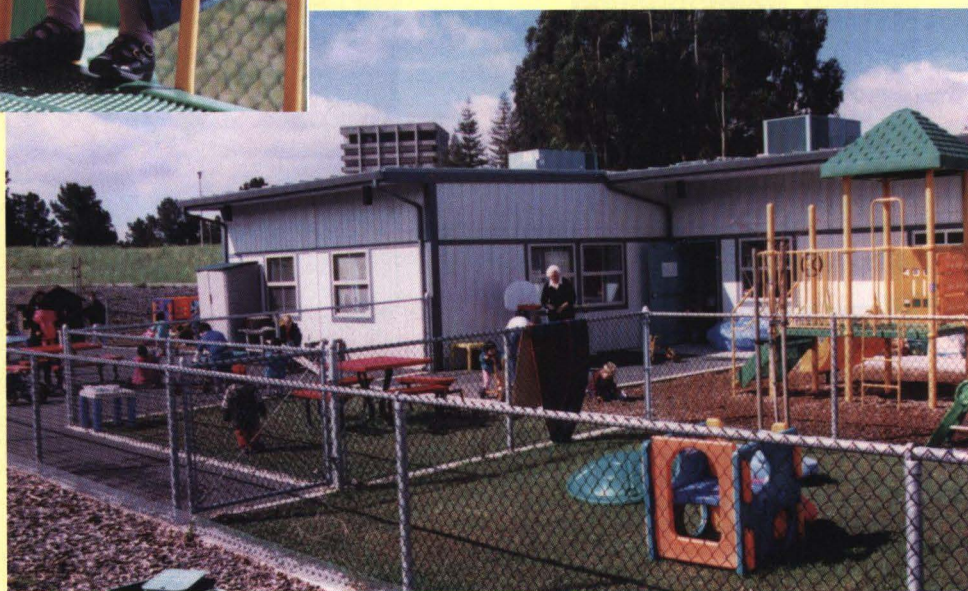
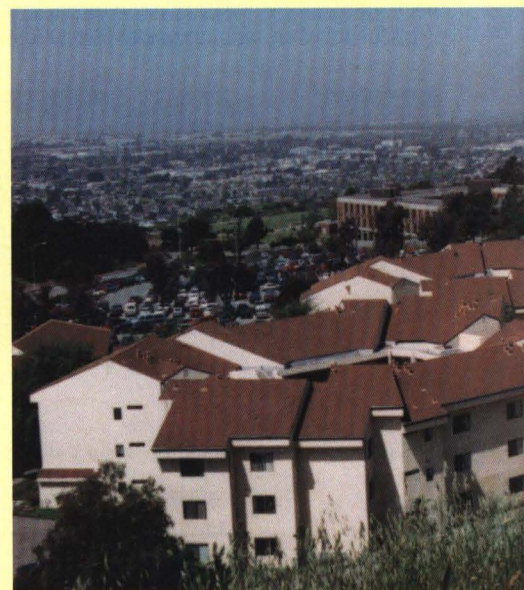
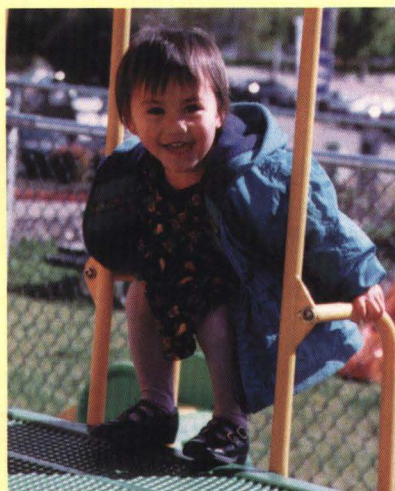




The Changing CSUH Landscape

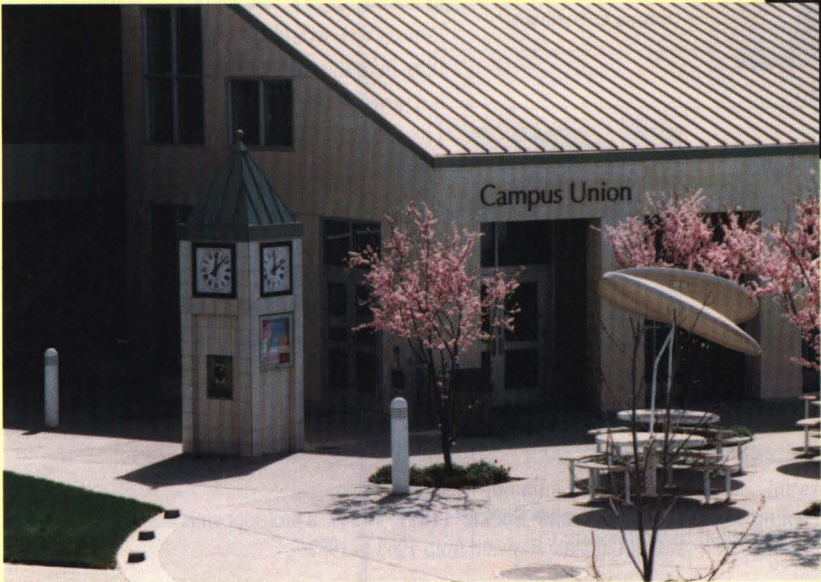




Contra Costa Campus, Concord

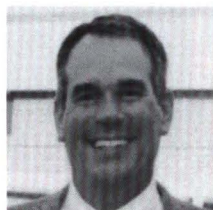

Alva V. Johnson, B.A., Political Science ('91), is now serving as the principal consultant to the Assembly Committee on Education in Sacramento.



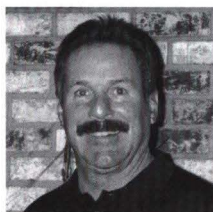

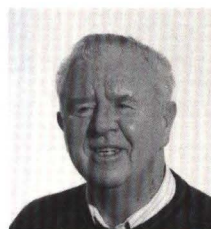

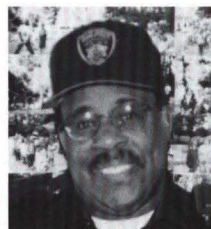

Newest Alumni Benefits - Free Email, Home Page

Free electronic mail, a personal on-line "yearbook" homepage, and access to other electronic services are among the newest benefits for Cal State Hayward Alumni Association members.

Under an agreement with the Internet Association Corporation, adopted in March by the board of directors, the new Alumni On-Line Community service will begin in early May. It can be reached through the CSUH website at <http://www.csuhayward.edu>.

The free electronic mail account will benefit alumni whose Internet connection does not include email service or that charges extra for this service. All Alumni Association members with an Internet connection will enjoy several new on-line options. There will be easy access to the CSUH and Alumni Association homepages, an on-line directory with current information about other alumni, free postings on the classified ad site, and job-hunting assistance with the opportunity to post a resumé on the career search site at no charge.

Other Alumni On-Line Community features include an electronic version of the Cal State Hayward alumni newsmagazine Haywire, information about volunteer opportunities and alum-

ni chapter activities, and interactive campus mentoring.

The email mentoring service, which is being developed in conjunction with the CSUH campus Mentoring Program, will allow alumni and other volunteers to provide advice and guidance to current students. Using this service, students will enter the field in which they need assistance and will receive a list of alumni mentor volunteers. Using their computer connection, students will be able to correspond with the mentors, who will reply when they can fit it into their schedules.
