
The action of the Public Works Board also required that by October 1, 1978 the district would have to confirm that the district matching share was available.

October 24, 1978

On September 5, 1978 the Governing Board, Ventura County Community College District allocated \$400,000 to the Oxnard College physical education projects and on September 19, 1978 the City Council of the City of Oxnard allocated \$431,000 (Resolution #7748) for assistance in constructing the outdoor portion of the Oxnard College physical education projects.

I am therefore prepared to certify that the District has met \$831,000 of the local matching requirement. I therefore respectfully request that the Public Works Board grant an extension of time until October 1, 1979, as provided for under section 81846 (b) of the Education Code (AB 2158), so that the district may obtain the final increment of its matching requirement for the above-mentioned projects.

Note: EC 81846 (b) reads as follows:

(b) Projects involving state funding which have been approved, but which are not yet under contract, and for which the community college district needs additional funds to complete the project shall not be eligible for additional funding pursuant to the act that enacted this section. However, any district with a project or projects under this category, which project or projects have or will obtain the further approval of the Public Works Board, shall have until October 1, 1979, to obtain alternate funding for such project or projects. Any state funds which previously have been committed to such project or projects shall not revert or otherwise be forfeited until October 1, 1979; provided, however, that such state funds shall revert if the district notifies the chancellor in writing that it will not proceed with the project or projects.
