We need your help to convince the Secretary of the Interior, Gale A Norton, to not approve taking newly acquired land in Oxnard into trust for a small Indian tribe from northern California to enable them to establish a huge casino and other projects in Oxnard. If she should do this then we will need your help to convince Governor Davis to not approve a Tribal-State compact for any gambling group in Oxnard or neighboring communities. Paragon Gaming, a limited liability corporation in Las Vegas, Nev. is proposing to buy land in Oxnard for the Greenville Rancheria of Maidu Indians to build a 150,000 sq. ft. gambling casino with 2000 slot machines and 175 table games, a full-service 250 room hotel, many restaurants, lounges, showrooms, retail stores, etc. The Ventura County Board of Supervisors unanimously opposed the same proposal in early March in the Channel Islands Harbor, which is in the City of Oxnard, but under the control of the Supervisors. Now Paragon wants it close to our new high school that will open in the fall, across from a long established chapel, a junior high school, an elementary school, and a new large residential development.

Several years ago a big gambling casino was proposed for the same area in Oxnard. Our very diverse community united in tremendous opposition to big time gambling in Oxnard and the project was denied. Everyone in Oxnard was opposed to it. Oxnarders do not want big time gambling. (See the enclosed newspaper clipping). This time the opposition is even greater to big time gambling.
