MANAGER COUNTS ACCOMPLISHMENTS OF THE YEAR

L.V. residents have watched a large number of work projects completed within the past fiscal year. According to General Manager Skip Roberts, all improvements were paid for out of budgeted funds, and substantial savings were made by having association employees do the work whenever possible.

Listed, neither in order or completion nor cost, are these major accomplishments:

The entire Rec Center was re-roofed and twenty separate air-conditioning units installed.

Approximately 21,000 square feet of concrete walkway were laid, branching out from the Rec Center. About one linear mile of walkway will be replaced each year at a cost of about \$28,000, until all asphalt walks

SENIOR LEGISLATURE

There is a great deal of concern being expressed by many of our residents in regard to the selection of health insurance coverage.

With drastic cut-backs by Medicare, the increase of insurance charges, and limitations set on coverage, we have a real worry about health service protection. The market is expanding rapidly with almost everyone in the insurance business.

It is very important to get information that is accurate. We have two valuable publications coming into Ventura County, namely: Senior World and The Senior. Both contain information and resources that should be kept on file for immediate or long-term needs. This month the Senior World has an excellent comparative study on HMO's.

Now to get back to Insurance, the following is suggested for selection:

1. Select companies that have been in the business, with good track records, for a long time.
2. Request up-to-date information on their costs, coverage, age factors, and financial action.
3. Ask what are their reserves and rating.
4. Talk to friends and determine the direction you wish to take.

The competition is very intense and opportunities for good coverage at lower costs will result; therefore do a good job in studying the situation.

KEEPING AN OPEN MIND

Last month ILV printed a flash from Lou Okun, Chairman of Leisure Village Board of Directors, stating that the Board is in full accord with the Camarillo City Council's stand protesting the move of the Air National Guard to Point Mugu. That statement came to us so late that there was no time to print any statements of those who might have opposing opinions.

Hardly anything is ever all black or white.

ILV has tried to adhere to the policy we published early on, to treat all subjects as objectively as possible. We believe that we can best serve the Village in this way.

This has also been the stated policy of the Board of Directors for use of the center, to the point of their sometimes insisting that programs there, not be presented unless someone of the opposing opinion be slated to speak AT THE SAME MEETING. While this may be a little overly cautious, we cannot fault the thinking behind it.

We believe that fair-minded people are always eager to consider dispassionately any points that dissenting thinkers may put forward.

This does not seem to be what has happened on the Point Mugu proposal. The allegation was made that property values in the Village would be sure to drop "because of the noise pollution". Some villagers have become panic-stricken. Many have signed a petition without hearing one other argument, either for or against the move. There is always the tendency to trust those people whom we know, and to go along with them without taking time or effort to examine all the facets of the issue for ourselves.

But a heartening thing happened at the L.V. Board Meeting on April 1st.

Two homeowners rose to speak out for the acceptance of the Air National Guard at Point Mugu, which recently has been such a one-sided and emotional issue in the Village. They asserted that it has been difficult to voice their views at all here.

If this is so, it is very wrong. No matter what our personal feelings, we have the obligation to ourselves to learn as many facts as possible on both sides of any issue. Since Leisure Village usually acts as a large voting bloc in Camarillo, we have the responsibility to make doubly sure that we have meticulously evaluated all the evidence available, and carefully examined it. The more emotional an issue is, the more necessary this becomes.

ILV attempts to maintain its policy of strict neutrality on Point Mugu, but we can only applaud the fact that there are people in the Village who are courageous and willing enough to exercise their right to speak out against a popular cause and to inform us of some of the plus-factors of the Air National Guard coming to Mugu.

Was anybody listening?

We hope so, for this is democracy in action.

RE: POOL

Rules and regulations are truly "WRITTEN IN STONE". They are to be observed by residents, the hired staff, and the Board of Directors. If the rules are not observed and enforced we'll only have anarchy. Why bother having any rules at all? If the rules and regulations are no longer pertinent, then let's get them off the books.

It is my job as a member of the pool committee to monitor the pool facilities and to report conditions which might be unsanitary, unsafe, or which are in violation of the rules and regulations. I take my job seriously. If my reports go unheeded and unanswered by the staff and the Board of Directors, then I feel it my duty to report to the residents in any way that remains open to me. Fortunately we have the ILV Letters To The Editor.

If the staff really believes that the "residents are dirty", then obviously changing 65 year-old habits is not possible. The alternative is to clean the facilities more often. Covering up incompetency with ridiculous excuses is not the answer.

At the April 1 LV Board meeting the recommendation from the Education and Recreation Committee to DIRECT EMPLOYEES (the staff), to maintain the pool temperature between 82 and 84 degrees, was deliberately misread and misrepresented by the Board.

They made it appear as if the committee was recommending a change in the rules and regulations rather than their enforcement. Of course there is no controlling the weather, but is there any reason why the temperature of the pool water can't be regulated despite inclement weather? All that's required is that the heater be adjusted, automatically by using the existing timer, so that it goes on earlier in the morning, or on colder days, it remain on all night. Of course this takes adequate supervision on the part of management, but it seems that the Board is reluctant to insist on it. It appears,

they would rather have the "tail wag the dog".

electricity, there was a clause which suggested and advised that for those who needed heated pools for therapy, the water temperature should be maintained at a comfortable level.

I therefore request that the thermostat setting of 83 degrees be maintained for the enjoyment of us less than vigorous swimmers, who, for health reasons, swim for physical therapy.

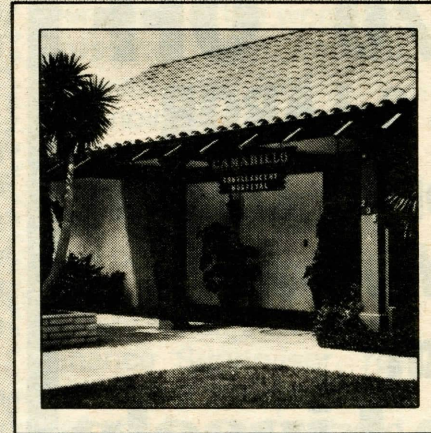

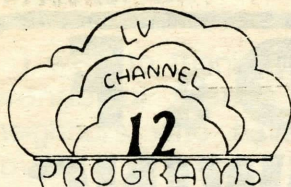

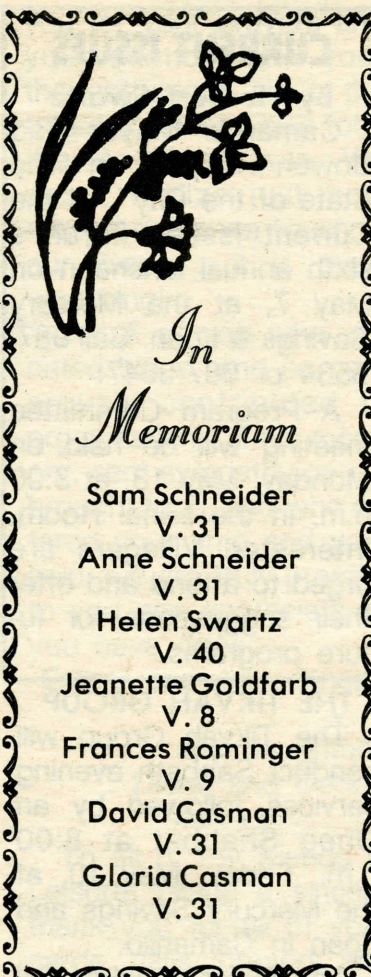
VILLAGE PAINTINGS ON DISPLAY

along the west side of the swimming pool to provide wind protection.

Patio furniture was refurbished by employees at a saving of about \$8,000 over an outside contract.

Two additional showers were built in the women's dressing room and all showers were tiled.

Renovation of the Rec Center foyer, hall, WCR, restrooms, new carpets, table, and chairs have given a completely new look to the area.

Gary Nottingham, Maintenance Supervisor, reported that 215 trees and 140 shrubs were replaced during the year. About the same number of shrubs will be replaced next year, and some 100 trees, as needed.

Residents repaired the Lapidary Shop with materials purchased by the Association.

The Association provided rough plumbing and electrical outlets for a

dark room which is being built by Camera Club members in the storage area near the gardens.

The filter room at the swimming pool was replumbed.

Projects already scheduled for next year include these items:

Renovation, first of the Library, then the MCR and MPR, depending upon the state of the budget.

Resurface the paddle tennis courts.

Repaint all village entry signs. Luminous paint will be used on the numbers to make them visible at night.

Our association remains in stable financial condition thanks to the careful planning of the Finance Comm, Budget Comm, Board of Directors, General Manager, and Staff.

CURRENT ISSUES FORUM

A panel of three experts discussed the "Victim/Vigilante and the Criminal Justice System" at the March 29 meeting of the Current Issues Forum.

Ventura County Senior Deputy District Attorney Richard Holmes claimed that society has moved to the criminal's side by being more concerned with individual rights than the rights of the victim. He said we allow suppression of the truth at criminal trials to the bewilderment of victims as to how the criminal escapes justice.

We believe it is better to allow a thousand guilty men to go free to avoid one innocent man being convicted. The result is that criminal defendants are encouraged and victims lose faith in the system. "A society which

does not swiftly take action against the criminal encourages vigilantism."

Forensic psychiatrist Dr. T.E.A. von Dedenroth, who acted as moderator for the program, agreed that there isn't much faith in the criminal justice system. He expressed the view that violent action is learned from the family experience and is reinforced by what is viewed on television. He said that those who do not learn self-condemnation for anti-social behavior will commit violent crime.

Robert Schwartz, a Ventura defense attorney, condemned vigilantism, saying that people can't take law into their own hands. He said "we get cases like Bernard Goetz, not because of lack of faith in the criminal justice system, but from lack of police protection." He praised the jury system and the presumption of innocence in criminal cases.

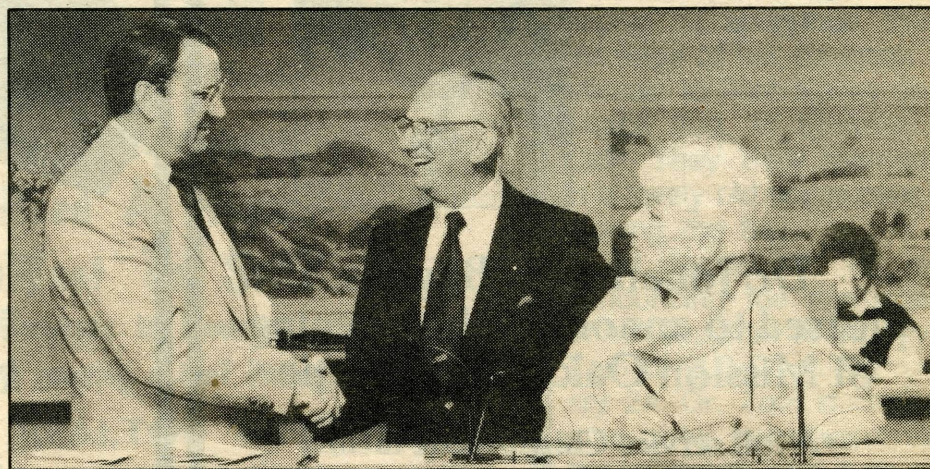
Rube is active in other
