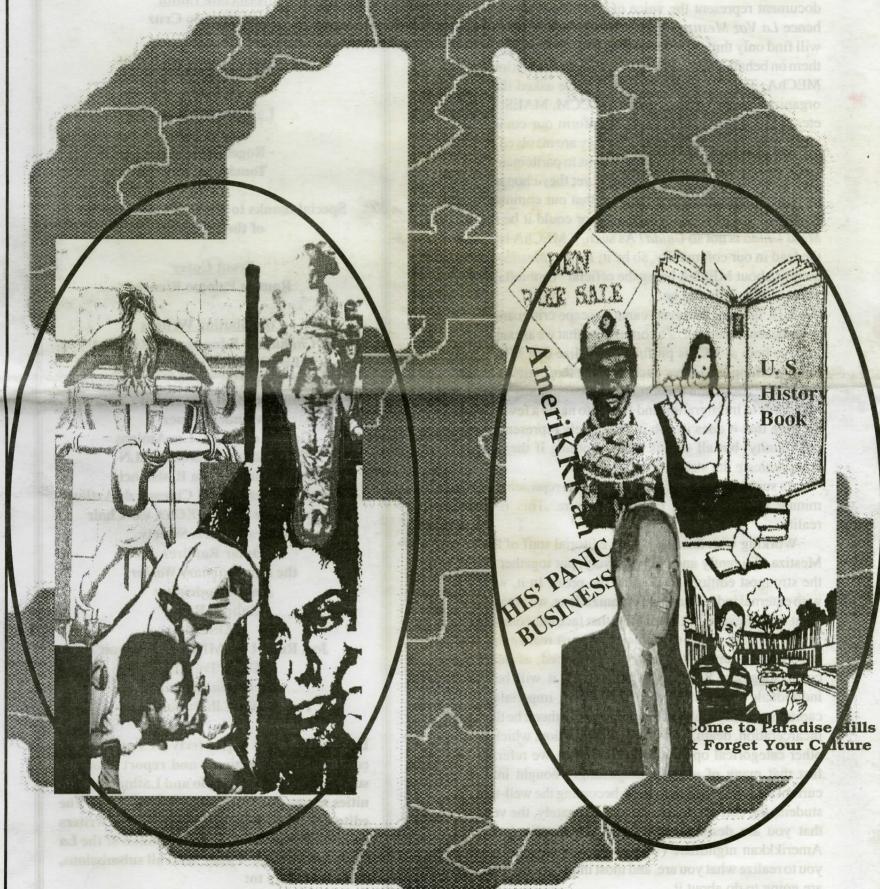

EDITORIAL

How can you be nonviolent in Los Angeles, as violent as you were in Vietnam?

How can you justify being nonviolent in the Southwest (Aztlán), when your homes are being destroyed, your people are being murdered, and at the same time you're violent with Vietnamese, Central Americans, Koreans, Middle easterners, and someone else you don't even know?

If violence is wrong in America,

violence is wrong abroad.

If it is wrong to be violent defending brown women,

brown children, brown babies,

and brown men,

then it is wrong for America to draft us, and make us violent abroad in defense of her.

And if it is right for America to draft us, and teach us how to be violent in defense of her, then it is right for you and me to do whatever is necessary to defend our own people right here in this country.

"Thirty Years Of So-Called Affirmative Action Have Not Undone 300 Years of Racism and Oppression."

The voter resentment promoted by opportunistic politicians against Latino and other immigrants, which culminated last November in the approval by the California electorate of Proposition 187, is about to be channeled against a much broader sector of the U.S. population. The same conservative political trend that led to the approval of Proposition 187 is now poised to go after all underrepresented minorities—Blacks, Latinos, and Asian Americans— and women, by attempting to undo affirmative action programs.

The goal of these anti-affirmative action forces is to place a voter initiative on the California ballot in 1996 outlawing affirmative action. They hope to accomplish this either by an act of the legislature or by gathering enough registered voter signatures. If approved, the measure will mandate an end to minority and women preferences in government hiring, school admissions, and government contracting. These preferences have evolved from a 1964 law resulting from the civil rights movement of that decade.

During the 1960s, affirmative action programs were designed and implemented to reverse three centuries of racial discrimination and oppression in this country. They were

called affirmative action because they pretended to go further than just outlawing discrimination; their purpose was to undo the harm already committed for generations.

At the national level, affirmative action seems to be taking a back seat. However, we can be sure that if California voters approve the initiative, rhetoric and arguments against affirmative action will be repeated at the national level. All major Republican contenders for the 1996 presidential election have already spoken against affirmative action. It is not unexpected that the Democrats will follow suit.

The California initiative proponents claim that the goals established by affirmative action programs are no longer needed, and that their objective is no longer needed, and that their objective is to prevent injustice from "reverse discrimination" against a group (White males), when opportunities bypass them for less qualified minorities. Although this initiative has an enormous impact upon women, since affirmative action programs also include women, the proponents leave women out of their discourse on the initiative, fearing they will lose votes if that aspect is widely disseminated.

Needless to say, we disagree with their

arguments. Those of us who are women and/or who belong to racial minorities know that racism is still very prevalent in this society. Our every-day experiences and the passage of Proposition 187 send a loud message to us that even thirty years of so-called affirmative action have not undone three hundred years of racism and oppression. White males continue to dominate economic, government, and educational spheres

in this country. Yet, given the political climate today, the anti-affirmative action initiative and movement seem to have ample support among voters. A coalition of the affected sectors and their progressive allies needs to organize and mobilize NOW.

Wetbacks, illegal aliens, undocumented immigrants, foreigners, illegal immigrants: call us what they will, we are here in our homeland of Aztlán and no matter what law or prejudice they pass on us, we shall never give up, for we are the ones who plant the seeds, water the fields and gather the crops. We have worked this land just as long as anyone. We pay our taxes, and help out this country. So why is it that we are not welcome? Throughout history, laws have been passed, some failed, but they all had the notion of making us, the Mexicans, feel inferior. They were laws concerning the denial of education, labor, social services, or anything "suspected" of the immigrant leeching to. This perception is what the majority of "Americans" feed upon. "Americans" now believe the United States is being invaded by a wave of immigrants, primarily Mexicans. Efforts to stop the "menacing flow" by passing tougher immigration laws and tightening enforcement along the imaginary division line between the United States and Mexico have been attempted but until this day have not been successful. Undocumented and documented immigrants are withstanding hardships to come to the United States. We tolerate low wages because in this capitalistic, imperialistic, bureaucratic society, "unskilled" workers are paid low, but we work because we need to eat and pay our American taxes. So why have laws been put forth to oppress my people? We are oppressed, whether it be economically, physically, or mentally, this society has made

us a target.

In 1982 the United States Supreme Court struck down a Texas law that would have denied undocumented children from public schools. In this case, Plyler v. Doe, the state wanted to save money. Money that the "undocumented children" were funded by. It was also designed to reduce the flow of undocumented immigration. Fifty two years before this case, the education of immigrants was also challenged. On July 23, 1930 in the small town of Lemon Grove, California the towns Parent Teacher Association (without Mexican representation) requested that a school be built to segregate Mexican-American students. This case ended as the nation's first successful legal challenge to school segregation, a landmark decision. The state was trying to deny an elementary education to a population that is part of this society. Taking away the education will only hurt this society. Plyler v. Doe and the Lemon Grove Incident were key in that such implications are likely to result in the creation and development of an underclass in our society.

Congress passed the Immigration Reform and Control Act in October 1986. This act was aimed towards undocumented immigrants in the area of labor. It would make it much harder for undocumented immigrants to work. For the first time, the business community faced sanctions for hiring undocumented immigrants. Employers found guilty of breaking the law can be given a fine up to \$2,000.00 per worker, plus jail time. The law also

included a segment which was dedicated to the enforcement along the imaginary line between the United States and Mexico. Because of this law 3.1 million undocumented immigrants obtained legal status (amnesty). In 1988 the number of captured undocumented immigrants was reduced by one-half. This raised hope for the "Americans" but it was short-lived. The companies here in the United States "love" undocumented immigrants. They exploit them by paying them under the table. Because unemployment, and low income pervade Mexico, the United States is the ideal destination as it offers considerable employment and income opportunities. If the sentiment is to get undocumented immigrants out, why do companies still hire them? They simply want them for their labor not their minds; an attribute brought upon by Immigration Reform and Control Act. because of the legalization of the 3.1 million, which was supposed to slow illegal immigration, it did the opposite. The immigrant workers thought they were going to lose their jobs, and have to go back to Mexico. But the companies did nothing except lower their wages, which led to the creation of an underclass, a class outside the "norm," or "mainstream," in the shadows of society they partake in. IRCA was supposed to stop them from being hired. Because of this law and its failure, more undocumented immigrants are crossing over to the United States. An underclass has developed, a whole economy not reported to the continued on pg. 18

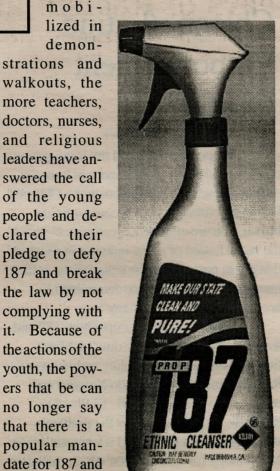
We must push the struggle forward. We must build even more defiance, non-compliance, and resistance against 187 and all attacks on immigrants. **EVERYONE MUST** REFUSE TO OBEY 187! We must build defiance, non-compliance and resistance against all the other attacks on immigrants: border blockades, scapegoating, denial of work, denial of health care, raids, roundups, and deportations.

In October and November, public opinion turned against 187 exactly because over 100,000 people marched on October 16, thousands of students walked out, and people who are the target of 187 refused to accept it. And why should they accept it? Many politicians say the students and young people went too far in the movement to defeat Prop. 187. They say that all the brown faces in the streets, the Mexican flags, the walkouts, and the confrontations with the police only hurt the struggle and turned people in favor of 187. WRONG!

The more people have resisted in the streets, the more other people have had to

seriously look at what 187 will really mean and the more people have turned against it. The more that people have

lized in demon strations and walkouts, the more teachers, doctors, nurses. and religious leaders have answered the call of the young people and declared their pledge to defy 187 and break the law by not complying with it. Because of the actions of the youth, the powers that be can no longer say that there is a



The only reason a lot of these politicians spoke out against 187 is because they were afraid that if it passed people would take to the streets and professionals would defy it. These are the same politicians, Democrats and Republicans, who support the border blockades to keep immigrants out of the U.S., the denial of the right to work to people who are undocumented, the denial of welfare and other social services to the undocumented, and the registration of everyone on a national computer system so immigrants without papers can be denied work and social services. Already they are pushing through other plans to accomplish the same goals. In fact, immigrant children are already being kicked out of schools and immigrants denied health care.

What we believe:

- 1) People are driven from their homelands and come to the U.S. to survive.
- 2) All people have a right to survive regardless of legal status.
- 3) Being an immigrant is not a crime. Human life is more important than laws.
- 4) People with legal status have the responsibility to defy and resist unjust laws, struggle alongside our brothers and sisters who have been declared "illegal" and protect them.

With Liberty and **Justice for All**

We must wonder at the speed with which the affirmative character of ethnic diversity has turned back on itself in this bitter struggle for American political territory. We must wonder at the polarities instantaneously created in this struggle and the way in which those polarities defy the diversity that lies at the heart of the contentious jousting over affirmative action. We must despair over the understanding that affirmative action will not save or damn America's soul. But most importantly, we must not grieve the imminent passing of such an institution, but instead seek solace in the opportunity these times give us to walk beyond affirmative action into a new understanding of American national identity that is more inclusive and representative.

The racial intolerance that now plagues California is not the result of, nor will it be relieved by affirmative action policies. At the University of California, such policies, particularly implemented in admissions, do not claim a large number of underrepresented students, yet these policies persist in their stigmatization of all minority students as foreigners, as others, as inferior. The scapegoating of affirmative action is symptomatic of larger rifts in the American national community, rifts that go as far back as initial contact between Native Americans and Europeans. As Americans we have struggled to define a body politic

that represents the interests of diverse groups. However, sometimes America fails to remember its origins as an immigrant culture, a lapse in memory that results in the persistent alienation of individuals and groups who challenge "majority" interests. We have further struggled for inclusion in the national community and simultaneously for individual and

cultural identity within the larger interethnic body politic. Both Proposition 187 and the threat of the California Civil Rights Initiative tempt us away from our faith in representative democracy.

While difficult, it is precisely at this time that we must renew our faith in the American democratic process and its promise of a balance between liberty and equality. For those of us at the University of California, this means preserving equitable admissions and redoubling our efforts to maintain a diverse intellectual community which supports the achievement and success of all of its members. In return, we ask for the support of the community and the faith that California

> public education will not betray its best intentions.

Stereotypes confusing ethnicity with intellectual potential have gained strength in public debates over the merits of affirmative action. The absurdity of such stereotypes in the midst of their empowerment testifies to the ideological force of myth in the construction of state and national iden-

tity. Such myths must challenge us to open up a thoughtful dialogue in the educational community about the efficacy of a racialized identity in a society whose diversity and hybridity challenge racial categorization. It is through education that such discussions can reach the ears of those who will inherit the effects of either our wisdom or our folly.

Educators have been no-

toriously overwhelmed by the pressures of public educational philosophies which have promoted and maintained an assimilationist model for American education. Neither demographic reality nor curricular trends toward multiculturalism dismantled have assimilationist paradigm. Tracking, both formal and informal, negative expectations, standardized tests, and socio-economic disadvantage have ensured that educational opportunities tend to distribute themselves along racial, cultural, and gender lines. Yet it is precisely within the realm of education that the democratic promise of equal opportunity must be maintained and supported from within and without. Public education builds bridges between policy and practice, between ideology and experience, and between learning and teaching. We must all work to maintain the structural stability of California education.

Education is a public good; it allows members of a national community to participate in the dialogues that continue to engender democratic exchange and development. The University is committed to greater educational collaboration in order to preserve the democratization of intellect and educational opportunity. But

Latino Leadership Conference The Immigration Crisis Proposition 187: A post Election Analysis On Its Implications January 13 and 14, 1995, Riverside, Califaztlán

On January 13 and 14, the Ernesto Galarza Public Policy and Humanities Research Institute at UC Riverside sponsored a Latino Leadership summit conference about the immigration crisis that is hitting California and the possible consequences and solutions that such a crisis implies.

A delegation of UCI students attended the important summit which united Latino leaders from the Southwest in order to draft a plan of action against anti-immigrant legislation. Many Chicano/Latino leaders from California, Arizona, New México, Colorado and Texas shared their views and experiences of the problems that are affecting our 'gente' from the Southwest communities. The leaders from California agreed that Proposition 187 is the biggest threat to the Chicano/Latino community regardless of legal status. Many of the leaders fear that when proposition 187 goes into effect all people of Mexican or Latino descent will become a "probable illegal" suspect.

The generalization or concept that all Latinos are undocumented is a big lie. Only around 23% of the Latino population in California is undocumented, while around 37% are legal residents and the remaining 40% are citizens through naturalization or were born in the United States. The suspect hysteria implies a justified hatred and racism towards people of color, and in particular, the Latino people.

Plan de Riverside Chicano/Latino Empowerment Conference

Proposition 187 and the immigration crisis were the two most important issues at the summit given their effects in the Chicano/Latino community. Just because you are brown, you are eligible to become a target of the racial hatred of a few ignorant individuals that are in pursuit of their materialistic selfish interests, and that they are determined to accomplish their goals at any cost.

As a response to proposition 187 and the immigration crisis, the director of the Ernesto Galarza Public Policy and Humanities Research Institute, Armando Navarro and other Latino leaders drafted "El Plan De Riverside" which addresses the problems affecting nuestra gente; and it suggests a post-187 strategy for mobilization which includes the use of boycotts at pre-selected institutions. recycling the brown dollar, lobbying and other actions. The Plan de Riverside will be submitted in the following months to every Chicano/ Latino institution and the people in the community for approval. El Plan de Riverside can not go into effect until it is accepted unanimously, like the Plan de Aztlán. The drafters of El Plan de Riverside want it to become a universal strategy guideline for the defense of the Chicano/Latino community-- in that way la Raza would have a more efficient and organized movement.

One of the solutions that the Plan de Riverside suggests is a restructuring of the student movement. At the summit, all the participants agreed that the students are the most important asset to the solutions of the problems affecting our communities. The participants suggested a revitalization of the student movement: students from the different schools that attended the summit came with some suggestions that will help the community deal with the proposition 187 crisis:

1) Escuelita Program- in case 187 goes through, a new system of education for

our Raza.

- **2.) Health Care-** Raza Health Center to provide for our people regardless of documentation.
- **3.) Citizenship Drives** to strengthen the Chicano/Latino vote.
- **4.) Community Communication Codes** special codes and secret passwords, e-mail are suggested for the creation of the Chicano/Latino internet.
- 5.) Higher Re-education- Massive campaign for retention and recruitment of Raza with the focus of an education revolution in the dawn of a new revolutionary era.

One of the highlights of the summit was the presence of Revolutionary leader Reies López Tijerina. Reies Tijerina took justice into his own hands in the 1960's and at Tierra Amarilla (Nuevo México) kidnapped two senators in opposition to the Treaty of Guadalupe Hidalgo. Now known as the courthouse raid he served time for his struggle, but after getting out he went on a mission to pull a "Citizen's Arrest" on Supreme Court Justice Warren Burger. Tijerina enlightened and enraged the audience with his passionate details on the struggle and the need to recapture the new revolutionary movement.

The Chicano/Latino summit was one important testimony that La Raza is starting to unite; although the process seems slow, it is up to us, as students to accelerate that process and make the changes that will benefit all. You now have six suggestions on how to get involved, and if you want more information on how to get involved come to the MEChA meetings every Wednesday @ 5:00 pm in the Cross Cultural Center, or go to your local community center and ask for information where you can help as a volunteer. You can make a difference!

Well, tomorrow is the 8th; we will see what happens. I pray to God things go right, because if we lose, things will get hectic. There will be a revolution. We shall not be brought down; we shall not get stepped on. Not now, not ever, not in our Mother's nation of Aztlan. My people shall rise above all. We asked for equality. Now I am afraid we will have to fuck equality and take control. Esta es mi tierra, don't ever let anyone take what is yours. Now is the time when we have the right to defy authority. Now we can fuck the rules. Now, we must unite. Now is the time. Simple minded indegenous Indians in Chiapas knew the meaning of pride. Well, if my people really have any, we shall fuck everyone and everything in sight with it. Passivity is over; now it is our turn. An eye for and eye. Only thing is, I'll take both your eyes. Now it's my turn to be greedy, mother-fuckers. Like I said, fuck equality, we want control.

Letter to the Editors

The following letter was written to La Voz Mestiza the day before the Proposition 187 vote. Clinton's Desperate Bailout of the Mexican Peso Can't Stop U.S. Imperialist Decline

Clinton's executive decision to prop up the collapsing Mexican peso with a \$50 billion loan package is a desperate gamble dictated by U.S. imperialism's weakness. Clinton & Co. had no choice. The alternative was a possible collapse of the world financial markets and worldwide depression.

Clinton's biggest political opponents, Newt Gingrich and Bob Dole, hailed his action as "courageous" and heaved a sigh of relief that the Clinton bailout didn't have to lose a congressional vote. Henry Kissinger praised the Clinton plan, explaining that U.S. bosses would lose their ability to suck super-profits from Mexican workers if they didn't act quickly and decisively. Clinton's action and his support from Gingrich, Dole, Kissinger & Co. show that despite certain internal differences, the main wing of the U.S. ruling class can unite to defend its interests. With billions at stake, the big bosses could care less about their own "democratic"

process. The bailout is a good lesson in the exercise of capitalist state power.

Home is Where the Money Is

Vital U.S. imperialist interests are indeed at stake in México. The worldwide crisis of overproduction has left U.S. business particularly vulnerable to foreign competition. European and Japanese bosses are solidifying their local markets and looking to invade turf previously dominated by the U.S.. Japanese investment is increasing throughout Latin América, particularly in México. The European Community (E.C.) has set up a "free" trade group ("Mercosur") with

several Latin American countries.

U.S. bosses concocted the North American Free Trade Agreement (N.A.F.T.A.) to resist the Japanese and Europeans by tightening Wall Street's control over Western Hemisphere economies. On one level, N.A.F.T.A. has been a windfall for U.S. business. Since it was signed, U.S. exports to México have increased nearly eighteen percent and have grown three times faster than U.S. exports to the rest of the world. On the other hand, like all capitalists out to make maximum profit, U.S. rulers' eyes were bigger than their stomachs. Their N.A.F.T.A. windfall began sputtering almost immediately.

Taking advantage of the deregulation and privatization "reforms" that allowed them to steal fortunes during the past decade, México's rulers sold tens of billions of dollars in stocks and bonds to U.S. interests over the past few years. The issues were gobbled up by investors looking to do better than the three percent interest they could get on the U.S. market. Mexican bosses found themselves caught in a vise. In order to pay the interest on the \$166 billion México owes in long-term debts, they had to issue short-term junk bonds ("tesobonos") yielding as much as fifty percent interest. The bubble didn't take long to burst.

Even a forty percent devaluation of the peso—a massive wage cut for Mexican workersover several weeks didn't settle the Mexican money markets or stabilize México's debt service. A huge injection of fresh capital was needed. The peso's devaluation wiped out the U.S. trade surplus with México and would have created deficits for the foreseeable future without the bailout. If México fell into a long depression, the big money boys would panic and pull the plug elsewhere, creating major depressions throughout the world. Faltering U.S. exports would threaten a collapse of the U.S. stock market and a depression on the home front as well. So the Clinton bailout packcontinued on pg. 17



La devaluación del peso: México pierde en la economía

En México la mano de obra se paga por peso, pero ellos venden los productos a precio dólar, ya sean productos agricolas o productos fabricados. Mexicano les imponen a las compañías nacionales, como la limitación en producción, tales pueden producir cierta cantidad de un producto y otros que no se les permite producir. ¡Hipocresía de parte del gobierno Mexicano y el Estadounidense!

•La situación del indocumentado Guatemalteco en México y el indocumentado Latino en los Estados Unidos

La elección estatal en California, que se realizó el ocho de noviembre, reelegió a Pete Wilson como gobernador, y la proposición 187 se convirtió en ley. Un día después, el Gobierno mexicano anunció oficialmente que estaba en contra de la proposición 187 por ser racista, inconstitucional e inhumana. Entonces, ¿por qué cuarenta mil indocumentados centroamericanos sufren en carne propia, en el estado mexicano de Chiapas, las mismas carencias que enfrentan los trabajadores indocumentados latinos en California?

Datos del Instituto Nacional de Migración de México indican que en lo que va del año han sido deportados entre doscientos y 250 extranjeros mensualmente, por lo que en 1994 han sido expulsados de territorio mexicano más de sesenta mil indocumentados. ¿Pero qué no se supone que el Gobierno mexicano está en contra del racismo, y en favor de los derechos fundamentales de los indocumentados?

El Comité Diocesano de Ayuda a Inmigrantes Fronterizos afirmó que los hijos de unos cuarenta mil indocumentados de Guatemala han sido rechazados en las escuelas de educación elemental en Chiapas. Al mismo tiempo los hijos de guatemaltecos indocumentados tampoco pueden acceder a los servicios médicos y de salud.

Agentes del Instituto Nacional de Migración han establecido en Chiapas con policías de otras corporaciones, una barrera infranqueable para los inmigrantes ilegales. Esta barrera en contra de los inmigrantes subió cuando México inició las negociaciones del Tratado de Libre Comercio (T.L.C.) con los Estados Unidos y Canadá, y en los últimos dieciocho meses ha deportado a más de 150 mil extranjeros por la frontera con Guatemala. El obispo de Tapachula, Monseñor Angél Chávez, señaló que todo aquello que México critica de las autoridades norteamericanas en contra de ilegales de su país, "los mexicanos lo hacen con los indocumentados



que vienen a la frontera sur a buscar trabajo."

La profesora, Sylvia Trujillo de ciencias políticas en la Universidad de Guadalajara, dió este comentario sobre el papel del Gobierno mexicano: "¡Lo que el Gobierno mexicano dice oficialmente es sólo una fachada, una frente, para quedar bien con los latinos que viven en los Estados Unidos, pero lo que en verdad debería contar son sus acciones. La acción siempre vale más que las palabras."

El plan desarrollado por el Gobierno mexicano revela que antes de que se aprobara el Tratado de Libre Comercio de Norteamérica, México fue obligado por los Estados Unidos a detener la migración desde la frontera sur, lo que ha propiciado que Guatemala sea la receptora de miles de indocumentados.

Un comprobante de esto se ve en la gran similaridad entre la barrera infranqueable

que ha puesto el Gobierno mexicano y la Proposición 187 que se convertirá en ley, en California, el primero de enero del 1995. Los dos buscan negar la educación fundamental, los servicios médicos y de salud a todos los indocumentados.

El crimen que los Gobiernos mexicano y estadounidense están cometiendo es que quieren vendar nuestros ojos para que no veamos la realidad. Los gobiernos quieren hacer a los indocumentados como chivos expiatorios, víctimas a quienes les han culpado por todos los problemas que sus sociedades están enfrentando. En California, la Proposición 187 se ha convertido en ley. En México, siguen expulsando entre 200 y 250 extranjeros cada mes. Parece que la batalla la van ganando los gobiernos y sus políticas racistas, inconstitucionales e inhumanas. Ahora han dejado a nuestra comunidad latina completamente dividida. Como la señora María Villafaña me dijo cuando le expliqué de este reportaje: "¡No está bien que escribas algo negativo de los dos gobiernos. Yo sé que son sucios, pero 'horita que nos odian aquí en los EEUU se les va a hacer hasta más fácil sacarnos del país y negarnos los servicios más básicos que necesitamos para sobrevivir!" Lo que la señora María Villafaña dijo es cierto, pero si uno no intenta revelar la verdad entonces siempre estaremos luchando contra uno al otro y no con los verdaderos enemigos.

La unión se debe buscar entre los más de 40 mil indocumentados guatemaltecos que están sufriendo las mismas condiciones que sufren los trabajadores latinos en California. Pero si hay un sistema opresivo que sólo buscar beneficiarse con nuestro esfuerzo y nuestros pulmones, entonces, como latinos, tenemos que unirnos para luchar contra ese sistema. Querer la educación, los servicios médicos y de salud no es algo radical ni comunista... es fundamental. Es necesario para sobrevivir. La hipocresía de sistemas o gobiernos opresivos no hay que barrerla abajo de la carpeta sino desenmascararla para que todos vean la realidad.

Por fin, el dinero y la fachada no debe traer miedo, ni debe comprar nuestras creencias, y nuestros valores morales por las tácticas manipulativas de gobiernos opresivos.

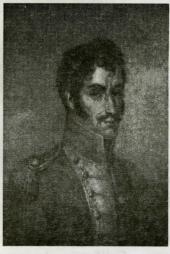

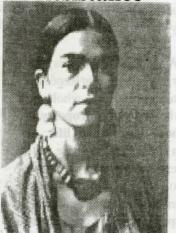

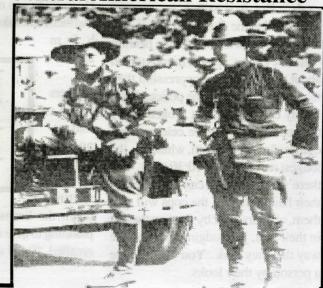

GRINGO JUSTICE: The Murder of César Arce

William Masters, a 35 yearold white male, shot and killed César René Arce, an unarmed 18-year-old Latino youth, at 1 a.m. on January 31 in the San Fernando Valley of Los Angeles. Masters was arrested by the LAPD and held without bail. But two days later he was released, free of all charges. The District Attorney said it was "justifiable homicide"-taking at face value Masters' claim that he was afraid of being robbed. But the real justification in the eyes of the system was that René was not only a Latino youth, but a writer (graffiti artist) who was tagging a freeway underpass just before his death.

When William Masters pulled the trigger that killed César René Arce, his actions typified this whole sick system-where law and property are valued more than human life. And the media came to his defense. In an atmosphere where the passage of Proposition 187 has fueled a vigilante mood against immigrants, talk shows and newspaper articles hyped fear and hatred-pitting white citizens against outlaw Mexican youth. For the Latino youth the release of Masters and the murder of Arce has brought into stark relief the double standard of justice where the oppressed people cannot have a spray can while police and reactionary vigilantes can murder in cold blood.

On Sunday, February 5, a wake was held for César René Arce in a mortuary in the town of San Fernando, a couple of miles from where he was killed in Arleta. The San Fernando Valley, especially in its northern reaches, doesn't look much like the shopping mall's in the film Valley Girl. It's an industrial area, with gravel pits, garment factories and huge junk yards. It is criss-crossed by flood control channels leading south to the Los Angeles River and by freeways going north to Simi Valley. Although most of the Anglo students in the L.A. School District live in the Valley, most residents are Latino. Many work in local industry, or tend lawns in the better-off areas of nearby Ventura County.

Arleta is single-family houses, with chimneys and neat fenced-in yards. But it is still L.A., an area patrolled by the Foothill Division of the LAPD, best known for the beating of Rodney King. René's friends talked about the day-to-day oppression they face, beginning with the police. Even family celebrations get broken up by the cops. "Say they're celebrating a quinceañera or baptism, whatever, the longest it ever lasts is 10:30 or 11. Say there's four guys in a car. Just because their hair is shaved, the cops will stop them, of course. Or by the way they sit in their seat, just judging them by the way that they look.. You don't judge a person by their looks.

LEGAL LYNCHING: Sleepy Lagoon II

About 100 people dropped by René's wake throughout the afternoon, people of all ages. They sat together in the small chapel, hugged and comforted each other, and gave their condolences and respects to the family. As a group of youth were taking a break outside the backdoor, Lucy, 18, who had known René for years in his former home of North Hollywood, had been wanting to talk to the press, "Nobody has talked about what he has done. He and I tutored little kids together. We

used to help all the little kids we could. We went to Burbank Elementary. You could call him any time in the

morning and he would pick you up if you needed a ride. None of the press are saying that."

The underpass they were tagging was a lonely spot located in Arleta, an area in the northern end of the San Fernando Valley. David told Revolutionary Worker that they first noticed Masters when they saw a man writing down their car license number. "René saw some guy writing on apiece of paper. We knew right away that it was the license plate number. René ran across the street and told him to hand over the number. I started walking towards the guy. I said, 'why don't you give my friend the number?' He said 'No' to me and then René asked h i m

Elena Penuelas's nightmare is always the same. first there is the gruesome image of the dead Anglo boy, Steve Woods. His eyes are wide open but empty. A thin steel rod protrudes from the side of his head. It has skewered his brain from ear to ear.

S u d denly people are screaming at Elena in English, a language she does not understand. "We are drowning."

Five out of the six young Mexican men charged in the case, face possible lifetime sentences in prison for Steve Woods's death. Their case has become a dark mirror of class and ethnic polarization in the conservative suburbs of Orange County.

The kids from Sinaloa, many of whom could barely speak English, bore the brunt of racial slurs and crude "beaner" jokes. Some, like 18 year old Saul Penuelas, found the daily hu-

miliation intolerable a n d dropped outtowork full time. H i s younger brother Hector, 16,

buried himself in the extracurricular fervor of Youth for Christ.

On the evening of October 15 last year, following a Friday football game, San Clemente High's two worlds inadvertently confronted each other in the Calafia Beach County Park parking lot. Seventeen year old Steve Woods and four carloads of friends were partying at the bottom of the lot; two carloads of Mexican kids, including Perez Bonilla and the Penuelas brothers, were parked near the top.

Both sides had been drinking beer, and the kids at the bottom of the lot may also have been doing drugs. The Anglo teenagers later admitted that they drove their cars "very fast," with headlights off, toward the exit where the Mexican youngsters were standing. But Woods's friends claimed they were merely trying to escape after one of their friends had been slapped by Julio Perez Bonilla, who was mad because the boy had flipped him the finger earlier in the week.

Hector Penuelas, Testified that the four vehicles "were coming directly at us, and we were scared. We thought they were trying to run us over." Hector threw a block of wood and Julio, a short length of copper pipe. Meanwhile the rest of their group hurled beer cans, an old badminton racket and several paint rollers from the back of the Penuelases' pickup.

The clash lasted but a few seconds and involved only the first two cars. Although some of the Mexican kids heard a window break, they had no inkling that anyone had been injured. (Steve Woods was not visible behind the lead vehicle's tinted windows.) Their sole intention had been to stand their ground, to show courage. Perhaps Monday, as a result, there would be more respect at school para la Raza. In the meantime, they all went home to get ready for their weekend jobs unaware that they were about to become Orange County's most infamous "street terrorists."

They did not know that one of the paint rollers spinning end over end, boomerang like, without its carriage had broken the passenger side window of the first car and impaled Woods's cerebrum. Later pointed out "the astronomical odds against a paint roller hitting any predetermined point associated with a rapidly accelerating car." Even the investigating sheriff conceded that it was a "fluke," and officials of

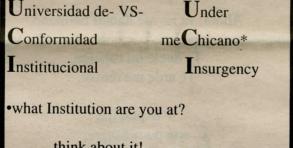

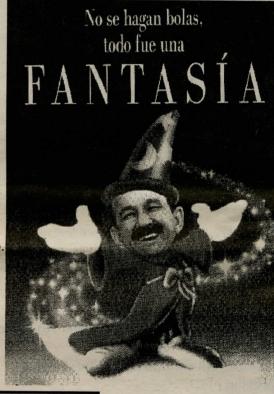

The following is the full text of the declaration delivered from an unnamed upholstery shop somewhere north of Bakersfield by the Pocho Villa Army of National Liberation.

ATTENTION GRINGO MEDIA: TODAY WE SAY
ENOUGH IS ENOUGH! ; YA BASTA, YA' BASTARDS! TO
THE CHICANO PEOPLE OF AZTLÁN, POCHAS Y
POCHOS, HARDWORKING MEXICANOS AND
HARDWORKING POLITICIANS:

We are a product of 500 years of chingazos:
Pochos throughout history have been revolting and leaders
like Zapata, Villa and Olmos emerged,
poor men with poor complexions, just like us.
Because we have been denied the most elemental acne preparations, the imperialist dictators can easily embarrass us
at any quinceañera or lowrider car show.
For this reason we are condemned to wear these ski masks,
and the crop dusting pesticides sprayed in the valley
where our headquarters are located.

Now the passage of Proposition 187 has disgraced us even further and will require drastic measures. We must slap it to the guero before he slaps it to us.

We have no land, no health care, no food, no education, no adequate cable.

Nor are we able to freely and democratically elect our political representatives, nor can we get good jobs any more as

they are being taken by Gringos and other suburbanites.

We are being tossed out of our own home by the racist forces of an

unjust government, so we have decided to make the first move.

We have been training during clandestine night maneuvers

in various barrios everywhere, including Salinas, San José, Fresno.

San Ysidro, Hazard, Denver, San Antonio, Albuquerque and Bakersfield.

We have turned once common inner-city cholos into disciplined, ferocious warriors of Pochismo, knowledgeable in the indigenous fighting arts and cultures.

Their deity, Huitzilipocho, has promised them eternal life in the deluxe housing projects in the sky if they should perish in battle. Soon we will strike— do not be fooled as we are fit and strong.

Beforehand, we refuse any effort to disgrace our just cause by our enemies who accuse us of being thieves, narcosatanicos, narcotunelistas, hygieneodentistas, lawyers or other questionable occupations.

Besides our own street soldiers, we will enlist the working people of Aztlán in our battle. Our Cybercholos have obtained lists of names of Pro-187 supporters

and voters. We urge all undocumented nannies to not only feed their youthful

charges the allegedly unhealthy Mexican cuisine, but to liberate the credit cards

(gas cards, especially) of their low-wage paying bosses. We urge all gardeners to

slash and burn their bosses' yards like so many virgin rainforests.

Therefore, according to this declaration of war, we give our PVLA military forces the following orders:

FIRST: Advance to the capitals of México and Aztlán, overcome the Mexican federal army, the Migra and crash the Republican Party. that it was a "fluke," and officials of the Orange county Crime Lab complained that it took them hours of experimentation to puncture some drywall with an identical roller.

Steve Woods was in a coma for almost a month before dying. His mother a widow who had lost two other children lashed officials with her tearful demands for revenge. In the meantime, the shared responsibility of both teenage groups for the tragedy at Calafia Beach as well as the ineffable quotient of sheer accident was transformed into a demonic allegory about a "wilding" pack of gang predators and their "innocent victims."

Of the nine Mexican youths arrested at their homes or work places on October 16, six were ultimately indicted. Horrified by Steve Woods's death, and assured by police that charges against his friends would dropped if he confessed, Arturo Villalobos admitted that he had thrown a paint roller, although he had no idea whether or not it was the one that speared Woods. Elena Penuelas confirms that Arturo was deliberately

tricked, None of his friends were released as promised. Instead, while he was entering a guilty plea to voluntary manslaughter (a possible fourteen year sentence), they were arraigned for murder.

This August the two youngest defendants, Hector and Julio (at the time of the incident, both were minors charged as adults), went on trial in Santa Ana Superior Court, Although neither was accused of throwing the lethal roller, both were quickly convicted of second degree murder, along with eight felony counts including assault, conspiracy and "street terrorism" (gang membership).

If sentenced as adults, as anticipated by their families, they face terms in state prison ranging from a statutory minimum of fifteen years to a maximum of life.

In his summation, meanwhile, the prosecutor characterized Youth for Christ activist Hector and conscientious student Julio as "wild dogs." Under terrific political pressure to set an example against "gang terror" in southern Orange County, Judge Everett Dickey discounted every molecule of the defense case. "If the defendants feared for their safety," he argued, "then all they had to do was get off the roadway." For all those involved," they were "equally responsible for Steve Woods's death," Q.E.D.

THE GHOST OF SLEEPY LAGOON.

Alice McGrath was executive secretary of the original Sleepy Lagoon Defense committee. Together with Carey McWilliams, the committee's chairman and future editor of The Nation, she worked tirelessly to build the grassroots movement that helped overturn the guilty verdicts in 1944.

your own safety." Because of their sons' notoriety, moreover, the Penuelases all nine of them were evicted by their landlord and forced to camp in a relative's living room.

The specter of ethnic cleansing shadows the entire barrio. According to Elena Penuelas, "the Anglos now stare at us like we are insects or aliens from space. They look at us like they want to eradicate us all." A wealthy homeowners' group, in fact, is crusading for the wholesale eviction of "families of gang members," while one of the city's handful of rich Hispanics demands a "clean sweep" of gang youth from city streets. Barrio resi-



"superbarrio" centered in Santa Ana but also straddling Anaheim, Orange and Garden Grove that segregates two thirds of Orange county's 600,000 plus Latinoresidents. With governor Pete Wilson sharing the photo opportunity, District Attorney-Michael Capizzi announced the arrest of 123 members and associates of the "notoriously vicious" Sixth Street gang. Their names (all Spanish surnames except for two) were prominently displayed in the Register.

In fact, the imaginatively titled Operation Roundup, with its confirming images of immigrant criminality, was partly a hoax. The Santa Ana Police something of a rogue power in a Latino majority city governed by Anglos had deliberately padded the body count with children as young as 12 and some very low level misdemeanants. In patrolling the streets near Santa Ana's Civic Center, for example, they had arrested fugitives from such warrants as an unpaid dog license, drinking in public, driving too slowly in traffic and improper mud guards.



ments the grotesquely slanted press coverage, the assumption of collective guilt, the biased hysteria around Sleepy Lagoon fed the bigotry that erupted in the so called zoot-suit riots of 1943, so today the San case has become a lightning rod for antimmigrant resentment. "The manipulation of Mrs. Woods as a symbol of middle-class vengeance is particularly disturbing."

The Mexican residents of San Clemente have seen a lot of meanness lately. Shortly after Steve Woods was mortally injured, swastikas were painted on statues at Our Lady of Fatima Catholic Church. Teenage protesters, instigated by Woods's mother and sister, staged a high school walkout and hung a provocative banner, "Take Back Our City," across I-5. A local assemblyman promised to introduce legislation to forbid the defendants' return to San Clemente High, even if acquitted.

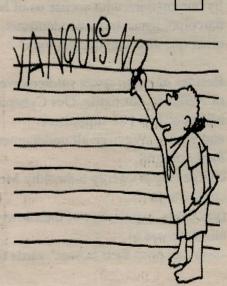
Families of the defendants received numerous death threats, and their kids like 14 year old Rolando Penuelas were warned by sheriffs to "stay off the streets for

dents, for their part, denounce the "reign of terror" brought by the escalation in I.N.S. raids and sheriffs' dragnets since last October.

Indeed, the new "brown peril" of Latino gang violence has recently supplanted the old communist conspiracy as the central obsession of Orange County conservatism. The region's leading historian, Gilbert Gonzalez, at the University of California, Irvine, contrasts the traditional stereotype of the "docile, dawn to dusk Mexicancitrus laborer" with "Anglokids' new socialization into an image of Latinos as a violent criminal class." The Santa Ana Police Officers Association, for example, recently sent out an election mailer that juxtaposed portraits of 2year old Mexican children holding rifles taller than themselves with photographs of armed teenage gangbangers. The caption: "When their baby pictures look like these, this is how they grow up."

Two weeks after Hector and Julio were convicted, moreover, the largest criminal task force in local history swept through the enormous with liberty and justice for all by Manuel Gómez continued from pg. 5

-age wasn't merely a plan to save one goose that lays golden eggs. The main section of U.S. bosses was teetering on the edge and had to cough up or face a meltdown. Besides, if U.S. capital turned its back on Mexico, the Germans and Japanese would surely step in.

U.S. "Aid:" = Unemployment and Starvation for Workers

The Mexican working class will pay in blood for this "aid." The peso devaluation already brought massive layoffs and bankruptcies in its wake. In 1993, barely half of all Mexican workers received a wage or salary. "Official" unemployment stood at twenty-five percent. These figures will skyrocket. Unemployment and service cuts will increase in the U.S. as well, because loans for debt service are essentially another form of non-productive speculation that suppresses jobs rather than creates them.

U.S. imperialism is using every angle it can to increase its direct control of the Mexican economy. In return for the package, Mexican bosses had to pledge their oil revenues as collateral, agree to reduce their feeble government services, and promise to increase anti-immigrant border patrols. In other words, the price for the bailout includes a massive dose of economic and political terror on all fronts.

The Clinton plan also sharpened the escalating contradiction between U.S. bosses and their European rivals. Clinton's unilateral seizure of \$17.8 billion in International Monetary Fund funds infuriated the Europeans, who were worried about having enough capital to deal with Mexico-like situations in their own backyard (Russia, the former German Democratic Republic, the Czech Republic, etc.). They eventually endorsed the Clinton package, but sooner or later the money well is going to run dry, and as it does, this kind of infighting among the major imperialists can only intensify.

The Clinton peso bailout may represent a short-term tactical victory for U.S. bosses. But it's bound to turn into its opposite, because potentially similar situations threaten U.S. imperialist investments all over the world, and Wall Street doesn't have enough capital to prop them all up. As a matter of fact, U.S. bosses are deep in hock themselves to Japa-

nese and German investors.

The cycle of overproduction and financial crisis is built into the profit system. War remains the big bosses' last resort for redividing the world economy in their own interests. It's no accident that the peso bailout took place a scant week before Clinton launched an all-out trade war with China's rulers and that every major imperialist power is increasing its military spending. As these rivalries intensify, growing numbers of workers will see that they can no longer live under the inhuman, murderous conditions of capitalism. Huge rebellions will become the order of the day. More than ever, the capitalist crisis opens the door for revolutionary communism and the international PLP. Donated by The Challenge

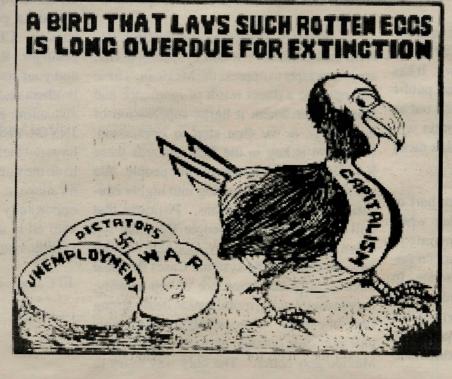

United States Federal Government is in progress. Not just because of IRCA, but people are still hiring, and paying under the table. A table that only has chairs for U.S. businesses.

Now we come to the contemporary issue of immigration, Proposition 187. This law encompasses all the previous laws. It has an effect on children, state laws, crime, public health, and privacy. This law started out as Save Our State (S.O.S.) but California will suffer for the mistake of allowing this racist law to pass.

The aforementioned laws are part of the historical cycle of scapegoating when something goes wrong with the system. Through this 187 campaign the Mexican immigrant has been portrayed as a nuisance. In reality, Mexicans have contributed enormously to the wealth and development of this country. The farming business is primarily worked by documented and undocumented

GRINGO JUSTICE: Murder of César Arce

then the guy turned around. René had barely took half a step when the guy took a gun out of a pouch that he had and just shot René. Like point blank right in the chest. With the impact of the bullet, his arms flew and his chest went back. I saw the whole thing because I had the side view.

"René just ran as far as he could to get away and he just fell right there on his face, right off the curb. I had time to just turn around and start to run, cuz' at first I didn't feel it was a real gun but then I saw René fall. The guy just shot me in the leg and I fell down. I started bleeding and my leg was going numb. The guy was walking toward me and he was pointing the gun at me and he put it to my head. He was looking at me and he told me to roll over. So I rolled over and he kept walking back and forth right there by my head.

"He was saying that it was all because of tagging. He kept saying it over and over while walking back and forth, 'This is all because of tagging.' "I was laying on the island, got up and went to step off the curb and I couldn't feel my leg and I fell back down. That guy kept walking back and forth saying stuff to himself. I was in the middle of the street and I was trying to get to the car. I was crawling away with my arms while dragging my leg. I couldn't feel it, it was all numb and bloody." David managed to get to the car and get away.

Masters has tried to put the blame on the two people he shot, but his excuses are flaky. There is nothing in his story that justifies murdering René and shooting David. In the end, a very different picture emerges of the shooter and his motivations- a portrait which reveals that William Masters was in many ways a vigilante murder waiting to happen. Interviews with the L.A. Times and Daily News portray Masters as a mean-spirited loner with a police mentality-a man who had been taught by this society to see himself as a defender of the social order and to see the basic people as a threat. In defense of his actions Masters told reporters that as a former marine he was trained to take as many as "the enemy" as he could. Masters' comments are filled with racist stereotypes of Mexican youth. He referred to René and David as "two gang-dressed people," because they were wearing baggy pants and were Latino. He told the L.A. Times, "This situation is what everybody lives in fear of a couple of skin head Mexicans robbing you at 1 a.m. with a screwdriver." After gunning down René in cold blood, he had the arrogance to blame it on René's mother, saying, "She murdered her son by being an irresponsible, uncaring parent. Nobody who has been raised by responsible, caring adults

goes around making armed robberies."

The murder of Arce has witnessed new contortions by the system to target graffiti writers. In an attempt to justify Masters' actions, the L.A. Times, citing unnamed "law enforcement experts, sociologist and community activist," wrote, "Like racial slurs, urban graffiti provokes deep psychic turmoil that can push usually placid people to verbal excess and even violence." This psychobabble is typical of how the system tries to say that incidents like the murder of Arce are the response of ordinary people driven to violence by the unruly youth. But the reality is that a brutal campaign has been orchestrated by the system against the graffiti writer-including whipping up an atmosphere to justify vigilante attacks.

Since the 1992 L.A. Rebellion, the LAPD has been moving forward with the police state program known as "community -based policing." It involves getting people in various communities to work with the police against the rebellious youth. "Anti-graffiti" programs have been a centerpiece of this program. In Van Nuys, for example, the LAPD targeted" prostitution, panhandling, and graffiti." Police-trained volunteers have staked out walls with video cameras. There are hot lines for callers to report graffiti writers and \$500 rewards are offered to callers if their tip leads to a conviction.

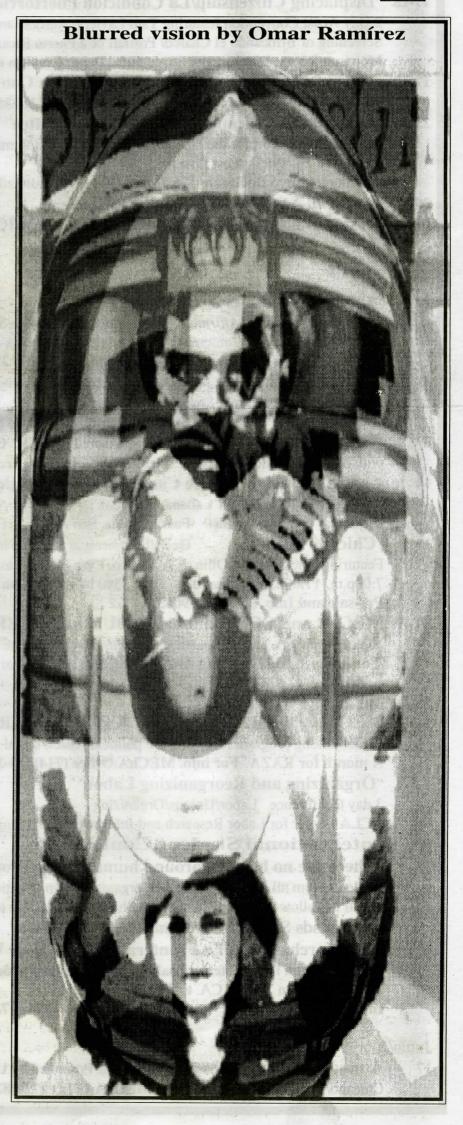
Comparing graffiti to racial slurs is truly perverted. There is a strong trend against racism in the graffiti movement, as the L.A. Times is well aware of. The graffiti writer themselves are largely Black and Latino youth, and white youth often become writers because they see it as a way to unite with other people of different races and ethnicities. They express themselves in practically the only creative outlet they have-putting their mark, from a simple tag of their name to a complex piece with a powerful message, on a society which denies their culture and their future. The authorities always mention graffiti and writers in little phrases like, "graffiti, prostitution and drug dealing", or "taggers, gang members and muggers." They talk about "graffiti-plagued Los Angeles."

The writers themselves look at it as a positive thing. Some say it's an alternative to gangs, and a way for youth with differences to come together. If they have differences, they "battle" with spray cans to see who can piece the best. Mike, René's friend, talked about how serious they are about their art. "We take the way that we write, it's a profession. René drew butterflies, he drew all kinds of beautiful things- you wouldn't imagine. He had so many ways of writing and drawing. He expressed himself that way." A friend added, "It's a passion to draw, to write."

Hungry for justice, René's friends and neighbors have gotten active in many ways. They called a press conference on the spot where René was killed, but the press didn't show up. They raised money to help his family. One of his old friends said he was surprised at how much some of the youth were giving. His neighbor Noemí told the *RW*, "We're not going to stop until it gets to where it has to get. **Everybody is born with a gift, and that's the gift of life.** René was very happy with who he was. Everybody loved him."

The writers in René's crews and others are planning murals in his memory.
