Gentlemen:

In connection with Contract No. OHA-120, dated July 7, 1976, for general construction of Alterations and Additions to the Existing Housing Development, Project No. CAL 31-1, 31-2, 31-3, Oxnard, California, the following change is ordered in accordance with Paragraph 8 of the General Conditions:

CAL 31-3 ONLY: Due to deterioration of existing conduit to the degree that it does not provide an adequate ground, add a ground wire to all sub-feed panels.

Add \$3,605.00 plus \$432.60 overhead and profit..... \$4,037.60

Subject to conditions hereinafter set forth, and equitable adjustment of the contract price and the contract time is established as follows:

THE CONTRACT PRICE IS INCREASED FOUR THOUSAND, THIRTY-SEVEN AND 60/100 DOLLARS (\$4,037.60) AND THE CONTRACT TIME IS NOT CHANGED.

The above amount is subdivided as follows:


Dear Bill:

In response to the request for an estimate for an electrical change at the Oxnard Housing Project, Oxnard, we have determined that the cost will be \$3,605.00.
