A. Accomplishments & Activities

- a. Administration Issues

- c. Tasks Assigned by Board of Supervisors
 - i. Fiscal & Administrative Review by Ventura County CEO: The Chair received notification by email (8/21/2012) from the CEO staff, Linda Catherine Le, MPPA, Program Management Analyst. She stated the following, "In preparation for the Study Session with the Board of Supervisors, I would like to meet with you to clarify issues/concerns and outline the Study Session. To further prevent any Brown Act violations, I would like to limit the number of committee members attending this meeting with you and me as it would constitute a Special Meeting. Therefore, please limit to only 2 members of the Executive Committee." At that time the Chair will seek to have included in the Study Session operating policies and budget for VCCW, and procedures to establish website linkage and bylaw changes.
