

Contaminated Media:

Groundwater Surface Water Air Soil and Sludges Environmentally Sensitive Area

Most waste remains on-site, including an estimated 700,000 cubic yards in the waste management area. Elevated levels of aluminum, barium, beryllium, cadmium, chromium, copper, lead, magnesium, manganese, nickel, thorium, and zinc are present in the wastes and on-site soils. Waste material has moved into both underlying groundwater and sediments in the Oxnard Industrial Drain.
