DEAR MRS. TOLMACH:

YOUR LETTER SUGGESTING A JOINT MEETING OF OUR TWO HOSPITAL ADVISORY BOARDS OF TRUSTEES WAS DISCUSSED AT OUR LAST MEETING HELD ON FEBRUARY 8. DR. LOWRY, WHO HAD BEEN SCHEDULED TO ATTEND THE MEETING ON FEBRUARY 8, WAS UNABLE TO BE WITH US. HOWEVER, HE HAS INDICATED THAT UNLESS SOMETHING UNFORESEEN HAPPENS HE PLANS TO BE WITH US FOR OUR NEXT MEETING SCHEDULED FOR THURSDAY, MARCH 28, 1968.

OUR BOARD WISHES TO EXTEND TO YOUR BOARD OF TRUSTEES OF CAMARILLO STATE HOSPITAL A CORDIAL INVITATION TO JOIN US AT PORTERVILLE ON MARCH 28, THUS GIVING DR. LOWRY AN OPPORTUNITY TO TALK TO BOTH GROUPS AT THE SAME TIME. SHOULD DR. LOWRY NOT BE ABLE TO MEET WITH US, WE HAVE SCHEDULED A BACKUP PROGRAM ON VOCATIONAL REHABILITATION, OR IF YOU HAVE SOME OTHER SPECIAL INTEREST PERHAPS THIS COULD BE WORKED OUT. OUR MEETINGS USUALLY CONVENE AT 1:30 P.M. IN THE HOSPITAL CONFERENCE ROOM, WITH OUR BUSINESS MEETING FIRST, FOLLOWED AT APPROXIMATELY 2:30 BY THE PROGRAM TO BE PRESENTED. THE MATTER OF AGENDA CAN BE WORKED OUT, I AM SURE, TO INCLUDE ANY SPECIFIC ITEMS YOU MIGHT HAVE TO SUGGEST OF MUTUAL INTEREST.

I WOULD BE PLEASED TO HEAR FROM YOU WHETHER THIS DATE OF MARCH 28 IS AGREEABLE FOR YOUR MEMBERS OR WHETHER YOU WOULD RATHER MEET WITH US AT SOME OTHER TIME.
