POOL RENOVATION GETS UNDERWAY

On January 31, 2000 the Leisure Village Board of Directors approved a contract with California Commercial-Pools for renovation of the pool at the Recreation Center. The contract price is \$160,000

with a completion date set for May 15, 2000. The project includes making a slight modification to the bottom of the pool to accommodate more of those who use the pool for exercise without sacrificing any of

the lanes used by lap swimmers. The water circulating system is to be completely replaced to bring the pool up to current construction and sanitation codes. The pool heater, which was installed in November 1994, will be retained.


Honduras has a rich history since it was "discovered" in 1502 by Columbus on his last journey. Dorothy will tell us about life and customs

The Ventura County Local Unit of the National Association of Social Workers recognized Lillian Hawthorne with its Lifetime

Achievement Award during recent ceremonies at their Third Annual celebration and awards luncheon.

Lillian's social work spans more than thirty years, starting as a caseworker for the LA Dept. of Public Social Services. Prior to this assignment she spent some twenty years as a secondary English teacher, both on the East Coast and in California.

Knowing that social work was to be her ca-

reer, she attended USC, gaining an MSW (Masters in Social Work).

Later, joining the USC School of Social Work, she advanced to being Assistant Dean of that School. Her primary focus was field education, with the goal of protecting and enhancing the educational aspect of the student's field experience.

In her last year, prior to retirement, USC's field education program was lauded as one of the out-

standing in the nation.

Once retired, she continued to be involved with social work. With the help of USC's School of Social Work, she was able to revive and reorganize the Ventura County Chapter of the National Association of Social Workers.

For the next three years she coordinated a joint off-campus program between the USC School of SW and the Ventura County Dept. of Personnel.

These days Lillian is involved with the issues of aging for women. She writes articles for senior magazines relating to relationship changes in aging and is sought-after speaker before women's groups throughout the county and recently published a book on these subjects titled, "Finishing Touches."

Lillian has been married to Dr. Edward Hawthorne for 53 years.

KUDOS FOR LV BOARD OF DIRECTORS

The Leisure Village Board of Directors faced a situation of fundamental agreement amending the CC&R's to approve existing exterior improvements. However, residents expressed intense opposition to changing the wording in Section 6.02. The Board listened to, and respected their constituents. After lengthy deliberations, they unanimously presented villagers with a document that will clarify rules pertaining to exterior changes.

The attitude of Leisure Village residents changed from one of feeling ignored to one of feeling respected. They responded by voting nearly unanimously for the CC&R change. By their willingness to compromise, the Board showed leadership in this situation.

The construction of the slump stone walls and other exterior improvements can begin again, and the beautification of Leisure Village can proceed. By the middle of May the swimming pool will be completely refurbished. The past and present boards, working in conjunction with the residents, are ensuring that Leisure Village will continue to be a desirable place in which to live.

information provided by Leisure Village Administration and the latest Common Sense publication regarding my lawsuit against LVA and Common Sense.

I never wanted to sue LVA but was advised by my lawyer to sue Common Sense, its editor, and LVA. Then when Knopfler & Robertson, the attorneys representing LVA, contacted my attorney requesting that I sign a Mutual Release and thus drop the lawsuit against LVA, I agreed to do so. It was explained to me that if I dropped the lawsuit against LVA, I would not be held responsible for any attorney's fees or costs incurred by LVA up to this point, and they would not have to pay fees and costs to my attorney if I won the lawsuit.

I want to clarify the fact that this Mutual Release was initiated by LVA's attorney and NOT BY MY WIFE NOR MYSELF. In fact, when my wife and I were sitting in my attorney's office, he received a call from Knopfler & Robertson about them preparing the Mutual Release for my signature, which they did do. The only defendants then remaining were Common Sense and its editor.

I learned of the trial of this case at 5:00 one night by my attorney who wanted me and my wife to appear the next morning for trial. The only way we would agree to show up for the trial was on the provision that if the case would be lost, my lawyer would pay the prevailing attorney's fees and costs. Health Care Seminar at Leisure Village

Gallegly's Unexpected Visit

A very informative seminar on health care took place in the AR on March 2. Unfortunately, this event received very limited publicity, partly because it was arranged with little advance notice. This was unfortunate because of the wealth of data presented, and because guests and speakers included Congressman Elton Gallegly (last minute decision), Kathy Long, Chair of Ventura County Board of Supervisors whose participation was confirmed only a day before, and Mike Morgan, Camarillo Vice-Mayor.

Congressman Gallegly reviewed the current activities in Congress relating to health care that are of importance to seniors, including "patients bill of

rights" and relief in cost of prescription drugs. Supervisor Long reviewed some of the activities in these areas at the County level and related some of the options available to seniors.

The scheduled panelists and presenters were Betty Berry, Senior Advocate with Conejo Valley Concerns; Darlene Benz, Senior Services Coordinator, Camarillo Health Care District; and Dr. Jeffrey Allen, Camarillo geriatrician.

The speakers reviewed the practices and fee requirements of the five local HMOs: Kaiser Permanente, PacifiCare, Health Net, Blue Cross and Blue Shield. They commented on the departure of other HMOs from Ventura County (e.g. Secure Horizons). They discussed some of the reasons for the unequal fee structures among various localities, especially in the greater Los Angeles area, and they

also pointed out that government's reimbursement to the HMOs differs among localities.

The speakers explained the differences between the option of belonging to an HMO vs. having individual Medicare coverage, with or without supplemental private insurance. They pointed out the advantages and disadvantages of each choice. They also discussed the opportunities for switching among these options, as well as switching among HMOs or among supplemental insurance providers.

Other important issues relating to health care for seniors were discussed, especially in response to the many questions from the very enthusiastic audience. It was explained that, as a result of recent Federal law, Medicare patients and HMO members without coverage for drugs now have the opportunity to purchase prescription drugs at the gen-
