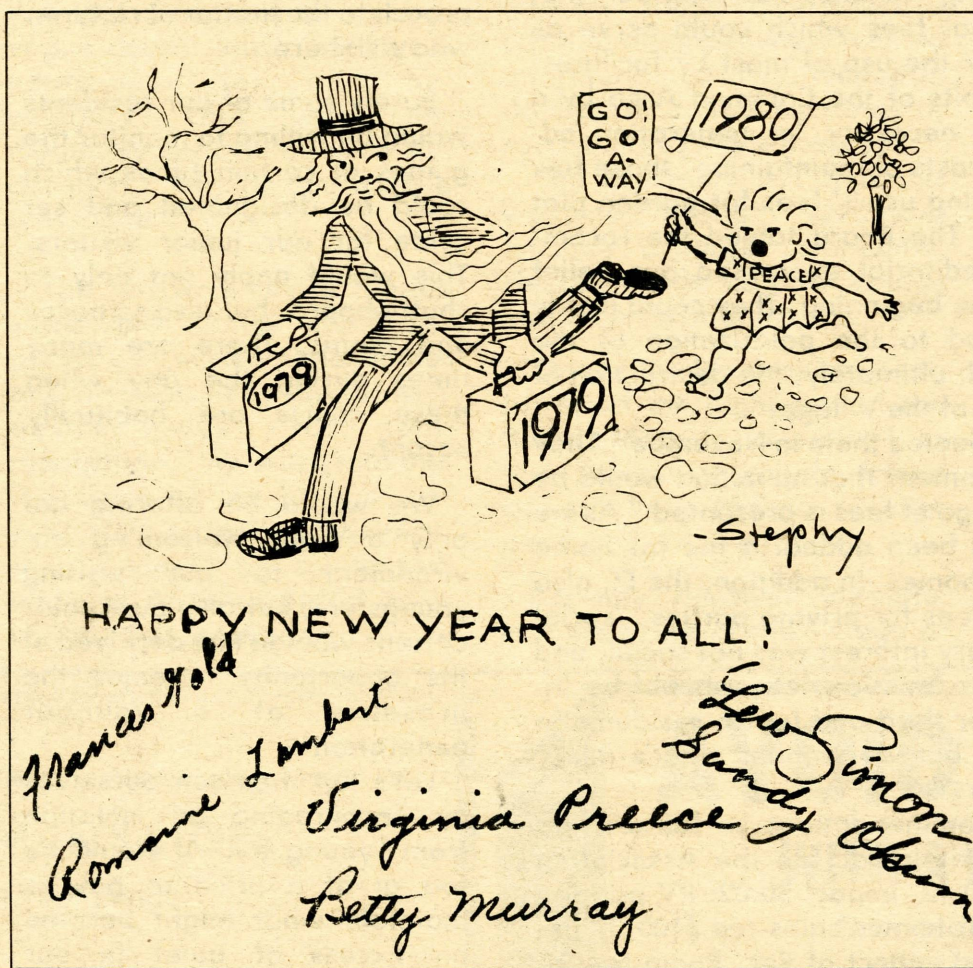
Finance Committee urges L.V. users fees

The Finance Committee, at the Dec. 3 Board of Directors meetings, presented more recommendations for fees for LV residents. They had previously recommended evicting those who held garden plots, replacing them with others chosen by a lottery (at a dollar a chance) and charging the winners a 42 cent monthly fee. The other recommendation was for \$3.50 to \$5 monthly fee for RV parking spaces. Both fees were set to cover the maintenance costs of these facilities.

In addition, fees of \$100 for a resident selling his home, or \$5 for leasing it were recommended. An increase of fees for use of Recreation building rooms for private parties, social events of clubs not primarily organized for "social," events which retain admission fees was also suggested.

At their November meeting, Bob Clayton, Chairman of the sub-committee with the task of studying new revenue possibilities, presented his final report: increases in the fees for the third and fourth resident in one home were not recommended. When this report was unanimously approved by the full committee, Chairman Art J. Wilson stated that the report completed the studies for revenue possibilities requested by the Board of Directors. The committee's rationale for these fees was that all residents were paying for facilities and services that only relatively few Villagers enjoyed.



letter, by former director Dick Van Horn, objected to the philosophy of charging fees for use of LV facilities. It challenged the committee's implied belief that the Board could legally assess such fees. The letter also indicated that many facilities are dedicated to specific activities, such as swimming, golf, etc. Those residents not engaging in such activities are prohibited from using those areas although all pay for their maintenance.

Wilson asked Clayton to prepare a response to the letter and present it at the next meeting, Dec. 20. ILV requested a copy of the response to print in this issue, but Wilson preferred not to provide it.

Following the formal meeting, several residents spoke from the floor in opposition to the fees.

Club insurance discussed

At a meeting held Dec. 4, 1979, Tom O'Brien, Chairman of the LV Board of Directors, requested that our insurance broker obtain a rate quotation on the following:

1. A Blanket Coverage Rider, to cover clubs, added to our master policy; and
2. A new policy to cover an Association of L.V. Clubs.

The general opinion of most people in the village who are knowledgeable about insurance, or are attorneys, is that the coverage is really unnecessary. Our L.V. master policy or our home liability policy would suffice.

What Next?

Last April, the hard-driving Finance Committee (FC) proposed assessment of special fees which could serve as precedent for charging fees for the use of most LV facilities. Claiming "unfair monopoly" of bits of the Common Area by a handful of residents, and the necessity "of generating additional revenues to cover the costs of maintaining" those few bits, the FC recommended levying users' fees for garden plot users and RV parking spaces. The Board tabled the recommendation. ILV's subsequent editorial expressed our belief that these two fees were but the beginning. They could justify more and more fees and lead to the polarization of the residents, endless haggling and, ultimately, the destruction of the friendly give-and-take spirit of the Village.

Undaunted the committee repeated them in November. They were tabled again with the comment that no action would be taken "until the complete package of fees is presented." As we had predicted, a third fee had been added: a fee for home owners selling or leasing their homes. In addition, the FC also recommended that Rec. Room fees for private parties, "social events" for groups whose primary interest was not social, and events charging and retaining admission fees, should be increased. No increase of fees for third and fourth residents in one home was recommended, but we wonder what's next? Golf? Swimming? Parking meters?

To inform Villagers, the recommendations so far are the following monthly fees and their impact on the Association monthly fee: garden plot fee \$0.42, impact \$0.02; RV parking fee \$3.50 to \$5.00, impact \$0.44; homes sales fee \$100, home lease fee \$50, impact \$0.50. The impact of Rec. Room fee increases was not stated.

The FC claims these fees are needed to hold down the Assoc. fee, yet, by charging only some of the smallest groups, using some of the least costly facilities, they produce only a trivial 96 cent impact. They failed to deduct the additional costs of recording, billing and accounting required.

The FC also proclaims these fees in the name of "fairness." The unfairness which they did identify was the lack of garden plots for those who were promised them by Leisure Tech. (The Board has long tried to get this remedied.) The FC proposed to perpetuate this unfairness by ousting the present gardeners "forthwith," choosing replacement by lot and charging an inconsequential fee. The fee in no way serves those who still desire garden plots.

The FC also objects to the long-term possessory interest taken by RV owners, and to the lock on the gate to the area. As a matter of fact, there are ample spaces for any residents who may need them. It is Security who demands that it be locked. Once again the FC does nothing to unlock the gate which seems to offend them. (Short-term possessory interest is pervasive in the Village, from the pool tables, bocce, tennis, etc. to parking at the Rec. Bldg.)

The FC seems eager to fine a few users rather than rectify the "wrongs" they claim many non-users suffer. This may stem from a narrow view of "fairness" or "lack of partiality." Beyond the provision of facilities ample to accomodate all who would use them, there are only two methods of being "fair:" (1) charge each user the costs of facilities to the extent he uses

L.V. Board Meeting Highlights

A meeting of the L.V.A. Board of Directors was held Dec. 3, 1979 in the Assembly Room with Tom O'Brien, President, presiding. One member was absent. The committees reported as follows:

Educ. & Rec. Comm: Recommended that the Current Issues Forum and the World Travel Group be recognized as clubs and that permission be given to meet once a week in the A.R.

Oxnard College classes: 379 enrolled with 24 from outside L.V. Attendance averages 330. Spring semester is being planned.

Finance Comm: Sub-committee has reviewed an increase in monthly-fees for third and fourth members of a household, but no recommendation for an increase has been made at this time. It has been recommended that fees be levied for events when admission is charged, for socials not directly related to clubs, and for private parties.

(Set-up fees for private parties are now being charged but an increase is recommended.

Bldg. & Grnds: has formed a new sub-committee for landscape design review which will be chaired by Nikki Goodman.

Information to New Villagers: Committee has called on 27 new residents and is also visiting new renters. Fifty guests attended the November "Meet Your Neighbor" social.

Architectural: Twenty-three new applications were received, 18 approvals and 32 previous applications not acted

upon. Contacting homeowners continues to be a problem because it is difficult to find residents at home. Mr. Rasmussen stated that there are about 100 jobs upon which no work has been done. His committee would appreciate having homeowners call the

One of the features has been to report the highlights of the Board of Directors Meetings, so that those who cannot attend can still keep abreast of what our Board is doing for us.

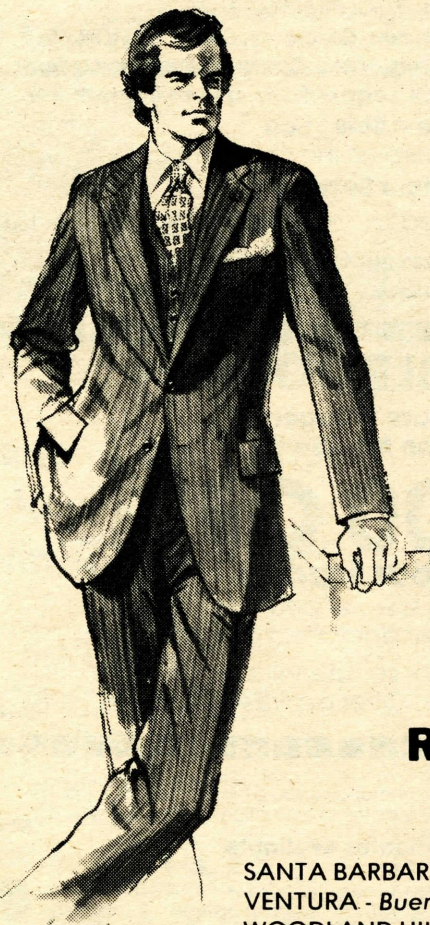
Recently, however, we note that the Voice of the Village is

A courageous resolution for a better life

Many people dabble with New Year's resolutions, the easy ones: to be more friendly, to pay bills on time, to answer letters promptly, to criticize less, to do good deeds, or to be more generous. Some tackle more difficult resolves: to really obey the Ten Commandments, to lose weight, to stop smoking, to exercise regularly, to stop drinking, gambling or to economize.

There is a lady in L.V. who has grappled with a problem which was starting to interfere with her health and capacity to function in the creative ways that she desired. She wrote a letter to friends in the Rhythmettes and Tap Dance Class to tell them of the action she had taken. She gave us permission to use her letter, and her name, on the chance that it would encourage someone else to take a determined step away from

dependence on alcohol. Her New Year will begin FREE. Her most important resolution ever is to herself, but as a consequence, her family and friends will also benefit from her improved health and energy.

Here is her letter:

"Dear Friends:

"Perhaps you have heard where I am, but if not, I have joined the Raleigh Hills Hospital Group for rehabilitation. A couple days ago, I could not have disclosed this situation because I was ashamed. Today I look at it realistically, having been assured that alcoholism is a disease affecting perhaps 10 million or more people in the U.S. Experts agree that a combination of emotional, physical, and possibly genetic factors are involved.

"America is a highly social country where almost all activities involve drinking. I enjoyed these social functions,

too, and could control them. In May 1972, however, when I was nearly totally incapacitated with vertigo, a problem about which not too much is known, I soon found refuge in more alcohol to minimize my discomfort. Five years and many medications, tests, and allergy injections brought no improvements and I was told to live and cope with it until a remedy could be found.

"I've lived with it but at times I couldn't cope. Retirement brought new changes and stresses into our lives. So more and more, I masked the health problem by compounding it with a more dangerous one.

"It has taken me over a year to bring myself to this course of action, but I went in on my own volition, determined to have a healthier and more productive life. I hope I will have the strength and fortitude to persevere.

"Alcoholism is a progressive disease and is not always accepted as such by society. However, I told myself that if the wife of a president, as well as other prominent and highly intelligent people, could admit to being ill, then I, too, could hold up my head.

"Seeing and talking with other patients here has con-

On entering the Emergency Room, the first thing you notice is "youth," accompanied by

Villagers are urged to attend this important discussion.

Stated succinctly, the issue is: "Will Leisure Village become a jet air corridor to the Camarillo airport?"

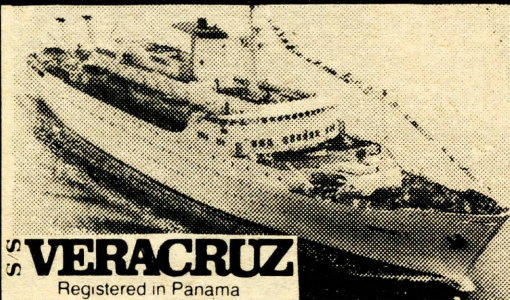

And let thee, Love, have the final say?

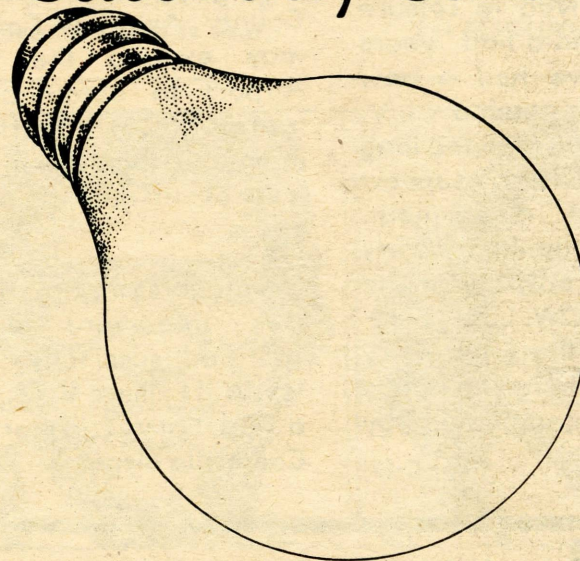
Now that is a gift that should please thee, dear,

Profile: Diana Dugall

Not too many people in L.V. know about the quiet, efficient lady who works in the back room of the Association Office. She is surrounded by ledgers, adding machine, files and figures. Diana Dugall (say: Doo'gull) is Head Bookkeeper of Leisure Village Association, a very important member of the team who makes our business function smoothly.

Let's follow the check we wrote for monthly Association dues. We deposited it in the compartment marked for our village; checks are sorted by house number, then entered on the prepared ledger sheet for that village. The amounts are totalled and checked against the entries, then deposited in the bank. Strictly bookkeeping procedure! Ms. Dugall records money received, pays bills, makes tax and insurance payments, writes paychecks and keeps payroll records, and

prepares monthly financial statements. An auditor does the yearly report, which residents can see.

Diana has been keeping books since she was seventeen, back in Michigan. The family moved to San Diego in 1970, where she worked for a number of types of businesses, C.P.A.'s, and even conducted her own bookkeeping service for small businesses a couple of years. She has been at L.V. since September, 1978.

Besides interest in financial affairs, Diana has reared three children. Oldest son Robin, age 25, is in his final year at the Lutheran Seminary in San Francisco. He graduated from California Lutheran College in the same class as Larry Pfeifer, our new Recreation Manager. Both daughters also attended CLC; Dawn is already an assistant comptroller, following her mother's interest in bookkeeping. Youngest daughter, Karen is a Junior, with a major in music.

With one full-time and one half-time assistant, Diana says that they are working to capacity to complete the work of the Village. When the 300 to 500 more homes are added,

more help will be needed. They are using the "Peg Board" System which is the fastest manual system available, for Accounts Payable and for Payroll Records. She hopes to get a similar system for Villagers' accounts.

When asked if a computer would be helpful, Diana said that the amount of work does not warrant a computer now. It would be expensive to initiate, and would take three or four people to operate, making it illogical to consider. She did suggest that having a Purchasing Agent for the Village might be wise, especially as we get larger.

If playing with columns of numbers can make one happy, Diana has the spot! She is constantly learning, she asserts, and hopes eventually to be a Comptroller, doing cost analysis and auditing. Leisure Village has attracted a capable and friendly group of people to staff the Administrator's office. Thank goodness! Some folks have trouble even balancing a checkbook.

Simon discusses metric system

Misinformation is rampant concerning the introduction of the metric system in our country, according to Lewis B. Simon, when he addressed the Current Issues Forum on Nov. 13. Simon is an MIT graduate Engineer and a resident of Leisure Village. A great many people believe that Congress has passed a law mandating the introduction of the metric system in this country. Actually, it has only called for a study. A second misunderstanding arises from the belief that the standard metric system is the one that is being introduced. In fact, the system that has been recommended is SI (System International) which was adopted by the General Conference of Weights and Measures in Paris in 1960 to correct the inadequacies of the metric system. There are considerable differences between the two. As one example, the metric system is a gravitational system based on the gram as the unit of weight

whereas SI uses gram as a unit of mass.

Simon is very much opposed to the adoption of SI, claiming that it would cause tremendous disruption and expense. For example, a crash program would have to be adopted to cover changes in 20,000 standards and specifications in all fields of industry. Some members of the audience disagreed with Simon's views and advocated a changeover to the standard metric system.

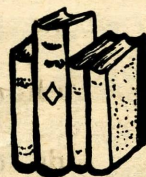

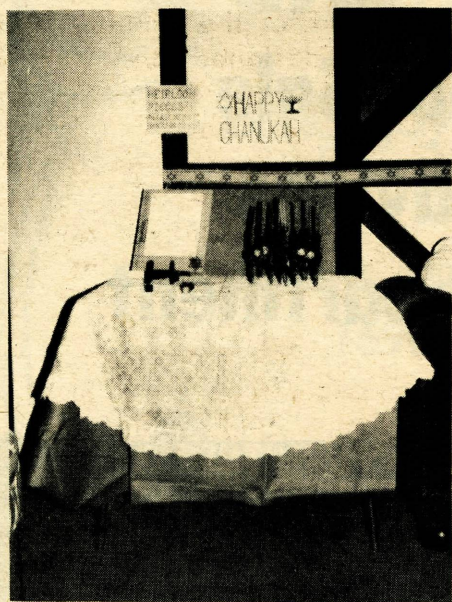


LV MENS GOLF ASSOCIATION

The members of the Men's Golf Association wish to express to all Leisure Village residents and their families their best wishes for happiness during the Holiday season and during the New Year.

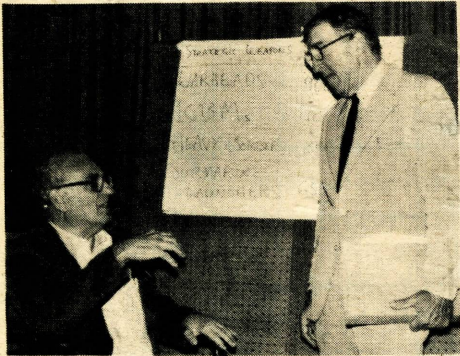


The Chanukah table decorated with treasured ceremonial objects stands in the foyer in recognition of the Eight Day Jewish Festival of Lights in December.

Current Issues

According to Lu Haas, field representative for Sen. Alan Cranston, who addressed the Current Issues Forum in the Assembly Rooms on Dec. 7, sixty U.S. Senators now favor ratification of SALT II -- the Strategic Arms Limitation Treaty -- 30 are opposed and 10 undecided.

About 100 Leisure Villagers heard Mr. Haas analyze the pros and cons of the arms limitation agreement, entered into by the United States and the Soviet Union after years of negotiation extending through the administration of three Presidents: Nixon, Ford and Carter.

Originally scheduled for December, the Senate ratification debate was postponed for at least a month, because of the interposition of other issues: the energy crisis, the problem of Russian soldiers in Cuba, and the taking of American hostages in Iran.

With the United States and the Soviet Union together having the equivalent of 600,000 Hiroshima-type nuclear bombs, Haas maintained that both sides, pursuing a similar strategy -- Mutual Assured Destruction (whose acronym is MAD) -- "have too many weapons."

SALT "is not a dramatic change," continued Haas, but it places a cap on the arms race, it monitors the arms of the USSR, it is a continuing process of negotiation, it strengthens our NATO allies and enhances America's world leadership role, particularly at a time when nuclear weapons are proliferating.

A responsive audience peppered the speaker with many questions, indicating serious concern with the complicated issues surrounding the nation's arms program and our relationship with the Soviet Union.

At the beginning of the meeting a brief memorial tribute was paid to those who died at Pearl Harbor and in the battles of World War II. "Taps" was sounded on the organ by Betty Murray, of Village 4.

The Current Issues Forum has begun a \$2 "Charter Membership" drive under the direction of a committee consisting of Lilly White, Dolly Riskin, Charlotte Delson, Midred Prella, and Mollie Silversher, club treasurer.

Forum meetings are open to all Villagers.

There are two Vegas jaunts, one in December and the other in January. We never have

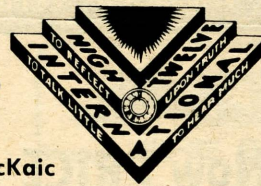
difficulty filling up the bus for these trips.

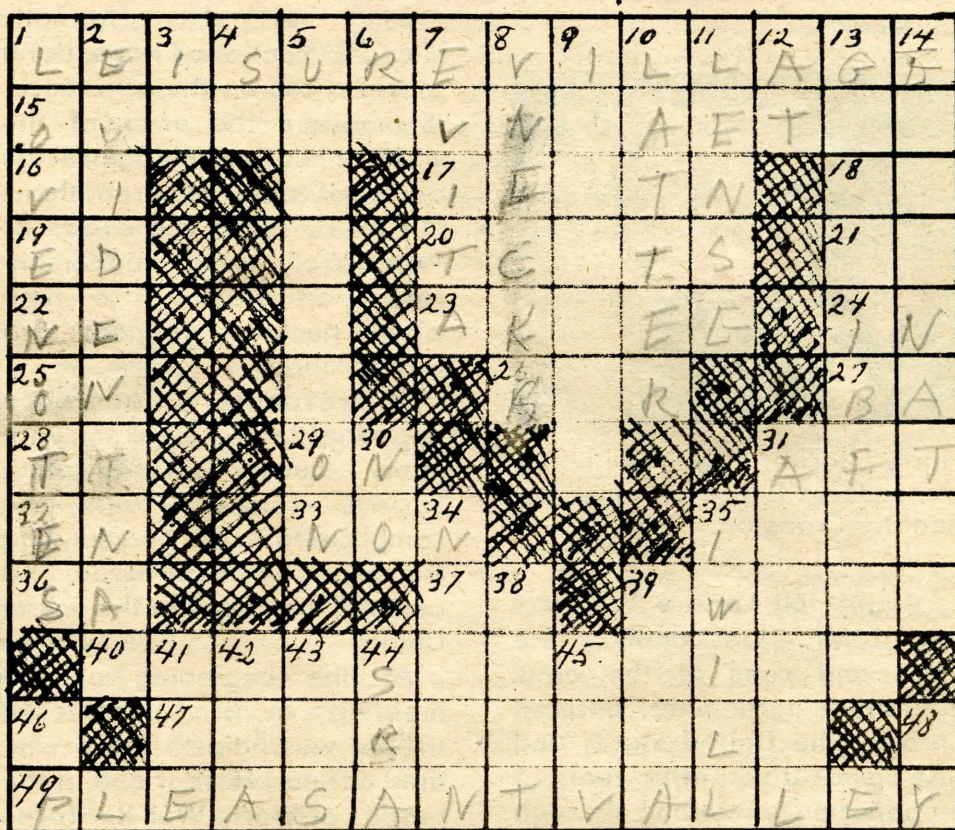

them, or (2) assess each owner a prorated portion of all the costs of all the facilities. That is the methods now mandated by the Declaration of Covenants, Conditions & Regulations (CC&R) which is part of our deeds.

The FC mixture of the two methods is unfair and discriminatory. The FC wants some users to pay the costs of their facilities. The CC&R Article IV 4.2 states that all facility costs be assessed to all Owners. The FC wants to discriminate among owners, making only minority groups fund the facilities they don't use. Article XII 11.6 states that no owner may avoid his obligations through non-use of the Common Area. In brief, the FC proposes rules that are in violation of the CC&R. Article II 3.1 states that in such a case, the provisions of the Declaration shall prevail.

The FC claims to have an oral legal opinion to the contrary. We reject that opinion and strongly assert that, regardless of any legal technicalities, the very attraction and pleasure of life at Leisure Village is due in no small part to that very principle of sharing set forth in the CC&R. It insures that all residents shall share all costs and each resident will feel free to enjoy any, all or none of the facilities without payments. The Association fee, minimized by being shared by all, covers all.

Therefore, we believe the Board of Directors should renew their efforts to get more garden plots, and direct the FC to forthwith withdraw their disruptive recommendations and return to their budgetary work which they have performed so ably in the past.

sympathy, concern and caution. Next came the "on call" specialists, "youth" again, and more caution. The next four days were spent talking, accusing and heckling all the young doctors about being too cautious with my wife, saying "Get her into surgery now."

We dared to disagree with them, however, communication and frank dialog with them continued throughout with no anger nor dissatisfaction with one another. In other words, we could "talk" with them. I doubt that older men would have taken it. We are indeed fortunate to have such fine young understanding doctors.

One other thing about these young doctors is that in talking to them I got the message that they are not averse to discussing their fees if you feel you cannot afford them. They would prefer you to discuss fees with them, rather than your neighbors.

The room service at P.V.

Hospital is excellent. The nurses, L.V.N's and aides are fast, cheerful and very helpful. The volunteers (and L.V. is well represented in that department) are there with your mail, newspaper and refreshments, for both you and your visitors. Visitors are welcome most of the day, and are not "ordered out" at night as in most hospitals.

Norman Gruber, the Administrator, in his kind, quiet voice, visits all new patients. Cris, the patients "good will" ambassador and discharge coordinator, is a gem who makes you feel better just to talk with her.

Noticeable is the lack of "paging;" calling doctors, etc., over the intercom. They all wear "beepers." The phones do not ring; they beep. The place is clean, neat, quiet and odorless. Everyone is in a single air-conditioned room near the nurse's station. The colors used in decorating are bright and cheerful.

And last, but not least, the food -- ah, the food, the thing most people hate in a hospital, is GOOD. The food served in the room is the same as that

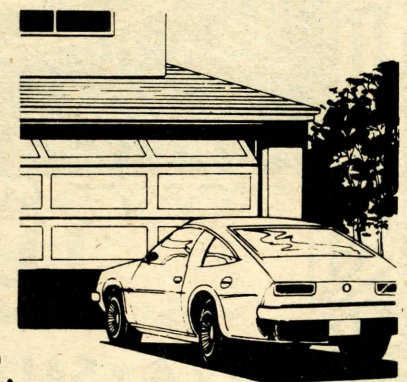

Impressions

All in all, there are more pluses than minuses. That's the way the bottom line reads in a summary of "Impressions on Moving from Rochester, N.Y., to Leisure Village." That's what I was asked to write for Inside Leisure Village -- thoughts while making the transition.

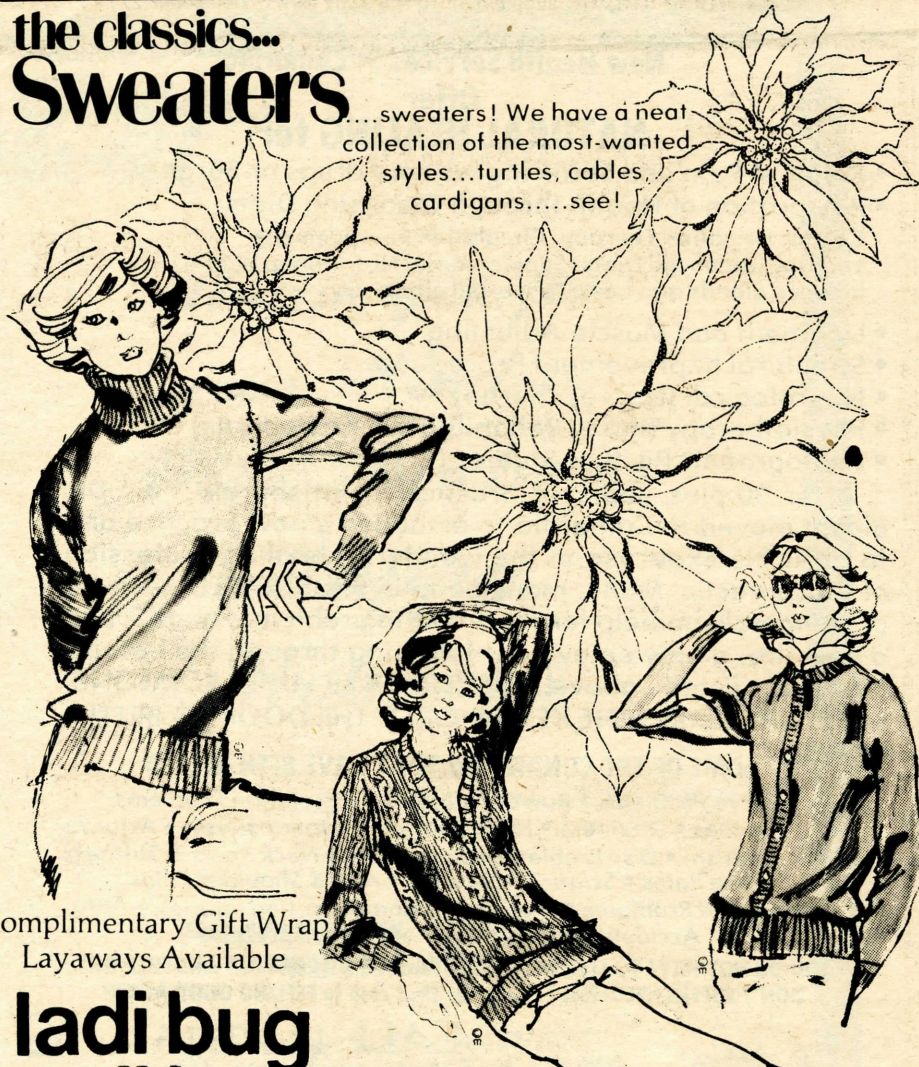

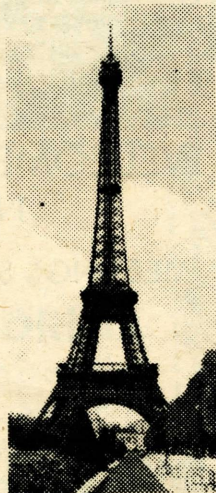

pays any attention to through street stop signs -- a down shift to about 20 mph is more normal procedure -- and I have yet to encounter a driver behind me who doesn't speed up when I indicate I want to change lanes. California is the only place where I can be travelling at five to ten miles per hour over the speed limit and have drivers whiz past and glare at me for obstructing traffic.

Then there are the prosaic little things. How do you go about finding a doctor or dentist with whom you can feel comfortable? Which supermarket has the best meat bargains? In reading a new daily paper, who are the good guys and which the baddies? What restaurants are good for the occasional evening out?

So there is a series of trade-offs. Any system of pluses and minuses has to weigh leaving two sons in New York against being near two daughters in California.

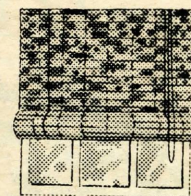
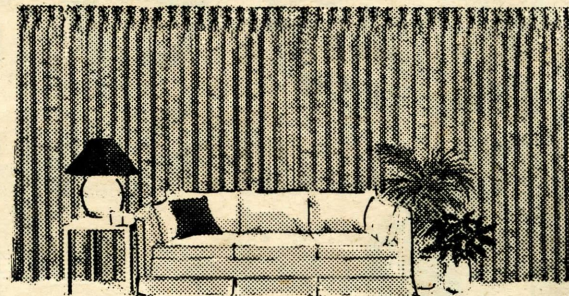

At a meeting of the Current Issues Forum on Nov. 27, Carl Brauer, former member of the L.V. Board of Directors, reported on his service as a member of the 1978-79 Ventura County Grand Jury.

The grand jury is established under state law and the power to return an indictment, to bring accusations against officials for corrupt misconduct and to investigate various aspects of county government.

Mr. Brauer described the work of the grand jury as a full time, demanding job starting with a 60 day orientation course. There are ten committees including jails, county administration, audit and finance and juvenile justice. Each juror serves on several committees. At the end of the year the Grand Jury published a 150 page report of its findings and recommendations for improvements in Ventura County government.

There were many questions from the audience after Mr. Brauer's talk.

Presentation: Virginia Schafer on behalf of the Rhythmettes presented a check for \$450 to the Association to be used at the Board's discretion.

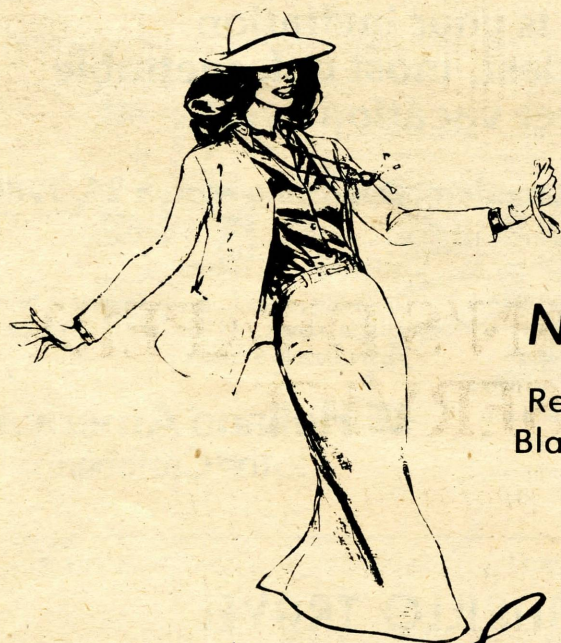
