ILV Urges Board To Table Resolution

The Insurance deductible debate has been rekindled in the Village since the September 8th Board of Directors Meeting when the first reading of a new Board resolution was introduced.

Inside Leisure Village and many homeowners are tired of the arguing, but we cannot back away from the issue until it is resolved intelligently.

ILV would like to suggest the following:

1. The Board should TABLE the resolution on the responsibility for the insurance deductible.

2. The Board should draft a new amendment to the CC&Rs to propose a REDUCTION in the percentage of votes needed to amend.

(As has been stated by those who should know, most Condominiums and Planned Unit Developments such as L.V. originally specified 75% of the Homeowners to amend. In practice, however, this has proved unworkable. L.V. has operated using a 75% figure, but twice a special election at considerable expense was voided because a quorum was not reached).

Therefore, we recommend that the CC&Rs be amended to lower this percentage to a more attainable 60%. Only after this is successfully accomplished can the real issue of the insurance deductible to resolved.

Therefore, ILV feels that it is necessary to amend the CC&Rs immediately, otherwise action on the insurance question might put the Board and Homeowners in serious danger of litigation.

Lucky Leisure Villagers

Our Board of Directors is currently trying to establish a firm policy on payment of the Leisure Village deductible insurance amounts on our individually owned homes. That effort should be strongly commended. To spell out the policy in the "Rules and Regulations" would advise all Villagers of the method by which payment responsibility is determined.

We are lucky that we have Directors who are willing to explain it in detail in an open meeting so that everyone knows what is intended. It is proposed to adopt a policy which Directors had followed for many years in the past, but not in recent years.

Members attending the September Board meeting correctly pointed out that what one Board could do under its Administration, another Board could undo. Well, that is democracy. But it is upsetting and divisive to have such a technical issue constantly raised. And fortunately, villagers took the floor and proposed that the Association again bite the bullet and do the job right. Few who questioned the Board's decision differed with it on the merits of having the Association pay the deductible. The Board can make the rule now, since it apparently has the will and enough legal advice to justify its action.

Since our CC&Rs are not explicit in defining payment responsibility, the Board should mobilize all its resources and amend the CC&Rs so that this problem can be properly solved. That too is the demo-

cratic way.

At long last the Leisure Village Board of Directors proposes to adopt a resolution confirming LVA's obligation to pay the deductible on the fire, extended coverage and special form insurance policy.

This action is in accord with Article III of the CC&Rs, which requires the Association "to obtain and maintain in force a policy or policies of fire and extended coverage insurance ... for the full insurable replacement value of all of the Dwelling Units."

Until 1985 the Board adopted a stance of refusing to pay the deductible — without making a public announcement of a change in policy - no problem arose in this regard.

The current Board is to be commended for restoring insurance integrity and especially for doing it publicly.

At the Sept. 8 Board meeting, a proposed rule was given first reading which if adopted would make the Assn. responsible for paying the deductible on the Assn. master insurance policy, except when the loss is due to the negligence of the homeowners. That is the identical policy which was in effect between 1980 and 1985, but held to be in violation of the CC&Rs by the Assn. Counsel on or about Jan. 1, 1985. That is the identical policy which was proposed last spring in amendments to the CC&Rs by an ad-hoc committee of homeowners which included two members of the current Board. The amendment was not approved by the homeowners.

If such a rule violated the CC&Rs in 1985, why wouldn't the proposed rule do the same if now adopted? Since the CC&Rs can only be amended by 75% of the homeowners, what right does the Board have to change the CC&Rs by a simple rule?

At the Board meeting, a Director stated that the Board had an opinion from Assn. Counsel stating that he saw nothing wrong with the proposed rule! Assn. Counsel was also reported to have stated that the previous Board had misunderstood his earlier opinion. These answers raise all sorts of questions.

As now indicated, if Assn. Counsel did not advise the Board, on or about Jan. 1, 1985, that the CC&R's required the homeowners to pay the deductible on the Association master policy, we

Terminate Termites - Part 3

The July and August issues of ILV included discussions of common sense approaches to termite problems as suggested by Dan Davis, V.39, a member of the Arch. Com., and a licensed building contractor with 40 years experience in the San Fernando Vallev.

In the last section of Mr. Davis' remarks, he discussed the advisability of getting a second opinion in some cases. Only after the homeowner is absolutely certain where termites are can he start to repair. This article will complete the series on termite problems and solutions.

In our recent survey of the Village, the most common locations for infestations were reported in attics, garages, and fences.

Many attics were re-

ported as having wood fungus. This is identified by discoloration in circular patterns. Actually the fungus is a living organism something like yeast--a type of plant-animal species. It also should be treated by scraping and painting with creosote. Mr. Davis says that every attic in L.V. is available to inspection by any carpenter who can create scuttle-hole access.

The chief problem in the garages is caused by leakage from hot water heaters and washing machines. Do not store household items directly on the concrete flooring. Use shelving and allow air circulation. Since the exterior walls of the garage are stucco, it is rare for serious infestation to start here.

Fences which are in contact with the earth are favorite hangouts for termites and wood-destroy-See TERMITES Pg. 15







Emergency Services Organization

Not to be alarmed, it's only a DPX! As a first, ESO (Emergency Services Organization) is having a DPX (Disaster Preparation Exercise). All 250 volunteers are meeting at 9:30 a.m. on Sept. 29 in the AR. An outline of a plan of action will be presented to guide the actual DPX which occurs on Oct. 14. Major General (Ret.) Tom Lawson, City Emergency Services Coordinator, will quide us on Sept. 29 as to the Village's part in the city-wide DPX. The dates of Oct. 14, 15 and the critique on Oct. 16 has been suggested by FEMA (Fed. Emerg. Management Agency).

On Aug. 17, Tom Lawson, city officials, Chief Max Moses and Paul Kelwin, in two flights of 10 each, flew by helicopter from Camarillo Airport. The object was to show us the area that would be affected if Bard Dam broke. That is an 11,000 acre foot, earthen, rock and concrete faced dam, just east off Highway 23, between Simi and Thousand Oaks.

The scenario is something like this: at 4:45 a.m., Oct. 14, an 8 point plus earthquake, lasting one minute and fifteen seconds, only cracks Bard Dam. But, by 9:45 a.m. the dam gives way completely. Its 11,000 acre feet of water escapes and about 11/2 hours later sweeps through Somis.

At about Lewis and Las Posas one branch of water will head west across Camarillo. The Pleasant Valley Hospital and medical complexes will have from 1 to 2 feet of water in it. The other flow of water will come down Lewis Rd. (flooding Camarillo Daily News, etc.) before flowing into Calleguas

Creek. Rancho Adolfo Mobile Home Park (where Tom Lawson, et al live) would, hopefully, be spared. Leisure Village would be protected by that ridge where Mission Oaks homes and St. John's Seminary are lo-

Conejo Creek would not get any of the flow, except far south of us. However, there may be "guests" from cars on 101 if the freeway overpasses are knocked down. Or others may need housing (such as Camarillo High School students) if the bridge over Calleguas Creek is down. We villagers could help with temporary housing.

Our helicopter flight, almost an hour long, carried us back from T.O. as far as Camarillo State Hospital. Charlotte Craven, City Councilwoman, wrote an article that went into more detail in the Camarillo Daily News of Aug. 23.

If you who have not al-

ready volunteered for anything in ESO and wish to participate, come to the Sept. 29 meeting or talk to your Village Coordinator. That person will be most appreciative. Also, watch Ch. 12 and review your Disaster Survival Guide for LV Residents.







MONEY MATTERS

Sometimes keeping things simple is best. I know that's not an original thought but it is one that I have just proven.

Recently, I spent several hours phoning various banks and savings and loans here in Camarillo. I was trying to familiarize myself with different accounts and services offered by our competitors. In my innocence, I thought this assignment was going to educate me and offer new insights into this complicated business of banking.

There I was, armed with a list of questions I intended to ask. A few hours into my phoning, I realized that surveying by phone nowadays was not at all like the surveying of my former years. Instead, I found it to be a test of my patience as well as my endurance. I found people answering the phone who didn't have the vaguest idea of their companies' accounts and services. I was put on hold, disconnected, transferred, and "referred" so many times I lost track. The few times I was lucky enough to receive information, it confused me. Now I know how all of you must feel when you shop by phone. To be fair, there were a few people who did a good job of educating me, but there weren't *that* many.

One of the things that stands out in my mind from this experience was the number of "creative products" being offered. I heard about variable accounts whose interest rates were "tied to the price of gold." That sounded good *if* the price of gold kept going up, but what about when it drops? I was told about "special bonus rates" which were offered if I fit into a specific age group and had a specific amount of money already on deposit at a specific place. And, the one that really got to me was the "guaranteed 8% average interest rate if I left my money in for 10 years." That one was so complicated I can't even tell you the details. Neither could the young lady who answered the phone.


I also found many ways interest is being paid, but I had to ask specifically to find out. Not one place volunteered this information. There is "simple interest", there is "compounded daily interest", there is "compounded monthly interest", "compounded quarterly interest", and at one place I called, I even found "compounded continuously interest." QUESTIONS..... From Pg. 2 them that it was their responsibility to pay the deductible for losses to the interiors of their units? The letters had the appearance of being drafted by a lawyer and cited Sec. 2.3 and Sec. 8.6 of the CC&Rs as being the basis for the homeowners' responsibility.

2. Why did the Assn. Counsel, at a joint meeting of the full Board of Directors and the full Insurance Committee on April 8, 1986, state that the Board could not legally pay the deductible from Assn. funds under the CC&Rs? After he made that statement, he was asked why, after the Assn. had paid the deductible for over 12 years, it suddenly had become illegal? He responded that he had never before been asked by the Assn. whether it was legal to pay such deductibles from Assn. funds; that when he had been so asked, he gave the ruling that the

CC&Rs required the homeowners to pay the deductible when losses occurred to the interior of the dwelling units. He did not at that meeting indicate that the decision to make the homeowners pay the deductible was an 'option" available to the Board and not required by the CC&Rs.

3. Why did Assn. Counsel in a letter dated Nov. 22, 1985 to an attorney representing a disgruntled homeowner, state:

"...it is the position of the Leisure Village Assn. that its insurance obligations are co-extensive with its maintenance obligations, that the Assn. has no repair or maintenance obligations regarding any interior aspect of an individual residential unit, and that, therefore, the Assn. is neither obligated to maintain insurance on the interior or contents of a residential unit nor a responsibility to pay any deductible portion of any such insurance

claim. Both yourself and others seem to be of the impression that the Assn. has an obligation to repair the interiors of the units as well as the exteriors, and, to the extent that insurance proceeds are insufficient to repair the interior, that the Assn. has an obligation to bear the cost of any such insufficient insurance or the deductible portion of any such insurance."

Not only is the foregoing statement in conflict with the present indication that the Board by adoption of a rule can reinstate the policy of having the Assn. pay the deductible, it contains the "shocking" remark that the Assn. has no obligation to insure the interiors of dwelling units (excluding personal property). That remark indicates a failure to understand why provisions are included in CC&Rs of Planned Unit Development requiring Associations to insure "all dwelling units for the full insurable replacement val-

4. Why did the Board consider an opinion it obtained from the law firm of Myers, Widders & Gibson, dated Sept. 1985, holding the homeowners responsible under the CC&Rs for paying the deductible on interior losses as confirming the previous opinion of Assn. Counsel to the same effect? There was no indication in that opinion that such a requirement was an "option" of

the Board. If Assn. Counsel had believed and had expressed the opinion that the Board had the option to determine who should pay the deductible, why did he in the several situations set forth above indicate that the CC&Rs required the homeowners to pay the deductible? Why didn't he advise the Board before the last proposal to amend the CC&Rs was presented to the homeowners, that it could simply adopt the See QUESTIONS Pg. 22

presently proposed rule instead of going through the complicated CC&R amendment procedure? And if he initially advised the Board in 1984-85 that it had an option in determining who should pay the deductible, why didn't he draft a rule for the Board to adopt to designate the option selected?

All of the arguments of the past 2-1/2 years stem from unrealistic and far fetched interpretations of a simple provision of the CC&Rs directing the Assn. to obtain and maintain in force a policy of fire and extended coverage insurance for the full insurable replacement value of all the dwelling units, and such other insurance as the Board deems to be in the interests of the Assn. and its members. The CC&Rs don't spell out who is to pay the pre-

mium on the policies or who will pay the deductible. Anyone reading the words would assume the Assn. was responsible and would include the annual costs in the annual assessments to homeowners. That is the way the CC&Rs were administered for the first 7 years of operation of the Assn. The Community Assn. Institute Guide for Assn. Practitioners on "Community Association Insurance" states with respect to the deductible: "if the association is responsible to insure for full replacement value, then the association is responsible for the deductible which is part of that loss." The rules of the federal lending agencies which purchase mortgages of planned unit developments in the secondary market - FNMA and FHLMC — provide that they will accept blanket insurance covering all units in the PUD if called for in the PUD's constituent documents. They also provide that "Funds for any deductibles must be included in the association's reserves and be so designated."

How do we resolve the mess we're in?

1. Table the proposed

rule.

2. Retain the most eminently qualified attorney in Southern California specializing in Condominium and Planned Development Practice to review the current situation and advise the best course of action. This is what the Special Ad Hoc Committee appointed by the past Board recommended after their first meeting approximately one year ago. However, this recommendation was abandoned a few weeks later when the group of homeowners represented on the Ad Hoc Committee insisted on a different course of action. As of this date it still remains the best course of action to follow if the legal issues are to be settled - rather

than just stirred up.


