A regular meeting of the Ventura County Commission for Women was held in the Commission office at the Human Services Agency, 4601 Telephone Road, Suite 201, Ventura, on Saturday, May 3, 2008. The Chair called the meeting to order at 9:18 a.m. As the Incoming Recording Secretary was not present, the Outgoing Recording Secretary was selected to serve in her place.

Commissioner Pallant read the VCCW Mission Statement.

Present were Chair Mary Pallant, Vice Chair Elvia Guizar, Correspondence Chair Diana Goodrow, Treasurer Nancy Lee Phillips, Recording Secretary Lee Riggan and members Janet Barron, Jan Lawrence, Sharon Hillbrant, and Shanté Morgan-Dunsseau. The Chair declared a quorum was present.

Commissioner Morgan-Durisseau introduced Ms. Debra Bagley (<a href="mailto:dbagley1@sbcglobal.net">dbagley1@sbcglobal.net</a>) who has submitted an application to represent Supervisor Foy in District IV on the VCCW. Ms. Bagley spoke of her background, experience, and desire to serve VCCW as a Commissioner.

Commissioner Phillips moved to approve the minutes of June 7, 2008. The motion was seconded by Commissioner Goodrow and was adopted.

Treasurer Commissioner Phillip reported that the Treasury balance was \$280 as a result of donations made in honor of Former Commissioner Cecilia Fargo. The report was received and filed as presented by general consensus.

At 9:30 a.m. Chief Deputy Clerk of the Board of Supervisors, Roberta Rodriguez (Roberta.Rodriguez@ventura.org, 805-654-3361), reported on her responsibilities in support of the Ventura County Board of Supervisors and its 80 Boards and Commissions (mandated and discretionary), AB1234 Ethics Training, and requirements for VCCW and its commissioners. Commissioners are required under AB 1234 to attend Ethics Training to be offered by the County beginning in October. After attending the first training commissioners may take annual refresher classes on-line. Currently the County offers no training on the Brown Act. Chief Deputy Clerk Rodriguez will obtain responses from County Counsel regarding VCCW Commissioners' concerns. The Brown

Act requires the posting of the VCCW Agenda 72 hours prior to its meeting at the location of the meeting and available at all time (24/7). It was recommended that VCCW have a policy regarding public comment that may be similar to the Board of Supervisors' policy. A packet of material to be considered at each meeting is to be posted on the web site and a contact number is to be provided for the public to obtain a copy. The Board of Supervisors approved the original VCCW bylaws. Revisions proposed by VCCW would also need Board of Supervisors' approval and be presented through the VCHSA staff (Larry Zimmerman). Chief Deputy Clerk Rodriguez was informed of the pending approval of the MOU between VCCW and VCHSA. Rodriguez asked that VCCW provide her with an updated Roster (both for public record and private information). She suggested that the VCHSA attorney review any revisions to the bylaws. She said that she would seek clarification for VCCW on the following specific issues: Brown Act; MOU with VCHSA; Email Policy; and collaborative requirements with outside groups. Future contact between Rodriguez and the VCCW is to be through the Chair, Commissioner Barron. At 10:37 a.m. Chief Deputy Clerk Rodriguez ended her presentation to the VCCW meeting.

Commissioner Goodrow reported that VCCW received phone messages and various correspondences.

Commissioner Phillips reported on the progress she, Darren, and Commissioner Peters have made. The web site is ready to upload and awaiting County server access. Photos of commissioners edited by Commissioner Lawrence were reviewed and will also be posted.

Commissioner Pallant reported that the CalWORKS presentation would be postponed to next year.

Commissioners Goodrow and Riggan reported that a letter, budget, and other documents had been sent to Hugh Ralston and Roz McGrath on the findings of the VCCW Status of Women & Girls in Ventura County 2009 Report Committee. The Committee was invited to discuss these findings with the VCCF Director and the Women's Legacy Fund Board on July 15<sup>th</sup> at 9:30 a.m. Commissioner Goodrow expressed her concern regarding the inability to obtain a model budget from already completed studies Commissioner Guizar reported she is seeking a source of funding for the Teen Sisters Pregnancy Prevention Project. Possible funding source mentioned were Office of Minority Health and Office of Family Planning.
