## Diversity Forum

*Hundreds of students from across the state and members of the community attended the CSUCI 2004 Southern California Forum for Diversity in Graduate Education held in early April. The all-day event featured more than 100 college recruiters from around the country who offered graduate program information to underrepresented undergraduate and master's degree students.*



## Two New Master's Programs Address Community Needs

The University was pleased to launch two master's programs this year. Designed to meet the specific needs of county professionals, both the master's of business administration (MBA) and the master's of education programs were developed with community input.

According to Ashish Vaidya, professor of economics and MBA Program director, interest in an MBA program began when the campus first opened and has been in the University's master plan since its first year of operation. Supported largely by student fees and offered under the Extended Education Division, it will be the flagship program for the University's Business and Economics Program.

Another distinctive feature of the MBA program is its founding Business Advisory Council, comprised of business and industry leaders from the county who will serve as a major resource for the program and its students.

"We have designed what I think is a forward looking MBA program – benchmarking it against some of the best programs in the country," Vaidya said. "It's highly integrative and very consistent with the University's mission of graduating individuals with multicultural and international perspectives."

The Principals Leadership Program, which awards a master's of education degree to qualified candidates, was created from a similar standpoint. After meeting with Ventura County Superintendent of Schools Dr. Charles Weis, Joan Karp, CSUCI professor of education and Education Program chair, was briefed on the area's need for highly qualified school principals and other educational leaders.

"Together with Dr. Weis, local superintendents, local principals and our own faculty, we've taken national and state standards for the requirements for a principalship and then tailored it to address the issues that are important to our county, such as how a principal works with children with English as their second language or who come from multicultural backgrounds," Karp said.

The collaboration has produced a program that emphasizes hands-on instruction and fosters leadership skills and technical knowledge.

## University Hosts Forum on Regional Growth Issues



As part its outreach efforts and involvement in community issues, the University hosted a recent conference on regional housing and growth problems, featuring a local panel of experts and a keynote address by Henry Cisneros, former Clinton secretary of housing. The event, titled “The Road Ahead,” was sponsored by the University, the *Ventura County Star*, and the Ventura County Civic Alliance.

The all-day conference was moderated by Tim Gallagher, publisher and president, *Ventura County Star*. Panel speakers represented local government, community agencies, and private business.

The speakers, as well as members of an overflow audience, discussed a rapidly increasing population, lack of affordable housing and parcels of lands upon which to build, increased traffic and congestion, and how all of these factors impact the environment.

In his remarks, CSUCI President Richard R. Rush said that the individual and collective dreams of the county will not become a reality without addressing these problems. “With everyone’s good offices and with your imagination and with your ability to articulate not only the questions, but the resolutions, we will solve these problems and together make the dreams as a whole, a reality for all of us.”

Panel members agreed that solutions will not come easily and that local government and communities must address these looming problems now since they will only worsen in time.

For the most part, the speakers, including Cisneros, endorsed the concept of “smart growth,” or combining commercial and residential units in neighborhoods that encourage pedestrian traffic.

Cisneros talked about recycling old neighborhoods to meet current and future housing demands. “Six out of 10 cities in the county will run out (of land) by 2008,” he said. “You can get more out of smaller pieces of land by recycling old neighborhoods.”

Cisneros also emphasized that Ventura County leaders can lead the way by providing housing for all income levels, including local farm workers. One answer, he said, is building apartments for low-income families.

Cisneros said that ultimately government must play a major role in solving housing and growth issues by reconsidering zoning laws and creating new policies on land-use. “I am a believer that cities, communities, and regions can be masters of their own destinies,” he said.

## Reading Program to Feature Local Author Villaseñor

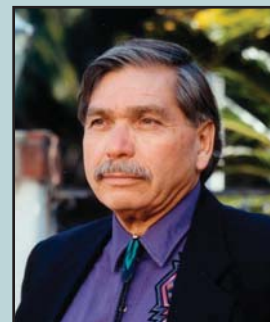
Lively discussions among students, faculty, and staff will result from a new program called “Campus Reading Celebration.” The program, to be launched this fall, will focus on local best-selling author Victor Villaseñor’s “Rain of Gold.” Copies of his book will be distributed free of charge to students thanks to funding from the University Foundation.

Discussion sessions with the author, facilitated by faculty and staff, are planned. Faculty will also integrate the book into class work. Here is his schedule:

**September 14:** from 10 – 11:15 a.m., meets with three classes; from 2:30 – 4:30 p.m., gives an informal book talk to students, faculty, and staff in the Student Lounge Courtyard.

**September 15:** from 11:30 a.m. – 12:45 p.m., meets with the Bilingual Literary Studies class and other classes in the Science Auditorium. From 6 – 6:30 p.m., a reception open to the University community at no charge (\$5 per person for outside community members and \$2 per person for students from other colleges and universities).

**September 16:** from 2:30 – 4:30 p.m., campus presentation for Hispanic Heritage Month, Lecture Hall 1; 5:30 p.m., reception for the President’s Council.

## CSUCI Honored as ‘Family-Friendly’ Employer

The University was recently honored as a “family friendly employer” by Project Work/L.I.F.E., a Ventura County organization.

CSUCI was presented the award at a luncheon in May for “implementing significant work/life practices” in the workplace, such as increased opportunities for quality family time and for offering a progressive benefits program paid mostly by the University, with minimal cost to employees.

According to Project Work/L.I.F.E., the University exceeded the family-friendly employer criteria established by the Workforce Investment Board, the Ventura County Economic Development Association, and the Child Care Planning Council of Ventura County.

## CSUCI Small Business Institute Helps Santa Paula Small Businesses

The University's Small Business Institute (SBI) has partnered with the city of Santa Paula to create a micro-loan program designed to help the city's small businesses that generally have more difficulty in obtaining loans.

In the program, the city of Santa Paula and its Redevelopment Agency have initially agreed to commit \$100,000 in micro-loans for small businesses located within the redevelopment area of the city. The SBI will have the responsibility to recommend approval of the loans and administer the program for the city.

In addition, the small businesses that are approved for loans will be able to qualify for free management and technical business assistance provided by CSUCI senior and graduate level business students.

"This is a wonderful opportunity to demonstrate our University's commitment to the small business community by helping to enhance the success of these small businesses, while at the same time drawing upon the growing technical business talent of our finest business students," said Rudolph Estrada, director of the CSUCI Small Business Institute and a member of the business and management faculty.

## Lifelong Learning Institute Created for Local Residents Over 50

In keeping with its mission to create meaningful partnerships with the community, the University has established its Lifelong Learning Institute, a program that will provide educational and enrichment opportunities for local residents who are 50 years of age or older.

Beginning this fall, the institute, which was funded by the Bernard Osher Foundation, will offer high-caliber, intellectually challenging courses from current and emeriti faculty members at a nominal cost.

Courses will focus on topics of specific interests, some of which may be suggested by students, says Martin Kaplan, director of the institute. Instructors will not require degree requirements nor will they issue grades.

As the program continues, a service-oriented workshop may be offered and educational travel trips may be offered at reduced costs. Guest speakers will occasionally be invited to address classes.

## Single Subject and Education Specialist Programs Approved by California Commission

The CSUCI teacher education program continues to develop in response to the continuing need for talented teachers in the area. The Single Subject and Education Specialist Mild/Moderate teacher credential programs were recently approved by the California Commission on Teacher Credentialing.

The single subject program prepares middle and high school teachers for instruction in English, mathematics, and science. The education specialist credential prepares special education teachers to teach students from kindergarten to age 22 who have mild or moderate disabilities.

The University was also approved to work with the local school districts with single subject and education specialist interns who are not

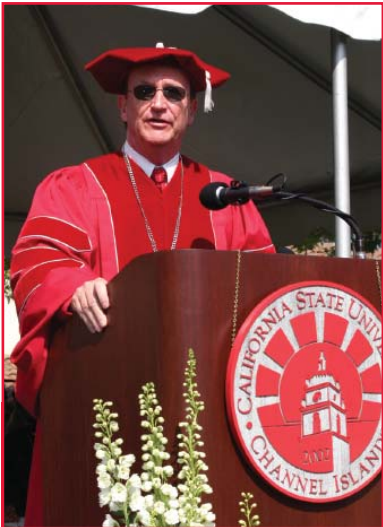

## Outstanding Individuals Recognized at Awards Ceremonies

As the academic year was coming to a close, two awards ceremonies were held on campus — the annual Honors Convocation, which recognizes student academic achievement, and the newly established Maximus Awards, in which students honor outstanding members of the faculty, staff, students, and community.

In the Honors Convocation, twenty-three students were acknowledged for their summa cum laude status (3.9 GPA or higher). Of those, seven scored a perfect 4.0 GPA. In all, 155 students attained 3.5 GPA status or higher, with 104 coming from CSUCI and 51 coming from CSUN-CI. Students created the Maximus Awards to recognize members of the University community with individual awards as well as with Paths of Excellence awards to University and community individuals whom they feel have participated in the growth and development of CSUCI.

## Nothings Larger than Life

She takes life in big scoops. She doesn't go for little snippets and bites; it's more like chunks of living, experiencing, and learning.

Jennifer O'Toole thinks and lives expansively, beyond boundaries. More than that, she has overcome limitations that many people would find daunting. When O'Toole was four, she had her first bypass surgery to correct a congenital heart problem. Since then, she has had three more.

But none of this snags her full-throttle look at life at CSUCI. The junior English major from Ventura is more than just a student here. She epitomizes the University's mission and is one of its most ardent supporters.

Since enrolling here in 2001, O'Toole has worked as a student ambassador, a student assistant in Student Affairs, Academic Affairs, and in the Recruitment office, and served on the Student Health Advisory Committee, Associated Students, Inc., the Faculty Support Task Force, and on the cabinet of Student Government. She is also a member of the Multicultural and Women's & Gender Center and is the current editor of the University's student newspaper.

"This place is perfect," O'Toole says. "Students have the unique opportunity to explore their interests, define their views, and establish career goals — and work one-on-one with faculty, students, and administrators.

"There's just an amazing amount of support here — including the president. President Rush is an outstanding person. It's pretty special when a student is comfortable with the president. And, really, I've experienced that at every level. It's such a welcoming environment."

Those who know Jennifer say that she's as much a part of the formation of this University as anyone. "From the beginning, she dived in to help this new University grow from scratch," says Renny Christopher, professor of English and chair of the Academic Senate. "She worked closely with faculty and administrators in ways that most students do not."

But it isn't just her involvement in building the University that makes O'Toole special. "Jennifer is very smart and talented," Christopher says. "She knows how to ask questions on any issue. She will not hesitate to use critical thinking. She is very committed to the core values of this institution, to diversity, equity, to its international perspective, to her role as an active member of the campus community. She is what the University is all about."

After graduation next year, O'Toole has more big plans. She may live abroad, perhaps in Spain, since she is developing her Spanish language skills. She will also continue to write poetry. Ultimately, her goal is to obtain a doctoral degree in English and teach writing at the university level.

Her University friends already know that they will miss her. But they understand that she has a great deal to do, to think about, to experience, and to learn. And they have no doubts that she will. After all, she has a lot of heart. **C**

# Art in Motion

In Liz King's mind, colors, shapes, and images swirl about in a continuum of motion. Lines, circles, and forms morph and dance into composition. The sounds of voices and music often blend into the mix. In computer-like play, abstract thoughts and ideas are given three-dimensional life.

It's the new art of the 21st-century. It's the computer as canvas. It's art and design fusing with technology. And King, CSUCI assistant professor of art, embraces the new art-tech media — from computer graphics, to animation, to interactive media, to Web sites — with endless fascination.

"It's exciting and creative," King says. "At the core of our philosophy is the integration of fine arts training alongside computer graphics training. Anyone can learn software. It's the original ideas and traditional artistic training that we bring to the software that is important and gives us the edge."

King has the credentials to be one of leading practitioners and teachers of computer art. The CSUCI professor has won awards for both her fine art as well as for her computer design work.

After obtaining her B.A. and M.F.A from UCLA, she took classes in virtually every aspect of the field — computer animation, special effects, multimedia, Web design, digital production, drawing for animation, figure and animal drawing, storyboarding for television animation, and just about every design software program in existence.

King soon put all this burgeoning talent and abilities to work. She garnered an impressive list of high profile clients, including KCRW radio in Santa Monica, UPN Channel 13 in Los Angeles, the Oxygen cable TV network, NASCAR, as well as segments for *CBS This Morning*, *ABC Monday Night Football*, and ESPN.


While all of this has been exciting and gratifying, King wanted to use her knowledge and experience for another purpose. She became a full-time CSUCI professor of graphic design technology in 2003.

"I met Jack Reilly, (professor of art and) head of the Art Program, and listened to his vision of the program. His idea is that art and technology feed into one another. What you can do in a painting you can do in a computer."

Another distinction is the University's commitment to interdisciplinary teaching. "Recently, I worked with Antonio Jiménez-Jiménez, CSUCI assistant professor of Spanish," King says. "His students worked with my Web design and multimedia students on Web sites and animations based on their Spanish compositions about such subjects as racism and human rights, using animation and Macromedia Flash. The results were extraordinary. It just shows you what we can do together. Integrative learning is a hallmark of CSUCI. I really believe in it."

Her CSUCI experience has exceeded her expectations. On a daily basis, she inspires and is inspired. "I want students to find their own way," she says. "When our students leave the University, I want them to go out there and create completely original and intriguing work that can compete in today's market. I want them to succeed. And I hope they'll come back and share their experiences with me and other students. That would mean a lot to me."

# Ambassador At-Large

Ideas and energy come bubbling and bursting forth. For her, life's a non-stop whirlwind of activities, with a to-do list that's longer than the day itself.

And a great deal of Linda Dullam's activities is focused on the University. She is one of CSUCI's original and most dedicated supporters, going back to the late '90s.

As a member of the Foundation, she helped in the creation of the University's first scholarship awards, as well as in the recent courtyard design contest as a member of the Landscape and Courtyard Committee. With all that, she also found time to plan the annual President's Dinner — and is now planning to chair a second one.

In essence, Dullam is one of the University's most enthusiastic and effective ambassadors. Everywhere she goes, she brings people into the CSUCI fold — to contribute funds, to serve, to create, to advise, or simply lend a helping hand at an event. "It's so gratifying because the people who do become involved are so committed, are so devoted to making this University a great place," she says. "We're all part of the CSUCI family."

Her ideas for the future of the University are boundless. She'd like to see a faculty club that would be open to the public to expose more of the community to the University. She wants to see a center for performing arts. And she is brimming with ideas to beautify the campus.
