Rosa Toro called the meeting to order at 1:39pm.

1. The agenda for the meeting was approved.
2. The minutes from the September 18, 2015 meeting were approved.
3. Chris shared that the Anthropology department representative indicated ANTH 145S revisions are in process. A revised syllabus will be sent in the near future. Per the committee's decision at the September 18th meeting, once the appropriate revisions are received, the course will be recommended for S designation.
4. Lizhu shared with the committee Working Group 2's summary review of the Dance 160S proposal. The committee approved the course for recommendation as an S course, with only one recommendation. Chris will pass that recommendation on to the department.
5. Rosa shared Working Group 3's review of MRKTG 100S. The committee will recommend the course for S designation, provided two requested changes be made. Chris will share those changes with the department and will work with them to ensure the changes are made prior to recommending S designation to the Undergraduate Curriculum Committee.
6. Ben shared an update on CFS 143S. That S course proposal will be put on hold by the department, pending a faculty member's participation in the SL Seminar and subsequent revisions and resubmittal in the spring.
7. Chris shared with the committee the status of the 5-year reviews for ART 177S, CHEM 165S, MCJ 158S and MCJ 159S. Given the passing of Professor Paulette Fleming, it was agreed that it would be best to table the review of ART 177S until the spring. Chris will notify Department Chair Martin Valencia. Materials for all other courses under review should be
