



Tapping into water savings

Despite the recent heavy rainfall in Southern California, the price of the water we drink and spray all over the Village continues to go up, and the supplies are nowhere near as plentiful as the occasional storm would lead us to believe.

Local officials estimate that our water rates will go up about 7 percent next year, adding about \$35,000 to the Village's water bill, which now is in the neighborhood of half a million dollars a year.

One source of financial relief for this bill is the soon-to-be-completed partial switching of our land-scaping water, from drinking quality, to that currently used when area farmers "water the back forty." Like

them, we too will use recycled water. And, like them, our incentive will be to make things greener — in other words, to save money.

More than that, we will also help to conserve the West's diminishing supply of natural water, which, if not voluntarily saved, will eventually have to be saved by some form of rationing.

Joys of a hobby pay off in retirement



he cause of the American Revolution is often simplified by the ery, "Taxation without representation."

Today, some residents of Leisure Village are crying, "End double taxation."

They complain of being doubly taxed, especially when it comes to repairing and maintaining the Village streets.

Since residents' property tax money eventually helps pay to maintain and repair streets in the city of Camarillo, the logic concludes that Camarillo's tax-generated funds should be used to help maintain and repair Village streets and some other possibly duplicated services.

As with most promises of possible tax relief, the idea has appeal.

Taxation itself is increasingly odorous to many Americans, but to be taxed twice is unfair and "un-American."

Each of us decides whether or not to pay our taxes -most of us do, even when we think our money is often being misspent or just wasted.

However, living in a walled and gated Village, separated from the rest of Camarillo, in a place where we restrict access to only those who own property inside the

Village or those who have our permission to enter, we live in a privileged community.

Beyond that, as citizens of Camarillo, Village residents have the right to use all the city streets and all other services because we pay for them through our taxes:


Camarillo residents, however, who do not own property in the Village, have no right of access to Village streets or any other Village services.

Yet, if Village residents feel the city is misspending or wasting their tax money, we have the right to vote in city and county elections; we are free to attend Camarillo City Council meetings, and, as resident Percy Silver showed in the recent election, we can seek a seat on the City Council to decide how our tax money is spent.

Insisting that we are victims of double taxation ignores the difference between rights and privileges.

If the general funds of Camarillo are used to maintain the streets in Leisure Village, will it then be logical to expect Camarillo to extend its rights to include free and uncontrolled access to those streets?

To paraphrase the late President Reagan, will we then be ready "to tear down our walls?"

eisure Village Association's new short-term pass procedure is at least a 70 percent downgrade.

A visitor can no longer use all three gates. They are restricted to the main gate.

Also, visitors are no longer issued a pass for reentry to the Village. The vehicle license plate is the pass, and all pertinent information is entered and stored in a computer. When the original information allowing a visitor to enter the Village is lost due to human or computer error, he cannot re-enter. This has happened, and without a doubt, it will continue to

Under some circumstances this could be critical and make Leisure Village fiscally responsible for any hardships suffered by the visitor and homeowner involved. This is especially true now because this possibility has been brought to the Board's attention. This possibility could be eliminated by clicking on the computer

The two main reasons given for this change are:

1. The old pass system was being abused, resulting in theft. (There has been no verification of this.)

2. Occasionally, residents want security to keep a family member or friend from visiting temporarily. (We should not put our security personnel in jeopardy by involving them in family matters. The Association is not our keeper; we are not a care facility.)

To implement this new procedure, a computer was purchased for each gate. Computerizing our pass system is a plus, as it will make our maintenance more effi-


The scheduling was unusual and necessitated personal off-hours time and patience to herd us through the procedure while maintaining smiles and good humor.

Village Ombudsman turns reins over to new crew



Ideally, we all have somebody who cares about what happens to us, no matter what.

For the past five years, Village residents could count on at least one person to be there if needed: Al Bennett of Village 25, the Chair and probably most visible and active member of the Ombudsman Committee.

Al enlivened open Board meetings with his often entertaining, always sincere, New York-flavored narratives of the ways his Committee helped vet another neighbor to be a better neighbor. And, usually, it was Al who personally stepped in to resolve disagreements this or that resident might be having.

All that ended a few

months ago when, citing health reasons, Bennett, now 92, resigned.

He got the usual mention and citation from the Board, but that did not adequately tell residents of what service Al Bennett had given the Village for more than a quarter of a century.

Unmistakably Manhattanborn and bred, Bennett, a graduate of Cornell, spent most of his working life as a chemist with, as he proudly put it, "The Great Atlantic & Pacific Tea Company," better known to all us New Yorkers as, "The A and P."

Like most in the East.

Marx classic 'Duck Soup' airs Nov. 21

Back in the 1920s, there were five brothers, Minnie's boys, who made a big hit on Broadway with their madcap comedy, "Coconuts." It did not take long before Hollywood beckoned, and they translated their chaos to the screen. They were Groucho, Chico, Harpo, Zeppo, and Gummo Marx.

"Coconuts" opened on Broadway as a play in 1925, and it was made for the screen in 1928. It was followed at a somewhat leisurely pace by "Animal Crackers," "Horse Feathers," and the movie we will see at 7 p.m. on November 21, "Duck Soup."

"Duck Soup" was the last movie to have the four brothers. Gummo never appeared in pictures, preferring to become an agent. But Zeppo stayed with the brothers until "Duck Soup." Easily the most handsome of the five, he usually played romantic leads, in contrast to Harpo, Chico

and Groucho, whose antics and wanton destruction of the English language set a standard that has never been surpassed.

Their sense of the absurd:

• A scene with Groucho standing over a character who has fainted, looking at his wristwatch and taking his pulse. "Either this man is dead or my watch has stopped."

• The brothers' constant jokes played on Margaret Dumont, their eternal foil. (Groucho claimed that the secret to their chemistry was that Mrs. Dumont never understood what he was saying.)

Groucho certainly had inventive character names. In "Duck Soup," he played the role of Rufus T. Firefly. In "Horse Feathers," he was Quincy Adams Wagstaff. In "A Night at the Opera," Otis P. Driftwood. In "A Day at the Races," Dr. Hugo Z. Hackenbush.

Only W.C. Fields approached the Marx


Brothers in his penchant for character names, with Elmer Prettywillie, J. Effingham Bellweather, and Larson E. Whipsnade.

Our historical footage will include one or two episodes of "Your Bet Your Life," Groucho's famous TV show. We're lucky to have them. The originals were produced on film. In the 1960s, the owner of the rights was about to sell all the films to have them melted down and reclaim the silver halide from the emulsion. A collector caught him just in the nick of time and bought the entire collection of TV shows for \$50. Speaking of bargains! And what a great service to the history of TV as well.



Contracting disputes can be a messy business

Having a dispute with a contractor can be a messy business.

To begin, state laws require a contractor to inform a potential client of the various laws that protect the contractor. These are primarily so-called "Mechanic's Lien" laws. These laws provide that, if a worker or material supplier on a construction job is not paid, the contractor has the right to place a lien on the property. That lien encumbers the title (ownership) of the property until the contractor receives the unpaid balance. In fact, that means that if the contractor, for any reason, fails to pay the

workers or suppliers, he owes money for doing your job, then you must pay those bills, even though you may already have paid the contractor the full amount.

The reasoning is that your property has been improved and its value has increased; therefore, the property must be held liable. As the owner, you must pay that debt. Though it seems unfair that you must pay for something twice, it is fair to the worker or the supplier who has contributed to the improvement of your property.

As I have previously written, it follows that you should not pay anyone the full amount of a contract until the work is done, until f there is anything you do not understand, have the documents checked by an attorney.

inspections are completed, and until "lien releases" are received that indicate that all workers and suppliers have been paid — all of which will be possible if your contract has been properly written.

If there are problems with the work, failure to pay the final amount, which should be around 10 to 20 percent of the total price, is your only leverage to obtain satisfaction.

You may also find a clause in such contracts that requires disputes to be resolved by mediation or arbitration. If so, then a process must be followed to settle the disagreement.

It should be obvious that the disputes that can arise in a construction arrangement can come from specific disagreements on what work was contracted for, the price, the schedule, and changes to the original agreement.

For these reasons, use of

forms provided by the contractor may be unwise. If there is anything you do not understand, have the documents checked by an attorney who may also add some important protections for you and give you other valuable advice.

If the project is clearly defined by words and drawings, payments are clearly stated, the time for the project clearly stated, and all changes to the original agreement are made in writing and signed by both parties, there should be no disputes.

Loose or sloppy work by you in any of these areas is a recipe for increased costs and a potential construction disaster.



We live in a typical house in Leisure Village, two bedrooms and two baths. Now the size of the house may vary, but the number of bathrooms is always the same. Our hall bathroom threatens the sanctity of our marriage. Please let me explain.

"At first, I wanted to go to the meeting with her, which is what the lady wanted. However, I checked with a lawyer to find out the proper legal procedure. He told me that if a lawyer did that, the fee would be a thousand dollars.

"Then I called Legal Aid in Ventura. They said all they could do was make an appointment with the lady and give her half an hour's worth of free advice.

"Next, I called Gray Law, also in Ventura. They, too, said their organization could give her advice, but it would not send a representative to any meeting.

"We tried several times to call the lady, but nobody ever answered the phone.

"Then, when we went out to her house, it was empty. Her neighbor told us that the couple had just moved out.

"I later found they had moved to assisted living.

"For some reason, I felt guilty that I had not solved their problem. And I've never forgotten the case."

But Bennett also recalled a nicer story, one that pretty well sums up the man.

"It was Christmas season a couple of years ago. I was walking and I saw a young

couple with a puppy. You know how it is with puppies. I had to go over to them and the lady says, 'Aren't you the

Ombudsman? I listen to your reports all the time.'

"If that didn't take the cake," Bennett marveled, his big, self-amused grin coming right through the phone at me.

And, as he had for the last five years, Al Bennett wrapped up another Ombudsman adventure with his familiar assurance, "And that's exactly what happened."

Like all things in the Village, time brings change, and with the Ombudsman's office, the change is a newly staffed committee which is chaired by Alan Rosin and comprised of members Barbara Swartz, Duane Waln, Ernest Houghton and this reporter.

Of Bennett, Rosin agreed, he was "one of a kind, a dedicated and thoughtful citizen whose work helped many residents."

Rosin does not plan any major changes. The emphasis will remain on helping neighbors to solve problems they may have with their neighbors.

While he would rather not be called at home, Rosin is discussing with the committee the possibility of setting up a telephone "hotline." But for now, he says, "The best way to contact the Ombudsman is through a sealed letter. Just think about what you want to say, write it out, put it in an envelope and put that in the Ombudsman Box in the Recreation Center Office or drop it off at the Administration Building.





The trip described here takes less than two hours depending on your "gawking" time. The total trek calls for about 50 miles of reasonable driving.



Insurance matters when others drive your vehicle

Last month's article generated a lot of questions which I really love. Sadly, none about my dog, Cutie.

In case you missed it, my column was about the dangers of using unlicensed individuals (no Public Utilities Commission license) to drive you somewhere in their car, for a fee.

My professional advice was never, ever do that.

The downside of that advice is that it leaves a lot of Villagers stranded.

What can be done when we really have to be someplace and cannot or do not want to drive or spend the money for a limo or a oneway taxi ride?

The shuttle from Camarillo to LAX costs from \$40 to \$85 each way. The key is to book in advance.

Another solution is to hire a driver. Most limousine companies provide drivers who will drive your car, for a fee of between \$20 to \$35 per hour, with a four-to six-hour minimum. It is less expensive to hire someone from the Classified Ads in Inside Leisure Village to drive your car.

But first, check with your insurance agent to make sure such an arrangement is covered. As far as I know, every auto policy has coverage for what is called a "permissive user," someone who

drives your ear, with your permission. In that situation, they are covered and so are you. The only downside is that any "at fault" (your driver's fault) accident will be charged to your policy's history.

However, most experienced drivers are very careful, and the risk is minimal compared to going in somebody else's car in which your payment of a fee has voided the operator's insurance

Now, to switch to another subject.

For the next few issues, I plan to concentrate on homeowner policies and begin with a recurring question: What are the sequen-

tial HO policy numbers, such as 1, 2, 3, etc.?

For example, HO-1 and HO-2, are stripped-down policies, but they do provide building coverage.

HO-3 is by far the most common policy. If you owned your home before coming to Leisure Village, the chances are good that you had an HO-3, the standard homeowner's policy.

An HO-4 policy is one purchased by a renter or tenant, and it has no building coverage.

An HO-5 is a super, deluxe homeowner policy. It gives expanded all risk coverage to contents and often covers your contents worldwide. It is very expensive. And the HO-6 policy is for condominium exposures. It can be expanded to cover buildings and is tailormade to include such things as loss assessment.

Next month, I will break down the various parts of an HO-6 policy. I plan to give you a basic insurance lesson.

However, every good lesson needs questions to make the instructor give his best.

because none has ever worn out!

Despite the progress, we still face a major problem: We need people. Our expanded facilities need people to manage them. We desperately need more camera operators, editors, programmers, message typists and general help.

We constantly remind you that our wonderful, dedicated technicians, George Huddleston and Bob Vanderhaven, as well as Art Kaufman, are already overworked. We need people to help them. It only takes a few hours a month. It is easy to learn and fun to do.

That's already being applied in the parts of Las Vegas that get their water from the ever-decreasing supply from the once bountiful Colorado River Basin, which supplies water to six states and part of Mexico.

Currently, at a price of \$622 per acre foot (the amount it takes to cover an acre of ground one foot high), the only water used entirely in the Village is drinking-quality water that makes a 600-mile journey from the Sacramento River in Northern California.

That price is three times as much as recycled, or "irrigation" water (\$200 per acre foot) that soon will be satisfying the endless thirst of the front nine holes of our golf course. Because of the higher salt content in recycled water, the area will occasionally be sprayed with regular water to rinse off the salts.

Such facts of water life were the basis of a Town Hall meeting on Oct. 20 presented by the Village's Water Management Committee to explain the logic and value of the coming switch to recycled

Technically, the repiping is just about completed. The practical switch, the actual use of recycled water, will occur within the next few

months. Eventually, if the residents decide it's worth the price, all of the Village landscaping will be done with recycled water, possibly as early as a year or two from now.

The meeting, attended by about three dozen residents and televised by Channel 25, was chaired by Association President Robert Ellis, who also heads the Water Committee. The thrust of the meeting was to explain some obvious differences between the two water sources: natural (drinking), and that which is processed (recycled or irrigation water).

The main presentations were made by Richard Hajas, General Manager of the Camrosa Water District, which supplies all the Village water, and Chuck Rogers, Superintendent of the City of Thousand Oaks Waste Water Treatment Plant in Hill Canyon, which is the source of the recycled water distributed by Camrosa.

According to current estimates, if all the Village landscaping were switched away from drinking water to recycled water, the savings would add up to approximately \$200,000 a year.

The savings would be even greater if residents used bottled water to wash down patios and driveways and to wash their cars. The tongue-in-cheek example is meant to illustrate the reality of using expensive and

harder-to-supply drinking water, no matter what the source, to do things best done by brooms, commercial car washes (which use recycled water) or not done at all.

Additionally, attendees saw a Village-produced video on the subject, examples of the new signs that will be posted at major points wherever the recycled water is used, new landscape watering equipment - such as hoses and sprinklers, which have already been purchased by the Village - and handouts and other materials designed to answer most of the obvious and basic questions about the new water supplies.

Despite some apparent misconceptions among some residents who lately have been expressing concerns about what they complain of as "double-taxation" in a variety of areas, (see separate comment in the Letters section), there is no tax associated with recycled water. Just the opposite, as noted earlier: Its use will actually save residents quite a bit of money.

The Water Committee has created a handout which provides the answers to the usual questions about recycled water. Those questions and answers can be found in the October issue of The Village Voice.

escrow account." That is not the case in California. Here, the Leisure Village Condominium Bluebook spells out how disputed assessments are handled under California laws:

"An owner may dispute an assessment debt by giving the board of the association a written explanation, and the board must respond within 15 days if certain conditions are met. An owner may pay assessments that are in dispute in full under protest and then request alternative dispute resolution. An owner is not liable for charges, interest, and costs of collection, if it is established that the assessment was paid properly on time.'

Now, to the subject of this article, "Fines."

Fines are a form of punitive action that an association may impose on a member for violating any of the governing regulations. Before fines are levied, certain conditions must be met.

The ubiquitous Davis-Sterling laws require that, if the board of directors adopts a policy of levying fines for rules violations, it must give notice of that policy to all members by personal delivery or first-class mail. The board is not required to distribute any additional schedules of monetary penalties unless there are changes in the schedule.

In effect, this means that fines must be clearly defined before they can be imposed on a member. (See

Leisure Village Rules and Regulations, Article I, in the Village Telephone Book, Page 9.)

The law goes on to state that there are "due process" requirements that must be met. When the board of directors plans to meet to consider or impose discipline upon a member, the board must notify the member in writing, by either personal delivery or firstclass mail, at least 10 days prior to the meeting. The notification must contain, as a minimum, the date, time and place of the meeting, the nature of the alleged violation for which a member may be disciplined, and notice that the member has the right to attend and may address the board at the meeting. The hearing must be in executive session if requested by the member being disciplined.

If the board imposes discipline on a member, notice of the disciplinary action must be given by personal delivery or first-class mail within 15 days following the

Again, all of these provisions are for the protection of the member's (resident's) rights.

We must be aware that failure to pay fines in a timely manner may constitute an additional violation, followed by further disciplinary action. Although an association may lien a property for failure to pay assessments, no such course of action is allowed for collection of fines. Unpaid fines are collected through small-claims action.

It should also be noted that fines are not the only course of disciplinary action open to the board. A mem-

ber's access to the amenities tained in the documents we of the community, use of the swimming pool, recreation center or golf course may be also be limited or prohibited for a time.

Of course, in most situations, it is always in the best interests of residents to conform to the governing regulations which are conwere given in the "closing" process when we purchased our residence.

The regulations "run with the land," which means that they cannot be denied by an owner, or any subsequent owner. They can only be changed by a duly certified, legitimate vote of the




