For retail Lumber and Building Material Trade operating under the Code of Fair Competition for the Retail Lumber, Lumber Products, Building Materials and Building Specialties Industry and Builders Supply Industry, as provided for in Section one of Article VIII, effective February 15th, 1934.

- PAYMENTS**—All accounts are due at the time of delivery of merchandise.
- CASH DISCOUNT**—Unless otherwise provided Two (2) per cent of the net amount may be deducted if paid on or before the tenth (10) of month following date of purchase. Thereafter net. It is a violation of above Codes to grant discounts after the date for such allowance has passed. We shall be governed by the postal cancellation date on your remittance. If it is dated after the last date on which discount is allowable, we can not allow the discount.
- DELINQUENT ACCOUNTS**—All accounts shall be considered delinquent if not paid within sixty days (60) days from the first of the next succeeding month following delivery.
- INTEREST**—Interest shall be charged on all delinquent accounts at the rate of eight (8) per cent per annum.
- SALES TAX**—Prices and/or quotations do not include State Sales Tax or any other Sales Tax either State or Federal that may hereafter be imposed and said Tax shall be net and must be added to quotation and/or invoice before rendering. We are prohibited by the Code of Fair Competition for Retail Lumber, Lumber Products, Building Materials and Building Specialties Trade from altering these terms in any particular.
