Thanks for sharing the Echoing Green and New Voices funding leads; I researched both sources and found the Echoing Green Fellowships a good match for the project we/CSUCI and partners want to do. The Fellowship's are applied on line - 77% funded focus on environmental issues. I suggest Don explore interest of his students applying. The competition is strong, however not many Fellows are from the California - where the issue of protecting our Ocean Shores and LNG have become National concerns. I suggest at least 3 students apply.

New Voices is a Gulf Coast Project, administered by the "Academy for Educational Development." I would encourage you to look at **Echoing Green's** opportunity as the choices you make now regarding the establishment of a 501 c3 may make you ineligible for this type of grant. What is the total amount of your grant and how is it paid?

- Fellowships awarded to individuals are \$30,000 a year for two years, or a total of \$60,000. Fellowships awarded to partnerships are \$45,000 (total per project not per individual) for two years or a total of \$90,000.
- Echoing Green pays the grants in four equal installments over two years. The first payment is issued in early September 2007. Subsequent payments are made in March 08, September 08 and March 09.

The second opportunity I mentioned does not appear to match your interests right now, however their priorities c (2008).
