The meeting was called to order at 11:04 AM.


**I. Approval of Agenda and Minutes**

- \* Amy called for approval of the agenda for February 26, 2019. Amber motioned for approval; Frank seconded the motion. The agenda was unanimously approved, 8-Yes/0-No.
- \* Amy called for approval of the minutes of December 11, 2018. Amber motioned for approval; Bets seconded the motion. The minutes were approved 6-Yes/0-No/2-Abstentions.

**II. New Business**

- \* **CCR 02/19-01 CRU 100 Sea Training I (Deck)** – Modify course. Delete NAU 106 Merchant Mariner Fundamentals as a prerequisite. Add FF 200 Basic/Advanced Marine Firefighting as a prerequisite. Frank motioned for approval; Nader seconded the motion. The unanimous vote was 8-Yes/0-No
- \* **CCR 02/19-02 HUM 120 Introduction to Visual Arts** – New course. Colin answered questions about the new course. Bets motioned for approval; Frank seconded the motion. The vote was 7-Yes/0-No/1-Abstention.
- \* **Online Courses Discussion** – There was a concern that currently there isn't a way to approve an online course for only one semester. Amber believes that the Curriculum Committee should only decide if a course should or should not be taught online. Don stated that there should be a policy that requires students to have computers when they arrive at CMA. This issue would need to be taken to the Senate.
- \* **Course Enrollment Discussion** – Tony requested that, in the future, letters be provided by the Curriculum Committee and the Senate for IBL's curriculum re-design. The IBL Dept. plans to do comparisons with other campuses.
- \* Amy will write up her notes concerning the online courses discussion and send the write-up to committee members.
- \* The meeting was adjourned at 12:38 PM.
