Any reference to "County Clerk" or "Clerk" means "Registrar of Voters" in counties in which such office has been established.

#### An Analysis of:

### California's Presidential Primary Law

(Division 5, Chapter 1, Elections Code)

#### First Steps to Qualify Slate of Delegates

Notification to Secretary of State by state central committee chairman giving number of delegates from California to which party is entitled.

(Number of delegates are determined by national committee

on or before March 1, 1968.)

Formation of "organizing" committee. Notification of formation to Secretary of State signed by committee chairman and committee members.

No special form required.

#### Filing Dates with Secretary of State

March 1, 1968 (on or before), by chairman, state central committee.

March 6, 1968 (on or before), by organizing committee.

#### Suggested Filing Dates by Others with Secretary of State

March 4, 1968, and not later than March 11, 1968, by candidate for presidential nominee. (His endorsement of slate of delegates.)

March 4, 1968, and not later than March 11, 1968, by candi-

dates for delegates. (Their affidavits of candidacy.)

#### **Forms**

See Sections 6058, 6088 and 6111, Elections Code. Organizing committee usually contracts with printer specializing in election supplies for printing of necessary forms.

#### **Organizing Committee**

A committee composed of three or more registered electors of same party joined in proposing nomination of group or slate of candidates for delegates. Committee selects candidates for delegates, names alternates, appoints verification deputies to circulate nomination papers, appoints and supervises subcommittees, attends to printing of forms, filing (leaving) nomination papers with County Clerks, sees to filing of affidavits of candidates for delegates and, if a pledged group selected, arranges for endorsement of group by candidate for presidential nominee. Endorsement may be filed with Secretary of State direct or through committee.

Files statement with Secretary of State "on or before the first day for filing nomination papers" (March 6, 1968, being first day) containing committee name and names of its officers or members. Unnecessary to file names of subcommittees or mem-

bers or names of authorized representatives.

#### Slates or Groups of Delegates

No restriction as to number of slates on ballot of party, whether one or more pledged groups together with one or more unpledged groups.

#### **Selection of Delegates**

Organizing committee selects persons equal in number to which party is entitled, since law requires nomination paper

to contain names equal in number to be elected.

Advisable to send typewritten list to Secretary of State or send sample nomination paper when printed. Post office addresses unnecessary on list or nomination paper. Secretary of State obtains such addresses from individual affidavits of candidacy when preparing certified list for counties.

Section 6053, Elections Code, implies the necessity for a "territorial spread" of delegates so that, except as hereinafter ex-

plained, each congressional district shall be represented.

By law, the smallest number of delegates selected from any one congressional district "shall not be less than the integer of the quotient obtained by dividing the number of the names of candidates appearing upon the same nomination paper by the the total number of congressional districts of the State . . ."

A district is allowed no more than twice that integer.

Example: If a slate is to be composed of 180 delegates, divide that number by the number of congressional districts (38), giving a quotient of 4 and 14/19ths. The integer, or whole number, is 4.

Thus 4 is the minimum and 8 the maximum number to be

selected from any one district.

If a slate is to be composed of 86 delegates, the minimum number from any one district would be 2 with 4 as the maximum.

The organizing committee will find it necessary to "balance" the selection from some of the districts. The minimum number from each district would not be sufficient in the aggregate, while the maximum number from each district would result in a total exceeding the number to be elected.

However, and this is the exception heretofore mentioned, if a county contains two or more *entire* congressional districts, such as Los Angeles, San Francisco, Alameda and San Diego, the dele-

gates may be selected from the county at large.

Alternates are selected in the same manner as delegates.

#### **Candidate for Presidential Nominee**

No written declaration of intention or of candidacy necessary. His signed endorsement of slate of candidates pledged to his nomination is only requirement. Endorsement (no specified form) to be filed with Secretary of State before circulating group nomination papers. Any delay beyond March 6 curtails time for circulating papers.

#### **Candidate for Delegate**

Must be registered elector of party.

If a pledged candidate his affidavit of candidacy expresses preference for person as nominee of his party for President.

Candidates in an unpledged group omit preference statement in affidavit of candidacy form and fill in space for naming chairman of group.

All affidavits of particular group to be filed with Secretary of State, at one time if possible, before circulation of nomination

papers.

A candidate who files in more than one group is disqualified from running as a member of any group.

#### **Circulating Period: Nomination Papers**

March 6, 1968, through April 5, 1968.

Circulating prohibited until required filings have been made by organizing committee, candidates for delegates, and candidate for presidential nominee for pledged group.

(Secretary of State will notify County Clerk as to clearance date for reference by such official when examining signatures on

nomination papers.)

All signatures to be made in presence of verification deputy. Voter signer must be affiliated with that party and must not sign papers of more than one group.

Sections circulated in one county not to be transferred to

another county for additional signatures.

No requirement that papers be circulated in all counties or districts or in any specified number of counties or districts.

All sections to show precinct designation of signer before leaving with County Clerk for examination.

Sections must not contain "ditto" marks.

Papers must be signed by at least ½ of 1 percent and not more than 2 percent of vote constituting "basis of percentage."

#### **Basis of Percentage**

Vote cast for party's candidate for Governor at last preceding general election at which Governor was elected.

Democratic: Brown 2,749,174 Republican: Reagan 3,742,913

#### **Verification Deputies**

Must be voters, presumably of that party although law not explicit.

Deputy must be resident of county in which he circulates

nomination paper.

No restriction on number of verification deputies.

All deputies for that county may be named in one appointment form signed by organizing committee members or authorized representatives.

Notarization unnecessary.

Committee should notify County Clerk as to authorized representatives.

Appointments remain with County Clerk and must be filed at or before nomination papers are left for examination. Comply if additional deputies are appointed.

#### **Valid Signatures Required on Nomination Papers**

Democratic: 13,746 (minimum) to 54,984 (maximum). Republican: 18,715 (minimum) to 74,859 (maximum).

Secretary of State to notify organizing committee chairman when sufficient number received and that no more signatures will be accepted.

#### **Processing Signed Nomination Papers**

Signed and verified nomination papers delivered to organizing committee or authorized representatives.

Sections to be numbered in order, fastened together by county

-and precincted.

Leave with County Clerk of county in which circulated.

#### **Certification to Secretary of State**

After County Clerk has examined nomination papers he attaches his certificate giving number of names not marked "not sufficient" and transmits certified papers to Secretary of State.

This certificate to set forth names of candidates for delegates.

#### **Certification by Secretary of State**

Certificate prepared on behalf of each party containing name or names of candidates for presidential nominee, names and addresses of delegates by group pledged to that candidate, together with name of chairman of any unpledged group and names and addresses of candidates for delegates in such group.

#### Transmittal deadline to County Clerk: April 20, 1968.

#### **Presidential Primary Notice by County Clerk**

County Clerk publishes certified list of Secretary of State in a presidential primary notice, one time, under proper party designation, giving date of election and hours polls are open.

#### **Names on Primary Ballot**

Names of candidates for delegates do not appear on ballot. Voting portion of each party's ballot is in substantially following form:

For Delegates to National Convention	Vote for one group only
Candidates preferring JOHN P. MONROE	
Candidates preferring WILLIAM ADAMS	
Candidates expressing no preference John White (Chairman)	

#### **Manner of Arranging Names on Ballot**

Order by which names appear on ballot is determined by and is in same order group nomination papers are received and filed with Secretary of State. Group first qualifying receives top ballot spot, and so on.

#### Write-ins

No space is reserved for write-in votes on a Presidential primary ballot.

Reason: There would be no group of delegates pledged to carry that person's banner to national convention.

#### **Meeting of Delegates**

Elected delegates of a pledged delegation meet together and select chairman of group before leaving State for national convention.

#### Vacancy

When vacancy exists in office of delegate or alternate, chairman of delegation designates person to fill vacancy.

#### **Alternates**

Alternates may attend convention and discharge duties of delegates unable to attend convention.

Alternate shall not vote for delegate he represents when dele-

gate is occupying seat at convention.

#### **QUALIFICATIONS \***

United States Senator—Inhabitant of State, citizen of U.S. nine (9) years and thirty (30) years of age.

Art. I, Sec. 3, U.S. Constitution

Representative in Congress—Inhabitant of State, citizen of U.S. seven (7) years and twenty-five (25) years of age.

Art. I, Sec. 2, U.S. Constitution

State Senator—An elector, citizen of U.S. and resident of State three (3) years and of district one (1) year, next before (general) election.

Art. IV, Sec. 2, Constitution

Member of the Assembly-Same as for State Senator.
