ANNOUNCEMENTS

A group of students in Chemistry 203 are interested in submitting a proposal to the National Science Foundation for grant support under its SOS (Student-Originated Studies) Program. The objectives of the competitive program are: (1) to encourage college students to express in productive ways their concern for the environmental well-being of the nation; and (2) to provide support for groups of college students who can demonstrate their readiness to assume increased responsibility for their own educational development. Since SOS projects must be inter-disciplinary in nature, participation by students from all fields is invited. Personnel Information Notice - The Internal Revenue Service recently warned that many employees are having too little money withheld from their pay checks and may end up paying additional taxes next year. Part of the problem arose when IRS raised the standard deduction to 13% but put a \$1500 ceiling on that deduction. An additional problem was created when IRS held the maximum withholding rate to 24% for single persons and 25% for married persons, while actual tax rates run much higher. As a result of this, employees in the following categories are likely to have an insufficient amount withheld: all working couples; married employees with income over \$25,000, single employees with income over \$15,000, and employees with income over \$11,500 who claim the standard deduction or whose itemized deductions total less than 13% of their salaries. Faculty and staff wishing to have additional withholding can file a revised W-4 by contacting the Personnel Office, AD 107, ext. 2259.

Also worthy of note is the fact that employees who had two or more employers last year may have overlooked the possibility of a tax credit or refund due to excess FICA tax. The maximum FICA tax for the 1970 tax year was \$390, and if you did not claim the excess as a tax credit, you may get a refund by filing a form 1040X.
