The e-mail notes also demonstrate the over 40 hours per week of work - which all high quality Coordinators of any Cisco Regional Networking Academy must perform.

I am including Oxnard College Cisco Academy phone call bills (which I have paid from my part-time College salary). I am not including meeting notes and attendance of business and education technology conferences and community meeting because I do not want to overwhelm you.

I will copy the e-mail documents at Kinko's and will deliver them to you. I would appreciate an opportunity of talking to you and meeting you - I have not had the pleasure of meeting you. Perhaps Ed Lynch can join the meeting also. A good discussion of the duties and responsibilities of the Cisco Regional Coordinator position is very important at this time. Cisco is examining all Academies and will be re-certifying each, depending on compliance with specific Cisco Academy program requirements which Ed and I would like to share with you. I will be leaving Oxnard College sometime in the near future - I would like an opportunity to share some ideas about the position.
