



California Delegation

1968 Democratic
National Convention

Chicago • August 26-29, 1968

On March 16, Senator Robert F. Kennedy announced his candidacy for the Democratic Presidential nomination at a press conference in Washington. Two hours later, a number of prominent California Democrats joined with me to announce our support of his candidacy. That was the genesis of the 1968 California Democratic Delegation.

The next step was to form a broadly-based delegation of Democratic leaders from throughout the state to conduct the Kennedy campaign in California and to represent our candidate at the national convention. This delegation was qualified for the June 4 primary ballot by means of a massive volunteer signature-gathering effort.

The ensuing two months saw a hard-fought and exciting campaign involving our delegation, a delegation pledged to Senator Eugene McCarthy and a third delegation headed by California Attorney General Thomas C. Lynch.

Election Day brought victory to our candidate and to his cause. The final results showed 1,472,166 votes for Kennedy, 1,329,301 for McCarthy and 380,286 for Lynch. As we had expected, the margin of victory was supplied by Los Angeles County.

But while the ballots were being counted, jubilation turned to unbelievable tragedy as an assassin's bullets struck down Senator Kennedy and deprived the nation of its most gifted young leader. The delegation had won the right to go to Chicago, but it was bereft with the loss of its standard-bearer.

The delegation met in Los Angeles on June 15 and voted to remain uncommitted to any candidate until convention-time. This decision was reaffirmed at our caucus in Sacramento on August 10. The delegation further pledged to fight for a Democratic platform embodying those principles for which Senator Kennedy gave his life and to dedicate itself to "the vision he held for this nation". We have come to Chicago to carry out those commitments.
