MRS. ROOSEVELT ENDORSES STEVENSON!

Mrs. Franklin D. Roosevelt announced her enthusiastic support of Adlai E. Stevenson last week. Mrs. Roosevelt said: "I am about to exercise the prerogatives of a woman and change my mind. Up to this time I have been firmly saying I would come out for no-one as the Democratic nominee for the Presidency until the Convention and now I am going to join some of my friends in a plea to the Convention delegates to nominate as the standard-bearer of the Democratic Party Adlai E. Stevenson."

Mrs. Roosevelt added: "I think he's a candidate, whether he says so or not. It's obvious he will serve...and a great many people are asking him to...As a Democrat I know that this campaign is not going to be easy to win...Therefore, we as Democrats must nominate the strongest possible ticket and there is no question in my mind that this ticket is a Stevenson-Kennedy ticket."

Mrs. Roosevelt stated that there was "a growing sense on the part of the people that Adlai E. Stevenson has more wisdom, more experience and more maturity than any other candidate. In addition he has the humility, courage and flexibility of mind which makes it possible for a great man to recognize a mistake if he makes one and turn to another solution."

"The November victory seems to me of paramount importance to our nation. Our people need restored confidence in their own judgment and a sense of being trusted because they are informed. Above all the world needs a man in the White House whom they respect for his good judgment and resourcefulness."

"I believe only Adlai E. Stevenson can give them this assurance."

CAN STEVENSON WIN?

The influential ST. LOUIS POST DISPATCH answered this question with finality, and in a highly unusual move gave Mr. Stevenson a ringing endorsement.

"Mr. Stevenson's superior qualifications are, in fact, generally conceded among Democrats. The principal argument against him is that, because he lost to President Eisenhower twice, he could not win against another opponent. This is a myth of expediency which has no basis in history or logic...It is now quite evident that no Democrat could have prevailed over the personal popularity of Dwight Eisenhower in 1952 and 1956. Authoritative studies, such as the recent one by Louis H. Bean which is being circulated by Senator Monroney, suggest that Mr. Stevenson lost, not because of any voter dissatisfaction with him, but because of the impressive stature of a military hero who seemed above politics."

"On the basis of the alternatives and conditions today, our choice for the Democratic nomination is Adlai E. Stevenson."

**MAGAZINE PUBLISHERS NAME STEVENSON
STRONGEST DEMOCRAT**

A poll of 323 top magazine men conducted at the Magazine Publishers Association Convention named Adlai Stevenson as the Democrats' "strongest vote getter." Stevenson received 52% of the votes, Kennedy 27%, with the remainder being divided between Symington and others. Stevenson was also picked as the candidate most likely to be nominated. Kennedy was named as the best choice for vice-president.

This poll, and the labor leader and newspaper men's polls reported in last week's newsletter indicate the views of individuals who have their fingers on the public pulse. They all choose Stevenson 2 to 1.

LABOR COMMITTEE
FOR STEVENSON FORMED

Frank McAllister, Director of Labor Education at Roosevelt University announced the formation of an Illinois Labor Committee to draft Stevenson for President. The list of members includes two vice presidents of the state AFL-CIO and two executive Board Members of the Chicago Federation of Labor. Mr. McAllister stated: "It is the largest group to come forward in support of any Presidential candidate -- and we expect more officials to announce shortly."

McAllister recently conducted a poll of the 161 top labor officials of all the international unions affiliated with the AFL-CIO and the United Mine Workers which showed that these leaders preferred Stevenson 2-1 over any other possible Presidential candidate. "These Illinois leaders reflect here at home what the poll showed to be true throughout the country: Adlai Stevenson is the overwhelming choice of the working people," McAllister said. "He must be nominated." Among the Illinois labor leaders supporting Stevenson are:
