First I will tell you a little about me and then a few of the ideas I have about current issues in this school district.

I worked as a social worker for the American Red Cross at Corona Naval Hospital from 1945 till 1946. I have been a member of the Camarillo State Hospital Board of Trustees since 1959. I was a member of the 1958 Ventura County Grand Jury and chairman of its Tax Committee. I was

a member of the Oxnard City Planning Commission for five years and the vice-chairman. I, also, have been involved in numerous civic and political organizations and activities.

I am seeking election to the Oxnard Union High School District Board of Trustees because of my strong belief in public schools. The goal of education should be to help every person achieve as much as he is able, thereby preparing him to participate in a productive, meaningful life in a free society. I entirely agree with the goals of education as set forth in the adopted philosophy of the district Board.

Our high schools are good now but we cannot coast. It will take time and effort to keep ahead of the problems in this fastest growing area

I have the time and the interest to devote to meeting the needs of our continually improving and growing school system.

Many issues such as teachers' salaries are so complex and so basic to the entire school program they cannot be solved with routine formulas. They require extensive study with year-round Board participation and direction. The 3 goals set forth by the salary committee headed by Mr. Manzer are essential to achieve. The attracting and retaining of highly qualified

teachers is the most important problem our rapidly growing district faces. How successful we are in this effort will determine the reputation and quality of our schools for years to come.

Each of the current important issues that the Board must face will require much time and study. Oxnard Union High School Board should be offering leadership in unification studies because it is the only group that represents the entire district being considered. The Board has a responsibility to see that the best plan is presented to the voters. I favor unification theoretically but I am well aware of the hazards unification can present to the high schools. I cannot tell you at this time what plan I would favor because I have only been cramming on this issue one month. Even during this month I have accumulated a long list of pros and cons on each of the³/proposals being considered. I still need the answers to many more questions.

Oversimplifications and use of labels is unwise and again study is vital in viewing programs involving federal aid. I think we should accept federal aid for some of our programs instead of insisting that local property owners pay for ^{all} of them. There is no reason why one segment of our population should pay

the ~~bill~~^{cost of} for education when all segments benefit. 30 years ago the State Sales Tax was levied to share the cost of education on a 50-50 basis with the local property owner. Gradually the local property owner has increased his share ^{to} 75% -- no wonder there has been a howl from the property owner. Federal aid does have the advantage of relieving the local property owner and sharing the cost with those who have other types of financial holdings.

Expansion of our vocational programs within each existing school is preferable to a separate vocational school and, is more readily adjustable to changing job opportunities.
