YNCG Seeks Subjects For Research Project

The assessment of general intelligence constitutes an essential part of psycho-educational, clinical and vocational evaluations. Two versions used, a long and a short form of testing on head injured or demented individuals, suggest that psychometric (the measurement of mental processes) properties of the tests might not be as comparable as it is estimated by the test authors. This could lead to inferior patient care.

This new study will address this issue by giving both forms of the test to different normal persons and those with dementias, different head injuries, etc. This will allow the assessment properties of the tests, the entire individuals, as well as impaired persons.

sures commonly used in clinical practice to estimate levels of intellectual functions before head injuries or mental illnesses. In most clinical situations, these factors are not known. It is important to have an estimate of the patients functional level prior to the present condition to predict prognosis for recovery and rehabilitation strategies.

Maura Mitrushina, PhD, with a diploma in clinical neuropsychology and a professor at CSUN and UCLA, will supervise testing. Maura, with the help of Y.N.C.G., has done previous testing of this nature in Leisure Village over the last 14 years.

The testing will be done by appointment at your home, at your convenience, and last about two hours. Within two months after testing, Maura will give each participant a written feedback on his/her functional strengths and weaknesses, and on possible effects of emotional factors on the participant's mental status.

It should be noted that in a clinical setting, the cost of such an in-depth evaluation, with feedback report, would cost about \$1,000.

Openness and Communication

One of the themes which came up over and over at the Candidates' Night was the need for "openness" and "communication" from the Board to all residents. The candidates' attitude was that the previous board operated too much "in secret." The Board did not answer questions their constituents wanted information about.

Well, now the charge of operating in secrecy is heard about THIS Board, the one, who when appearing as candidates, promised an atmosphere of more communication and openness. These campaign promises are no longer heard. Have they been forgotten so soon?

Some of the newly elected Board members must have finally read the real rules.

The Village has its Rules and Regulations and CC&Rs to follow, as well as the state's Davis-Stirling act and some parts of the state Civil Code. That's a lot of material which states how condos and Planned Unit Developments (LV is a PUD) are to be run. Apparently the newly-elected Board members are reading these documents, some for the first time.

Last term the Board's response was a brusque "We can't talk (publicly) about that" which concerned matters they felt they were directed by law to keep private. Talk about these sensitive matters is permitted only in executive sessions, but not at public or social events.

NOW the Board members are more familiar with the laws. They sound almost like the last Board, except that the few clipped words of that year are answered by this Board, with a torrent of words, still saying very little. Often "openness" is not possible.

By voting at the general election in June, homeowners gave the Board authority to act for them and by law the Board is still bound by legal restraints. Some candidates promised to give out information that they find they should not openly discuss. They know that NOW. Are they keeping some skeletons in the closet?

For example, one absentee owner sued the Association in Small Claims court in Los Angeles. This was impossible to keep secret after 22 villagers were subpoenaed. Those who were served were shown the entire list! They talked to each other and even joked about renting a bus to travel en masse to Los Angeles to meet the 8 a.m. court date. The case was dismissed—for the third time. These nuisance suits by residents cost the Association money—cost US money. This one also cost us a "reorganization" of board members, citing a "leak." Is this another skeleton?

4. She and her committee provided entertainment and furnished refreshments for about 200 new move-ins.

About 250 people attended each of the two parties. The programs took enormous effort and time by all participants and each was a tremendous success.

Barbara asked our Board to establish the 40 member "Welcome Committee" as a new LV committee. This request was denied and the "Welcome Committee" remained a sub-committee to the Ed. and Rec. At this point most of the "Welcome Committee" volunteers resigned and the committee disbanded.

We find it very interesting that our Board has now reinstated a "Wel-

come Committee" as a standing committee, no longer a subcommittee to the Ed & Rec, and is looking for new recruits.

Barbara Simon's "Welcome Committee" program was a huge success. Barbara has set a precedent for a new move-in format. We believe Barbara and the many volunteers who worked so hard to establish the "Welcome Committee" should be acknowledged.

**Duties of Two
LV Committees
Are Clarified**

Two very important standing committees of the Leisure Village Association provide consultation and approval or disapproval to homeowners' planning to make structural or landscaping changes to their properties. The Architectural Committee and the Landscape Committee are dedicated to maintaining and improving Village appearance and standards.

Leisure Village was developed as a Planned Senior citizen Community with its original and succeeding covenants, conditions and restrictions so the real property is controlled and administered by the Association as a single integrated project as stated in the 1991 revision of the CC&Rs.

Under the astute leadership of Manny Abbate, the Architecture committee reviews requests for structural changes to assure the proposed alterations are in accord with LVA and city requirements and specifications. Recent changes in the exterior color scheme and use of slumpstone patio walls are the results of Committee work.

With Don Hamilton as Chair, the Landscape Committee is the grounds and planting partner of Architecture. Both committees are concerned about the "aging" of the Village. As Y2K approaches, all residences are in the 14-25 year age bracket. Roofs, walls, and fences are one thing—gardens, shrubs, trees, and planter beds another. Residents not familiar with the sometimes confusing planter-bed maintenance rules, Rules and Regulations Section VII, 7.03, should review them as found in the LV Telephone Directory. Returning red-stake planter beds to full maintenance by LVA might be of inter-



Emergency Services Organization

In light of all of the earthquake news heard lately, ESO feels it is worthwhile to use this space to repeat information included in an article on earthquake safety published September 27, 1999 in the Camarillo Star.

- **Bolt all wall units, bookcases and other tall pieces of furniture to the wall studs with appropriate braces and fasteners.**
- **Make sure water heater is braced in accordance with current standards.**
- **Use common sense when arranging furniture.** Never put a sofa or a bed directly under a window. Never hang a mirror, heavy picture or other hazardous item directly above a bed or sitting area. When arranging art objects or books, place heavier items on lower shelves, especially with small children around.
- If it is impossible to relocate a bed or sofa so that it is not under a window, **install clear safety film on the glass to keep it from shattering.** Most window companies can do this.
- **Install quake-safe latches* on kitchen cabinets to protect dishes and glassware from flying out during a quake.**
- **Use industrial hook-and-loop fasteners** to anchor TV sets, computers and other heavy items.
- **Apply "Quake Wax"** to protect ceramic and glass art objects.
- **Keep flashlights in several areas at home at all times.** Replace the batteries once a year.
- **Install plug-in emergency escape lights** that automatically turn on when the power goes out.
- **Keep a crowbar or some other prying tool in the bedroom to open stuck doors after a tremor.**
- **Keep at least a five-day supply of emergency food, water, first aid products and medications on hand at all time.** Replace the food and water at least once a year.
- **Keep a battery-operated radio or television set on hand for media updates after an earthquake.**

Items are available at most home centers.

ESO has also suggested installing a "hard-line" (not cordless) telephone in the bedroom since cordless phones are inoperable when the power is out.

As has been said before, sometimes preparation makes the difference between victim and survivor.

OPEN HOUSE HELD AT CHANNEL ISLANDS STATE UNIVERSITY

In September a gala ribbon-cutting ceremony was held at California State University Channel Islands to celebrate its official opening. Wielding over-size scissors to actually cut a large red ribbon were: Handel Evans, President of CSUCI; Dr. Lunann Kennedy, President of CSU Northridge; and Kathy Long, Ventura County Supervisor. The program was chaired by Steven Lefevre, Director of the University; and included brief comments by the dignitaries about the history, progress and future plans of the new school.

Approximately one month ago, the students and faculty from the CSU Northridge off-campus center in Ventura County were all transferred to the new CSU campus, thereby beginning the building of its academic foundation. These students will be able to complete majors in business, communication, humanities, social sciences and nursing as well as a number of graduate programs.

In the fall of 2002, the first entering freshman class will be admitted. By that time, a total enrollment of approximately 3600 students is expected. It is predicted that, over time, that number will gradually reach a maximum of 15,000 students being served on campus, either full or part-time, and also via distance learning.

The current students, faculty and support staff are using two newly renovated buildings, the Bell Tower and the Technology Center. The Bell Tower Building, which is the largest and most centrally located, contains classrooms, administrative offices, faculty offices, student lounge, bookstore and food commissary, and other support services.

The adjacent Technology Building houses several large fully equipped computer centers, and also the temporary library. The permanent university library is scheduled to open in fall 2000, and it is being made possible by a million dollar grant from a local benefactor.

All of the offices and classrooms are spacious, and fully furnished and equipped. These two buildings will serve as the "heart" of the school; in time, with added enrollment and continuing allocation of funds, other buildings will be renovated and put into use.

CSUCI enjoys the advantages of a beautiful site, attractive architecture, spacious grounds, state-of-the-art technology and the enthusiasm of all who are involved. Given all this, it is predicted that this newest 23d campus will become one of the "gems" of the state university system.

Monthly meetings are held on the first Wednesday of the month at 12:30 p.m. in the Ceramic Room. The next meeting is November 3.



