

BACHELOR OF SCIENCE DEGREE

For the bachelor of science degree, a minimum of 124 to 132 semester units depending on the major field must be completed. The general degree requirement (page 68), a general education pattern (page 70), and one major must be satisfactorily completed. Courses used to meet the general education requirement may not apply on the major. If a second major is taken concurrently or consecutive courses acceptable for satisfaction of general education requirements for the first major may be used to satisfy second major requirements.

The master of arts curricula are designed to improve professional competence in educational service, to develop ability for continued self-directed study in a field of specialization, to afford graduate students an opportunity to broaden cultural background, develop personal and social responsibility, and prepare for community leadership. The master of science degree curricula are designed to improve competence in a chosen occupation other than teaching and to develop ability for continued self-directed study. For details of specific curricula see the department statements and the *Graduate Bulletin*.

GENERAL REGULATIONS

Applicants for the master of arts and master of science degrees are admitted to graduate standing, programmed, and advanced to candidacy under identical policies except for the field experience for the master of science degree, some differences in thesis requirements, and differences in curricula.

ADMISSION TO GRADUATE STANDING

Admission standards are stated in the *California Administrative Code*, Title 5, Education, Section 932, which provides uniform admission regulations for all California state colleges as follows:

932. Admission to Graduate Standing. For admission to graduate standing in a state college, a student shall have completed a four-year college course with an acceptable baccalaureate degree from an accredited institution or must have completed equivalent training as determined by the appropriate state college authorities.

To apply graduate study toward a master's degree, a student must have been admitted to full graduate standing at Fresno State College.

1. A graduate of Fresno State College who has taken no subsequent collegiate work elsewhere may be admitted to full graduate standing upon the filing of two copies of the application for graduate standing.
2. A graduate of another accredited institution, or a Fresno State College graduate who has subsequently attended another institution, may be admitted to full graduate standing upon the filing of the application in duplicate and two copies of official transcripts showing the highest degree earned and good standing in all work taken subsequent to the degree.
