

Thank you for contacting us about Quaker Chewy Granola Bars. We are sorry for any concern this situation may have caused you.

The reputation of our products for quality, safety, value and goodness is of the utmost importance to us. Please be assured that we view your concerns seriously.

All packaging includes a warning under the ingredient listing that the product "may contain traces of peanuts." Only one variety contains added peanut butter. The warning does not mean that peanuts are added to other varieties; there have been no product reformulations. Federal laws regarding the use and labeling of all ingredients are followed carefully.

Between the run of one variety and the beginning of another, the production line is shut down and thoroughly cleaned. However, it is possible that microscopic traces of peanut may remain on the production line. Because we realize the seriousnass of peanut allergy, and because we are concerned about the health of our consumers, we felt it was our obligation to warn consumers of the possibility of trace amounts of peanuts.

First and most importantly, we are sure glad you enjoyed the "Dunkin' Donuts Garden Veggie Delicious Cream Cheese Spread with garden vegetables and preservatives" purchased recently at a local Dunkin' Donuts! While it may be a bit cocky to use the descriptor "delicious" it does clearly tell the consumer about their upcoming gastronomic experience. After comparing the Dunkin' product to others, it was an easy choice for all of us. "Preservative" is a disclaimer and also a necessary enhancer of shelf life for those little quirks in life like temperature abuse, consumer mishandling, and all that other "stuff." "Spread" and "Cream Cheese" are both pretty obvious as you so well stated in your entertaining letter, so that leaves us with that term "garden vegetables."

Okay, I'll fess up, there are not "victory gardens" out there painstakingly growing all those delicious carrots, bell peppers, cucumbers, and onions for our creamery. In the early stages of development, we did consider the idea, but when told of the voracious appetite New Englanders like you and your co-workers would eventually have for all these cheeses, it was decided that we would have to turn our attention to those big factory farms out there in the Midwest and West Coast.

Just a bit of a serious note, though, the veggies do come from a variety of farm sources and are packed fresh in a brine until they are prepared by our employees for incorporation into the finished cheese, added at about 160°F.


