a. Provost Zelezny

Commended the students and events at Arts in Motion and the recent trip to Washington D.C.

b. Senator Ram (University-wide)

Inquired as to whether the detailed recruitment requirements were used for MPPs as well. Additional comments by committee related that some workload was shifted from Academic Personnel to departments, legacy verbiage that is a carryover from the previous administration, a need for a more efficient, streamlined system, and clarity in where responsibilities are allocated. responded that it is a good time to inquire due to the search for a new AVP for Faculty Affairs and the possibility of developing a small task force on streamlining the process.
