BOARD COMMITTEE

Commissioners Howard and Hurd volunteered to Co-Chair the Herstory Photo and Bio Booklet Committee. Commissioner Howard indicated that it was her dream to put the VCCW herstory together with names of all women involved over the years. Commissioner Lawrence volunteered to develop and contribute the photos and to collect and edit bios to be included. Commissioner Morgan-Durisseau will also retain copies of the bios to be used for publicity and grant writing. By general consent the Herstory Photo and Bio Booklet project was approved.

Commissioner Goodrow reported that she and Commissioner Barron are seeking recommendations for Supervisor Bennett for his representative in District 1. Commissioners Lawrence and Riggan volunteered to draft an outline (Talking Points for consistency) for Commissioners to use in meeting with their Supervisors. Commissioners agreed to contributed to VCCW to share the expense for flowers and to make a contribution in Commissioner Fargo's name.

COMMISSION VACANCIES

Commissioners discussed the VCHSA MOU. Commissioner Pallant will be asked to investigate its status. Commissioners also expressed the pride they have for Commissioner Pallant and her run for public office.

VCHSA MOU

Commissioner Goodrow reported that the Women's Forum Steering Committee must move forward. The next step is the Follow-up, Follow-Through Luncheon. Issues holding the concern of Commissioners on this matter have been the Brown Act and Forum/Collaborative Guidelines. Commissioner Lawrence said that the outline will facilitate the development of the guidelines and that they will be developed through a logical collaborative progression and not a dictation from VCCW.

COLLABORATIVE **GUIDELINES**

Commissioner Morgan-Durisseau reported on her research on the Brown Act and the training offered by Ventura County in a classroom and on the internet. She recommended that Commissioners attend the Ethics and Brown Act Training and she felt that this knowledge should be used to draft the Communications (Email) Guidelines, the Advisory Board and the Collaboration Guidelines. Commissioners Barron and Goodrow agreed to ask Supervisor Bennett's assistance in obtaining Brown Act instructions specifically for VCCW from County Counsel.

BROWN ACT TRAINING

Commissioners Goodrow and Morgan-Durisseau reported how very informative the ACCW quarterly meeting on May 9 at the Manhattan Country Club was. The next ACCW meeting will be August 22 in Sacramento and then a retreat at Asilimar on November 8 & 9. Commissioner Goodrow will serve on their Nominating Committee and Commissioner Morgan-Durisseau will serve on their Website Committee. Both women said that the ACCW helped them to better understand their roles on the VCCW and the importance of Commissioners; "It starts with us!" They said. And we must be willing to pay our own way.
