The question of how Commissions for Women can be involved in the working with the community on the issue of the workforce growing older. Older women face many challenges in the workplace including age disctimiation, lack of flexible hours and the need for updated technology skills. Older workers are defined by the EDD 45-55years of age. There is a need to use the self sufficiency standard not the poverty standard. The Workforce Investment Panel was suggested as a group to work with toward self sufficiency standard. 80% of women become impovished when there husband dies. Other groups to work with are Area Agency on Aging and One Stop Centers and the Women's Bureau There is no Affirmative Action Plan for Older Workers Suggested that Commission look at county hiring practice if there is one.
