MERITORIOUS PERFORMANCE AND PROFESSIONAL PROMISE AWARDS

The Faculty Contract offers a special incentive program to acknowledge meritorious performance and professional promise. Awards for Meritorious Performance and Professional Promise (MPPP) are given annually in recognition of recent accomplishments and as an incentive for continued excellence in the areas of teaching, coaching, librarianship, scholarly and professional attainment, and service to the university.

CSUB has been allocated 29 awards for 1989/90, which will be apportioned to academic units on the basis of full-time equivalent faculty (FTEF). Each award is in the amount of \$2,500, and nominations are now being accepted.

Eligibility

All faculty unit employees are eligible for consideration. This includes all full and part-time faculty, librarians, and coaches, regardless of length of service. Individuals who received an award in the previous year are also eligible, however, the award in the second year must be based on meritorious performance since the previous year's award.

Criteria

A complete outline of criteria may be found in the CSUB Handbook, Section 312.7. In forwarding names to the President, the selection committees consider the areas of superior teaching, scholarly and professional attainment, outstanding service to the university community, outstanding performance in the discharge of the duties and responsibilities of a librarian, and outstanding performance in the discharge of the duties and responsibilities of a coach.

The Calendar on the reverse side announces the timeline for administering the 1989/90 awards. Nominations are now being accepted and should be submitted to the appropriate MPPP unit committees by January 8, 1990.

**January 8, 1990
Monday**

Deadline for nominations to the school, athletic, or library MPPP Award Committee.

**January 29, 1990
Monday**

Deadline for submission of completed applications to the chair of the school, athletic, or library MPPP Award Committee.

**February 14, 1990
Wednesday**

Deadline for submission of MPPP Award Committees' recommendations to the school dean, athletic director, and/or library director.

**February 28, 1990
Wednesday**

Deadline for submission of dean's or director's review and recommendation to the President.

**March 16, 1990
Friday**

Deadline for President's referral of the review file to the Universitywide Faculty Honors and Awards Committee (Applies only in cases where the dean or director has refused to accept an affirmative recommendation from the MPPP Award Committee.)

**March 23, 1990
Friday**

Deadline for submission of the final report and recommendation of the Universitywide Faculty Honors and Awards Committee to the President. (Applies only in cases where the dean or director has refused to accept an affirmative recommendation from the MPPP Award Committee.)

**April 13, 1990
Friday**

Deadline for the President's decision on recommendations received from the Faculty Honors and Awards Committee. (Applies only in cases where the dean or director has refused to accept an affirmative recommendation from the MPPP Award Committee.)
