## **Assembly Democrats Kick Off Election Year**

A turn-away crowd of nearly one thousand people packed the Hollywood Palladium at the Assembly Democratic Caucus dinner featuring Washington Senator Henry M. Jackson.

"The Democratic Caucus is also known as the

Majority Caucus . . . and we want to keep it that way," said Majority Leader Jack R. Fenton. "That's why we're all here.

"Our goal for the Assembly is 80 Democrats, but we might settle for 54," Fenton said during brief remarks. "That's a working majority no matter who's in the Governor's office."

Jackson, a Democrat from Washington state, is the leading U.S. Senate expert on the fuel

crisis. He accused the White House and the oil industry of combining to block efforts to ease the gasoline and fuel shortage in what he called the "biggest lobbying operation I have watched in many years."

The Senator, who was introduced by state women's chairperson Shirley Goldinger, heads a Senate investigating committee empowered to find out why the government and the oil companies have not worked out a more even distribution of gasoline sup-

plies.

"It is perfectly obvious that people are mad, people are bitter about having to line up in long lines in order to get gas," Jackson said.






(L. to R.) U.S. Senator Henry Jackson, Majority Leader Jack Fenton, Speaker Bob Moretti.

#### **A Switch In Time**

Ronald Reagan's more generous critics have been saying for years that he is a habitual self-contradictor.

But the detractors usually have to wait at least a few months to catch him doubling back on one of his statements.

It took several years, for instance, for the Governor to switch his position on state withholding tax from solidly

opposed to desperately in favor.

The most recent turnabout took less than a week and a half, however. On February 15, the Governor issued a statemen which said, in part, "OUR (GASOLINE) SITUATION HERE IN CALIFORNIA THROUGH THE NEXT FEW MONTHS IS NOT AN EMERGENCY."

Ten days later he announced a plan by which any California county could require motorists to buy gas on the basis of

odd-even licence plate numbers.

This time he said he was using his disaster powers to implement the proposal where requested adding, "WE WILL LIFT IT AT ANY TIME THE SUPERVISORS (FROM THE VARIOUS CALIFORNIA COUNTIES USING THE PLAN) SAY THE EMERGENCY HAS ENDED."

#### To Tell The Truth

## NINE ASSEMBLYMEN WILL SEEK OTHER OFFICES

Nine incumbent Democratic Assemblymen have indicated

they will not return to the Assembly next year.

Three members, Alex P. Garcia, of the 40th Assembly District in Los Angeles; John F. Dunlap, of the 5th Assembly District in Napa and Solano Counties; and Frank Holoman, of the 65th Assembly District in Los Angeles, will run for State Senate.

John Burton, of the 20th Assembly District in San Francisco, and Henry Waxman, of the 61st Assembly District in Los Angeles, have announced their intention to run for Congress.

Kenneth Cory, now representing the 69th Assembly District in Orange County, will be a candidate for State Controller, while March K. Fong, of the 15th Assembly District in Oakland, and Walter Karabian, from Los Angeles' 45th Assembly District, both announced for Secretary of State.

Bob Moretti, 42nd Assembly District in Los Angeles, has announced for Governor. Harvey Johnson, of the 58th Assem-

bly District in Los Angeles County, will retire.

## JOHNSON BOWS OUT AFTER 12 YEARS IN ASSEMBLY

Harvey Johnson, the El Monte Democrat who has represented the San Gabriel Valley's 58th Assembly District since 1962, will retire from the Legislature at the end of this session.

Assemblyman Johnson was born in Kansas and came to California in 1926. He graduated from Los Angeles College of Law in 1936. He is a past president of the Pomona Bar

Association and is still an active member of the Bar.

Prior to his first election to the Legislature in 1962, Mr. Johnson was a veteran political campaigner. He served as a member of the 1958 Brown-for-Governor campaign committee; was active in the 1960 Kennedy-for-President campaign; and was a member of the Finance Committees for Clair Engle for U.S. Senate and Richard Richards for State Senate. He is a member of the El Monte Democratic Club and was a delegate to the Congressional Conventions in both 1958 and 1960.

## **NOBEL PRIZE WINNERS HEADLINE ENERGY SYMPOSIUM**

The energy crisis remains the toughest problem facing the State Assembly, and legislators find it the single most worrisome problem talked about by constituents.

As long ago as 1972, the Assembly participated in getting the Rand Corporation to make a study of the energy crisis and come up with some solutions.

This study was the basis of legislation now coming out of the Assembly Subcommittee on State Electrical Energy Policy. More legislation based on this important study will be forthcoming.

In order to get additional factual, scientific information on which to develop legislation, Assembly Speaker Bob Moretti brought together the most prestigious symposium on energy yet held in California.

It met March 5, 1974, in the Assembly Chambers in Sacramento. The keynote speaker was Nobel Prize winner Dr. Glenn T. Seaborg, former Chancellor of the University of California and former Chairman of the Atomic Energy Commission.

Also speaking was another Nobel Prize winner, Dr. Melvin Calvin, whose pioneering work in research in photosynthesis was the basis for his talk on the uses of solar energy.

One of the causes of the present "energy crisis" was the failure to look ahead for alternative sources of energy. The symposium brought to the legislators and staff a dramatic description of the many avenues open to us in implementing energy policies.

The Assembly is presently considering a series of bills designed to put more flexibility and competition into the retail gasoline station business, by eliminating some of the restrictive franchise clauses required by the major oil companies before a dealer can purchase gasoline from them.

A number of bills have also been proposed to facilitate the financing and development of new and existing mass transit systems.

"We are no longer limited to the traditional uses and sources of energy," said Speaker Moretti. "The Assembly now has factual information which we can use to develop a wide range of responses to the energy crisis. The bills which we develop this year can lead the way to a much better use of our energy resources in the future."

### New Committee To Study Plight Of Gas Stations

Assembly Speaker Bob Moretti has created an Assembly Select Committee which could prevent the extinction of small, independent gasoline dealers in California.

The panel's full title is Select Committee on Service Station Franchising and Petroleum Product Practices. Its first responsibility will be to investigate the relationship between major oil companies and independent gasoline station dealers.

"It is important for the public to realize that the real culprit in the ever increasing price of gasoline is not the man at the pump," Moretti says. "Up until now, with the exception of a single cent, all increases in the cost of gasoline have gone to the oil companies."

According to figures gathered by the Speaker's office, when regular gasoline cost the consumer 38.9 cents per gallon, the independent dealers got 7.6 cents and the oil companies got 18.4 cents. Now that gas costs 49.2 cents per gallon, the oil companies get 27.6 cents but the independent dealer's increase is only one penny, to 8.6 cents.

The committee, which will be chaired by Assembly Majority Leader Jack R. Fenton, will investigate the extent and nature of these unfair practices. Other committee members include Assemblyman Leroy Greene (D-Sacramento), Joe A. Gonsalves (D-Norwalk) and Joseph B. Montoya (D-La Puente).
