CCR 03/10-05 MGT 340 Global Logistics – Drop BUS 120 as a prerequisite and add MTH 100.

CCR 03/10-06 BUS 301 International Business II – Drop BUS 120, BUS 200, and BUS 300 as prerequisites and add Senior Class Standing or Chair Approval as a prerequisite.

CCR 03/10-07 TRA 405 Import and Export Regulations – Drop MGT 340 and TRA 300 as prerequisites. BUS 300 will become the sole prerequisite.


- ~ The meeting was called to order by Tom Nordenholz at 12:05 PM.
- ~ Tom called for approval of the minutes of March 3, 2010. Charlie motioned that the minutes be approved; Chris seconded the motion. The minutes were unanimously approved, 7-Yes/0-No.
- ~ **CCR 03/10-04 MGT 205 Organizational Behavior and Labor Relations** – Drop MGT 100 as a prerequisite.
- ~ **CCR 03/10-05 MGT 340 Global Logistics** – Drop BUS 120 as a prerequisite and add MTH 100.
- ~ **CCR 03/10-06 BUS 301 International Business II** – Drop BUS 120, BUS 200, and BUS 300 as prerequisites and add “Senior Class Standing or Chair Approval” as a prerequisite.
- ~ **CCR 03/10-07 TRA 405 Import and Export Regulations** – Drop MGT 340 and TRA 300 as prerequisites. BUS 300 will become the sole prerequisite.
- ~ **CCR 03/10-08 MGT 305 Information Systems Management** – Change prerequisite to read “COM 100 or equivalent course.”
- ~ **CCR 03/10-09 ECO 305 Managerial Economics** – Drop BUS 101, BUS 310, ECO 101, and MTH 107 as prerequisites. ECO 100 will become the sole prerequisite.
- ~ **CCR 03/10-10 MGT 410 Quantitative Managerial Methods** – Drop MGT 305 as a prerequisite.
- ~ **CCR 03/10-11 MGT 400 Strategic Management** – Drop approval of instructor and department chair, BUS 200, MGT 205, and MTH 107. Change prerequisite to read “Senior Class Standing.”

~ **CCR 03/10-12 MGT 420 Supply Chain Management** – Drop MGT 340 as a prerequisite. Chris was asked why no prerequisites were needed for MGT 420 after dropping MGT 340 as a prerequisite. Freshmen would then be allowed to register for the class, which isn't what the MPM department wants. Chris decided to add "Junior Class Standing" as a prerequisite.

Mitch motioned for the approval of all nine CCRs, with the knowledge that "Junior Class Standing" will be added as a prerequisite to MGT 420 on CCR 03/10-12; Charlie seconded the motion. The unanimous vote was 7-Yes/0-No.
