

Leisure Village Assets - Ed and Pat Holly

Ed and Pat Holly are the driving forces behind Leisure Village food Distribution, the organization that supplies food to the needy of Leisure Village. They have headed the program since 1983. At present there are 9 clients, but the number has been as high as 15.

Ed says that widows are usually the ones in this situation. Often when their husbands die the pension dies with them, leaving the women with minimal Social Security as their primary income. Ed says that even though they may own their home, their income barely covers their I living expenses. All clients certify their earnings are primarily Social Security. The Hollys purchase groceries from Food Share, Inc., in Oxnard at "very favorable" prices on Tuesdays and assemble the bags. They stress the importance of distinction between Leisure Village Food Distribution and Food Share, Inc. (Leisure Village's receptors are financed by donations from Village residents and clubs.

In 1999, the Santa Barbara Regional Center of the Braille Institute named Ed the teacher of year. Mary Camarillo, the Community Outreach Coordinator, considers his contributions to the Braille Institute to be priceless.

Ed's introduction to the Institute happened very dramatically in 1996 when he suddenly lost all sight in the upper half of his right eye because of glaucoma. He rushed to the Braille Institute in a panic. Luckily, he discovered a new medication was available to prevent further damage and was invited to work with the Institute.

He finds teaching

assertiveness training particularly rewarding. His aim is get people with little or no vision to come out of their shells, to speak for themselves, express

their needs and wants, to let go of feelings of hostility, to feel good about themselves and get some confidence.

Ed says it's rewarding when his students break through and take action and then see them smile as they relate what they did. Ed tells his "chicken soup" story to illustrate his goal. "A friend was sick and I sent him some

chicken soup. I was sick and no one sent me chicken soup and it finally dawned on me that I had not asked for chicken soup". He states, "That practice must be applied in life. People are unfair when they do not let spouses, family, or friends know what they need and want". He also leads discussion groups on traveling for the vision

Ed today is in the glow of good health, but he has had serious problems which he over'came with a lot of determination and hard work. He had emergency openheart surgery in 1995) and found the experience so frightening that he vowed not to ever have it again. His doctors told him there was still plaque that should be removed. In 1998, he decided to get a second opinion Ed sings the praises of his doctor and the system she used, but for legal reasons we can't divulge

The premise was that through a low fat, vegetarian diet, plenty of daily exercise, and stress management the body would rid itself of the See Holly's pg 13

plaque. Ed became a dedicated user of the exercise room. He believes that room is a real life saver for those who take advantage of

Altlhough he had been a "walker" before, he learned that strolling does not help the heart. Since engaging in a strenuous exercise regime and the other component of the program, all the plaque has been removed from his heart and all travel restrictions have been removed.

Travel is something the Holly's really enjoy. So far they have been to 11 countries and all seven continents.

Before his retirement. Ed was an executive in the entertainment industry, a career he found very rewarding. He has been a second vice-

TRIPS AND TOURS

The Fillmore Fish Hatchery

A recent KCET showing Huell Howser's "California Gold" reminded us, Mrs. H and-me, of prior visits to Piru and environs which lies 5 or 6 miles east of Fillmore on Highway 126. So we paid another visit in early November.

Piru can be reached by one of two routes. The easy one is to drive to Saticoy and take Highway 126 to Santa Paula, Fillmore, and then Piru. The slightly shorter but more adventurous trip is to go to Somis, east to Grimes Canyon Road, then to Highway 23 over the mountain to Fillmore and on. The Hwy. 23 route contains some steep-hillsides and sharp turns—sometimes wary for the scary. We took the Saticoy to Santa Paul via 126 route.

Piru is a community just now being rediscovered. Some new homes have been and are being constructed perhaps to be inhabited by commuters from the Valencia industrial commercial area. Piru has a scarcity of commercial stores and services. After driving the mile it takes to cross town and return, we drove five miles to Lake Piru only to conclude the trip is only worth it for overnight campers pulling boats.

The highlight of our sojourn was a visit to the, Fillmore State Fish Hatchery just about one-half mile east of Fillmore, Good parking, free admission, and viewing within arms reach a million trout in four shallow concrete ponds makes this delightful, educational trip. Fish are grouped in ponds by size ranging from one-or two-inch lengths to over a foot. When ready, smaller fish are planted in streams and larger ones in lakes. Fish reach one pound in about a year at the hatchery.

Hatchery employees see that fish are constantly fed. The ponds are protected from birds and other predators by overhead and side screens. Visitor hours are 7:30 a.m. to 3 p.m. daily.

Just to make sure our day would be complete, we stopped in at the Union Oil Museum in Santa Paula—open Thursday through Sunday 10 a.m. to 4 p.m. and closed Monday through Wednesday. A hundred years of pictures, artifacts, geology, and other exhibits make clear the significant role Ventura County played in oil exploration and development. Free parking behind the 110 year-old building and admission contribution is \$2.

We lunched at a neat Mexican restaurant across Main Street and then motored home via Saticoy. Time was no problem. We left home at

setting a time frame for the required repair or improvement. This time provement. This time deadline may be extended, if requested, and the committee is always available for assistance and suggestions.

Overall, this system works extremely well, i.e. residents are usually very cooperative be-cause they too want to maintain the value of their property and their community. The Leisure Village Board of Direc-tors or General

Managers are not involved unless there is a protest, appeal or refusal to comply. In some situ-ations of non-compliance, Leisure Village may be forced to do the work itself and charge the resident for it, and may even levy a fine -but these are rare.

Lucy Fiore has been a member of the Building and Grounds Committee for three years, and is now serving her second year as chairperson. She has been especially interested in this committee because she sees it as a way to do something specific and helpful in protecting our homes and our community. She stated that working on this committee has been extremely satisfying for her and the committee members who work well together to get things

Last year, the Building and Grounds Committee worked on two major projects. i.e. installing address numbers on the rears of all houses and painting all the facie boards and wood posts. In the coming year, the committee's special projects will be to complete the painting work, improve the uniformity of planter bed edgings and also special monitoring of homes backing onto the golf course.

One frequent problem the committee has to deal with is helping residents understand the rules and regulations, and the fact that these apply to all with no exceptions. In situations involving tenants, the legal home owner is the one held responsible.
